2. PROGRESS ON SCHEMES WITH BUDGET APPROVAL

2.1 Elizabeth Way Underpass

Budget of £7,250 approved via email 17th March 2008. Committee are asked to approve the budget formally.

2.2 Auckland Road / Parsonage Street

Budget of £7,300 approved 30th August 2007. Design for retaining wall and footpath renovation nearly completed. Expected to go to consultation shortly.

2.3 Lammas Land Cycle Parking

Budget of £2,350 approved 30th August 2007. Design for cycle parking is complete and expected to be implemented shortly.

3. PROGRESS ON SCHEMES BEING PROGRESSED

3.1 Canterbury Street

A Scoping Workshop took place on 2 April 2008 with invited local residents and businesses. The purpose of the Workshop was to explore the problem with residents and start to determine some possible solutions.

The Workshop has now enabled the EIP team to put together an informed brief to discuss with County Highways and to take a draft scheme to full public consultation, hopefully prior to summer vacation dates.

We will also be working with interested local groups to develop proposals for the scheme. In the meantime a newsletter will be sent to all local residence updating them on progress.

Recommendation: To allow officers to draw up a proposal and to consult with County and then to take to AJC (if approved by County).

Decision to be made: To allow officers to proceed or not.

3.2 Mud Lane Lighting

The installation of a light beneath the arch on Mud Lane has proved not possible to progress because of property owners do not wish it.

As a consequence the proposal changed to installing a column light along the lane. However, consultation with Land Registry has revealed that the landowner of the lane is unknown making installation of a light a risk.

In addition, consultation with the County lighting team has determined that although they have no objection to the City installing an additional column, they would not allow connection to the existing light columns because of funding issues to power the additional light.

Mud Lane Lighting Scheme is an old scheme on which officers have found it difficult to make progress on. As the County have now given us clear instruction that they are not willing to find the revenue funding to power a light, officers would recommend that the scheme is put on hold until a stream of revenue funding is found within the City budget.

Recommendation: that the scheme is put on hold until a stream of revenue funding is found within the City budget.

Decision to be made: To put scheme on hold until revenue budget found.

3.3 Histon Recreation Ground Seat and Replanting Mound A new seat has been installed next to the balancing log play equipment by Active Communities. A request to replant the mound adjacent to the Murketts garage has been put forward.

Whilst on site it was noted that the ground was waterlogged. A second site visit with the City's drainage engineer noted that the flow in the ditch was static and the outfall pipe was not able to drain properly. We have informed Parks and Rec. regarding this and have asked for it to be looked into during their maintenance inspections.

Recommendation: that officers investigate the possibility of replanting the mound with Active Communities.

Decision to be made: To progress with investigations in consultation with Active Communities and the Arboricultural team.

3.4 Manor Street / King Street Cycle Parking

The installation of ground mounted cycle racks has proved not possible because of tree roots. It was therefore determined to wall mount either racks or a rail, but to do this it would be necessary to consult and gain the permission of the building owner. Officers are continuing investigation and are awaiting a response from Bidwells who are acting as agents for Jesus College.

3.5 Round Church Street

Recycling Area behind the Student Union and wall is unsightly and wall is in need of repair.

Officers are have contacted the University to discuss but have had little response to date. Officers will continue to progress.

4. NEW SCHEMES FOR CONSIDERATION

4.1 Lammas Land pavilion

The small central pavilion on Lammas Land is in a very poor state and, as it has been assessed as uneconomic to repair, will be demolished later in May. The pavilion is known to be much appreciated by a number of residents and visitors to the park. It is proposed that consultation will be carried out to consider a replacement scheme in a nearby location

The Council will carry out public consultation on the options for replacement during early summer.

There is currently no funding available within the Active Communities budget or the S.106 Planning Obligation budget for replacement purposes. Active Communities will fund the demolition of the existing pavilion. It is envisaged that a replacement option may cost in the region of £20,000 (estimate only dependent on design). West Central Area Committee may wish to consider options for contributing to this cost.

Recommendation: To allow officers to carry out public consultation and following that, consider options for design, feasibility and funding for a replacement feature.

Decision to be made: To proceed with assisting with the public consultation and following that investigations and costing.

4.2 Round Church grounds

The Council has been approached by Christian Heritage, whose visitor centre is the Round Church, for funding to carry out minor repairs and renovations to the external area around the church.

The works would involve:

- The repair of the low retaining dry stone wall which runs parallel to the front boundary wall,
- Repairs to cobbles around the church building,
- The cost of purchase and installation of a light fitting along the passage to the Student Union Building, and
- The cost of planting adjacent to the wall on Round Church Street.

Recommendation: To allow the EIP team to investigate, in consultation with Conservation Officers, the costs for carrying out the works. Costs can be presented to the July West/Central Area Committee for approval or otherwise. It is recommended that the costs be granted to Christian Heritage to carry out the works themselves.

Decision to be made: To proceed with investigations and costings.
