## Amendments To Text:1. Amend Paragraph 8.48 titled Refuse Arrangements<br/>page 20 of the agenda item 4.

Paragraph 8.47

An underground waste recycling facility will be provided within the Local Centre adjacent to the adoptable highway. Condition (20) will be recommended to require a strategy for the management and maintenance of the recycling facility to be submitted. Condition (13) will be recommended to require details of the appearance and material finish of the above ground waste hoppers.

### 2. Addition of a new condition 20:

20. Prior to occupation of the commercial units, a maintenance and management strategy for the underground waste recycling storage containers shall be submitted to and approved in writing by the Local Planning Authority. The approved waste recycling containers shall be installed and operational prior to the occupation of the commercial units. Development shall be carried out in accordance with the approved details. (Reason: To ensure that the details of the operation, maintenance and management of the recycling storage containers are considered, in the interest of providing appropriate waste facilities in accordance with Policy DP/3 of the adopted Local Development Framework 2007).

#### 3. Amend approved plans to condition 21.
