To speak with the City Council's Project Leader, John Richards, on producing a document that would go out to consultation on parking/ double yellow lines on Riverside and on reconfiguring the entrance to Stourbridge Common	Cllr Whitehead	11/01/18 2/07/18 22/10/18 17/10/20	<p>The end of Riverside and Stourbridge was now being incorporated into a potential resident parking zone, which now included Riverside, Oyster Road, Garlic Row, Stanley Road and Newmarket Road. An informal survey with residents had been undertaken by Cllr Whitehead and the results would be published soon.</p> <p>The informal survey (results had shown that residents were in support of the parking zones) had been submitted to the County Council's Parking Officer. A formal public consultation was now being drawn up.</p> <p>The scheme was due to go out for formal public consultation in November with a drop-in meeting for residents on 29<sup>th</sup> November.</p> <p>Consultation on Riverside became merged with a wider consultation on resident parking, this included Riverside, plus the surrounding streets. This scheme was turned down by residents and there was now a new parking scheme for Riverside only, the main aim to make the area safe for cyclists and pedestrians and to solve the problem of overnight campervan parking. This is currently out for consultation to affected residents</p> <p><b>TO BE CLOSED</b></p>
To provide an update at the next meeting on a potential campaign regarding wheelie bins being left out in the street and information leaflet	Councillor Moore  Councillor Smith  Councillor Moore	11/01/18  11/01/18  12/07/18	<p>If bins are left out on the street this becomes the responsibility of the Executive Councillor for Streets and Open Spaces.</p> <p>Due to a change in regulation it was now more problematic for the Council to act. Discussion had taken place regarding the use of red stickers when the bins were not put away. A campaign was being planned to encourage residents to be more thoughtful to their neighbours when leaving their bins out, this would take place after the new recycling campaign.</p> <p>The Enforcement Officers had been working with Legal to look to target areas where the civic action route could be taken on those repeat offenders who left their bins out which became a nuisance.</p>

Officers would be undertaking a site visit in February and further action would be taken if required.  Officers had received no response from the owner and would be seeking a contractor making the site safe and would also be looking at demolition of the building.  No further action had yet been taken but Officers were still working on the matter.
To arrange a Ward Walk About around Tiverton Way with Mrs Deards and Mrs Griffiths in May 2018 and look at possible places for bike rakes to be installed. A meeting would be arranged with the officer to discuss this further. Bike racks had now been installed on the Tiverton Way estate. <b>TO BE CLOSED</b>
