This particular section of the act, gives police the right to search people in a defined area during a specific time period when they believe, with good reason, that: serious violence will take place and it is necessary to use this power to prevent such violence; or that a person is carrying a dangerous object or offensive weapon; or that an incident involving serious violence has taken place and a dangerous instrument or offensive weapon used in the incident is being carried in the locality. <p>20/24/NAC - HRARA asks the officers in GCP and/or Cambridge City Council to provide facilities and tools to continue monitoring particles as well as emissions particularly in the deprived areas in Arbury along Histon Road.</p>	<p>Cllr Todd-Jones / Paul Van de Buk (GCP Officer), Jo Dicks Principal Scientific Officer</p>	<p>Update 30 September 2020</p> <p>‘Histon Road has two diffusion tubes which provide a monthly data point for Nitrogen Dioxide (NO₂) concentrations and are part of our passive NO₂ network of more than 70 locations across the City. Nitrogen dioxide concentrations are the reason for our designating an Air Quality Management Area for central Cambridge and remain close to national objective levels in some city locations although in recent years have generally been below the annual mean objective of 40ug/m³. In terms of the Histon road tubes levels are in the mid to high 20s over the last few years so well below the objective.</p> <p>Particulate matter which is measured at two size fractions (PM₁₀ and PM_{2.5}) at a limited number of fixed monitoring stations in the City and South Cambridgeshire appears to be of more concern to residents and has a stronger association with health impacts. A monitor is operated by Highways England at the Junction of Histon Road and Huntingdon Road required by the DCO for the A14 improvement project. South Cambridgeshire district Council also run monitoring stations on Huntingdon road near Girton and within Orchard Park. In terms of a City the</p>

		<p>Size of Cambridge this is a very comprehensive monitoring provision for particulate matter.</p> <p>There are legal health based objectives only for PM10 in the UK and monitoring in the City shows we are well within those objectives at sites with far greater local emissions than those experienced at Histon Road. Our advice therefore is that the monitoring in place is sufficient to give a good measure of any significant impact of the work and the likelihood is that concentrations of key pollutants will remain well within the current legal health-based objectives’</p> <p>The Principal Scientific Officer has also provided some additional comment re: HRARA questions about particulate air pollution:</p> <p>Public health data indicates in 2017, 47 deaths in Cambridge (5.6%) could be attributed to Particulate Air Pollution. HRARA asked: 47 deaths in 2017 – how many today?</p> <p>Answer: ‘The data this is based on is derived from a Public Health England Study using 2017 figures for excess mortality due to PM2.5 levels. There isn’t any more recent data and Public Health England’s role is now uncertain following Govt. announcements</p>

		<p>earlier this year. No local authority has the resources or access to medical data necessary to calculate the mortality figures independently.</p> <p>Current levels of particulate matter monitored in Cambridge are similar or lower than levels in 2017 and so derived mortality figures are likely to be similar or lower than in 2017 also.'</p>
