### **The reason you appeared before the Sub-Committee:**

To consider a Premises Licence to supply alcohol off the premises only between 11:00 and 20:00 Monday to Sunday.

### **In making our decision we considered the following:**

**We found the following facts:**

Following discussion with Police the applicant had put forward several additional conditions that they are prepared to make if the application is approved.

**We did not consider the following matters to be relevant:**

- i. The location of help and support services in the area and the work they undertake.
- ii. The previous application history of other licence holders in the areas.
- iii. Those aspects of the written and verbal representations that did not address one of the four licensing objectives.

**Our decision is as follows:**

To grant the licence subject to the mandatory conditions and those conditions offered by the applicant (as outlined in page 25&26 of the public agenda pack) and modified below (additional text underlined and deleted text ~~struck through~~):

- i. No single cans or bottles of beer, cider, lager shall be sold at the premises, except specialist branded premium priced products or products agreed by the Police.

**Our reasons for reaching the decision are as follows:**

Although the premises is within a Cumulative Impact Zone the conditions offered by the applicant agreed with the Police, the Licencing Authority is satisfied that the operation of the premises involved will not add to the impact of the Cumulative Impact Zone already being experienced.
