7. Procurement of planned maintenance contractor 2022-2028

The Committee endorsed the recommendations (15-0).

The Executive Councillor for Strategy and External Partnerships:

Approved the issue of tenders and, following evaluation of tenders, authorised the Strategic Director (following consultation with Executive Councillor, Chair, Tenant Representative Vice Chair, and Spokes of the Committee) to award a contract(s) to a

 Page 1 contractor(s) to carry out planned building maintenance / capital works to Council housing and other buildings for a period of five years and four months from November 2022 to March 2028, with an option to extend for one or more periods up to a maximum extension of three years.

8. Procurement of compliance contractor 2022-2028

The Committee endorsed the recommendations (15-0).

The Executive Councillor for Strategy and External Partnerships:

Agreed to amalgamate the aforementioned contracts (paragraph 1, Executive Summary of the report) into a single procurement exercise and authorised the Strategic Director (following consultation with Executive Councillor, Chair and Spokes of the Committee and elected tenant spokes) to award either a single contractor, or multiple contracts for Compliance Delivery areas.

9. Housing Services Communal Cleaning

The Committee endorsed the recommendations (15-0).

The Executive Councillor for Strategy and External Partnerships:

Authorised officers to explore the option of transferring responsibility for the cleaning of the Councils Category 2 Sheltered Housing Schemes back in house to the Council, and to delegate

 Page 2 authority to the Strategic Director, in consultation with the Executive Councillor for Housing, Chair and Vice Chair of Housing Scrutiny Committee (HSC) and the opposition spokesperson, to make a decision on whether or not this should go ahead.

Following the above decision, to delegate authority to the Strategic Director, in consultation with the Executive Cllr for Housing, Chair and Vice Chair of HSC and the opposition spokesperson, to tender and award a contract for the communal cleaning of the Council's General Housing, Category 1 sheltered housing and, potentially, category 2 sheltered housing stock.

Approved delegated authority to the Head of Finance to amend both expenditure and income budgets in relation to the provision of communal cleaning services and bin cleaning in sheltered housing schemes in the HRA in line with prices received as part of the recent procurement exercises.

10. 2020/21 Revenue and capital outturn, carry forwards and significant variances – Housing Revenue Account

The Committee endorsed the recommendations (13-0).

The Executive Councillor for Strategy and External Partnerships:

Approved carry forward requests totalling £7, 598,300 in revenue funding from 2020/21 into 2021/22 as detailed in Appendix C of the report.
