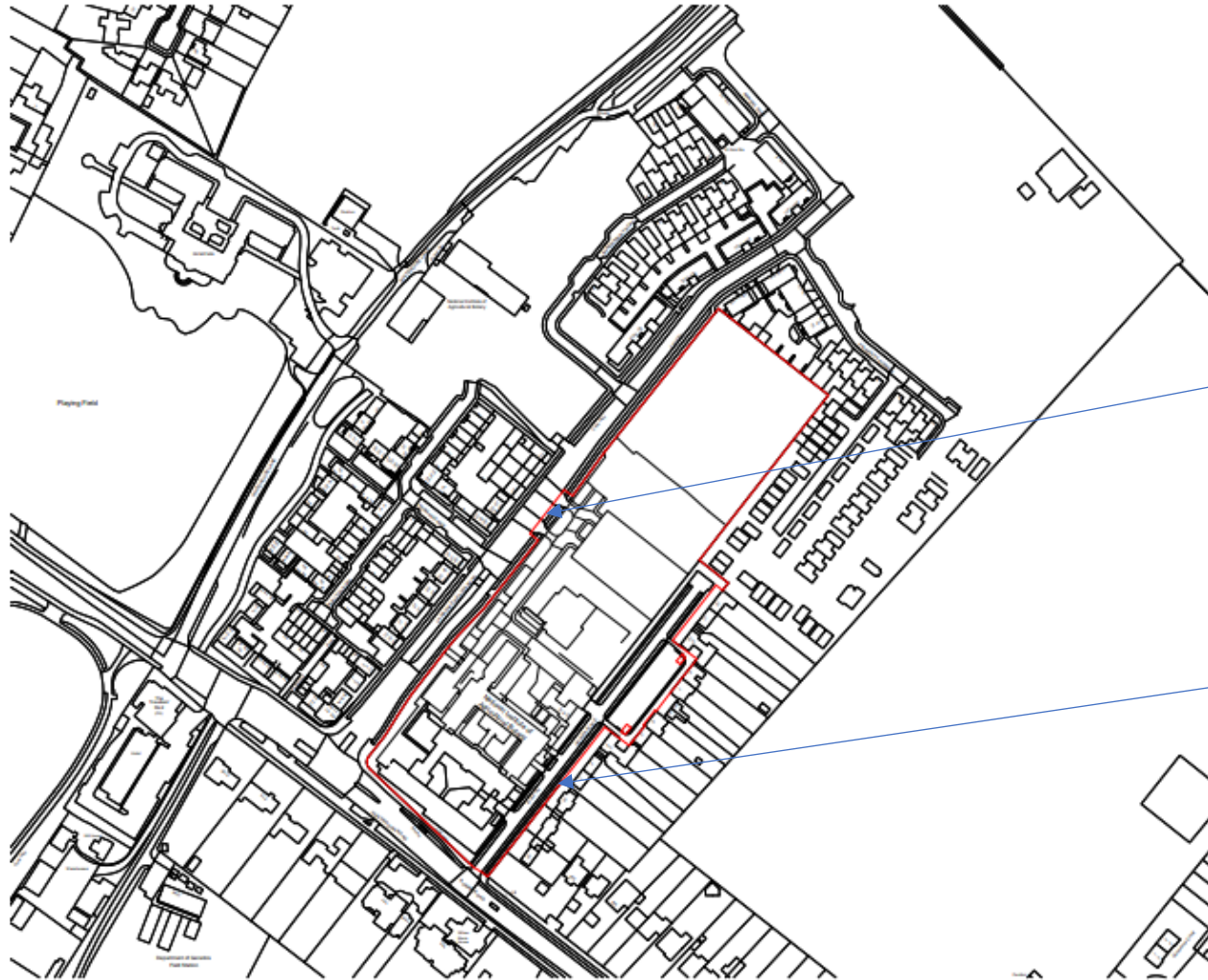

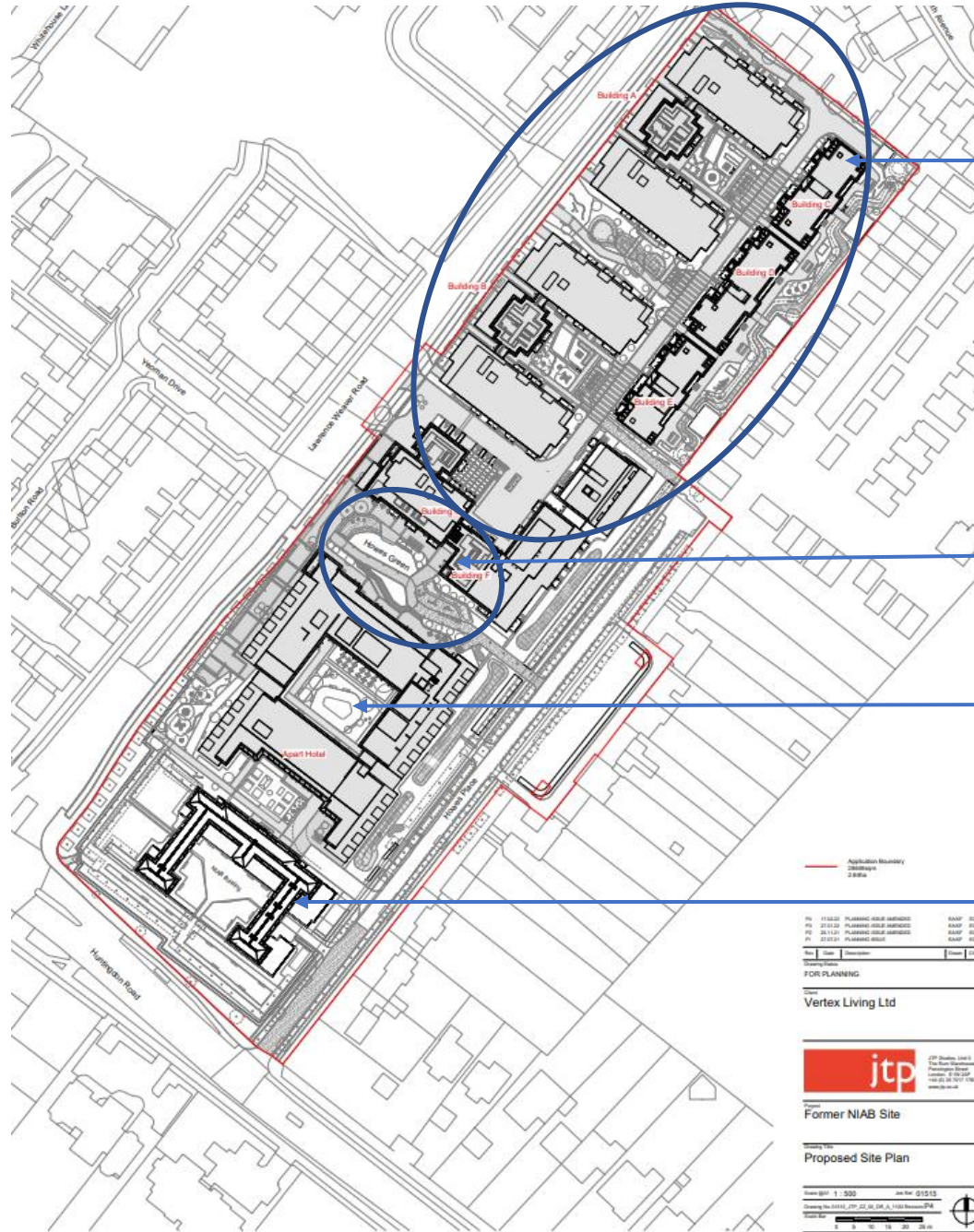

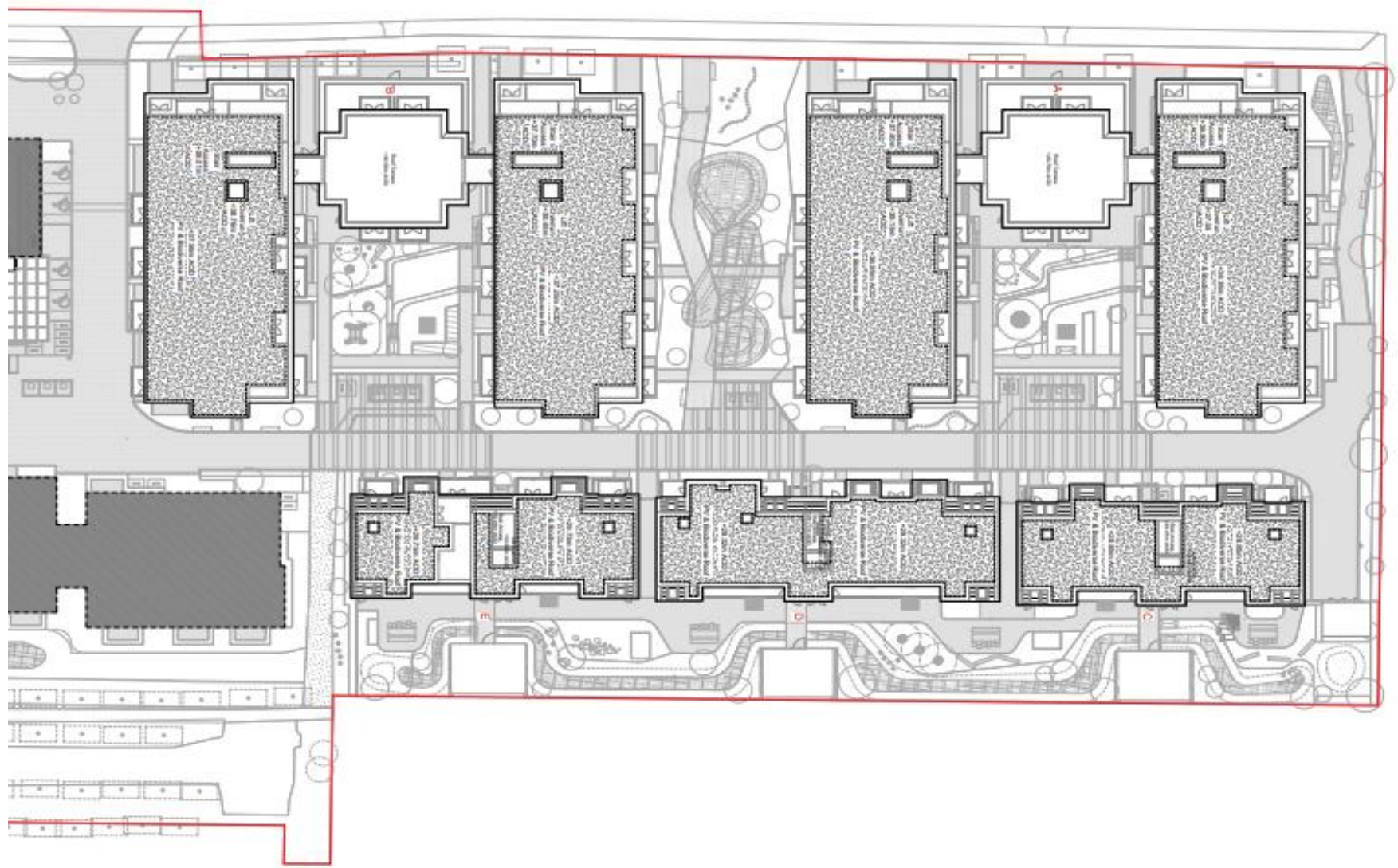

Roof Plan – Buildings A-E



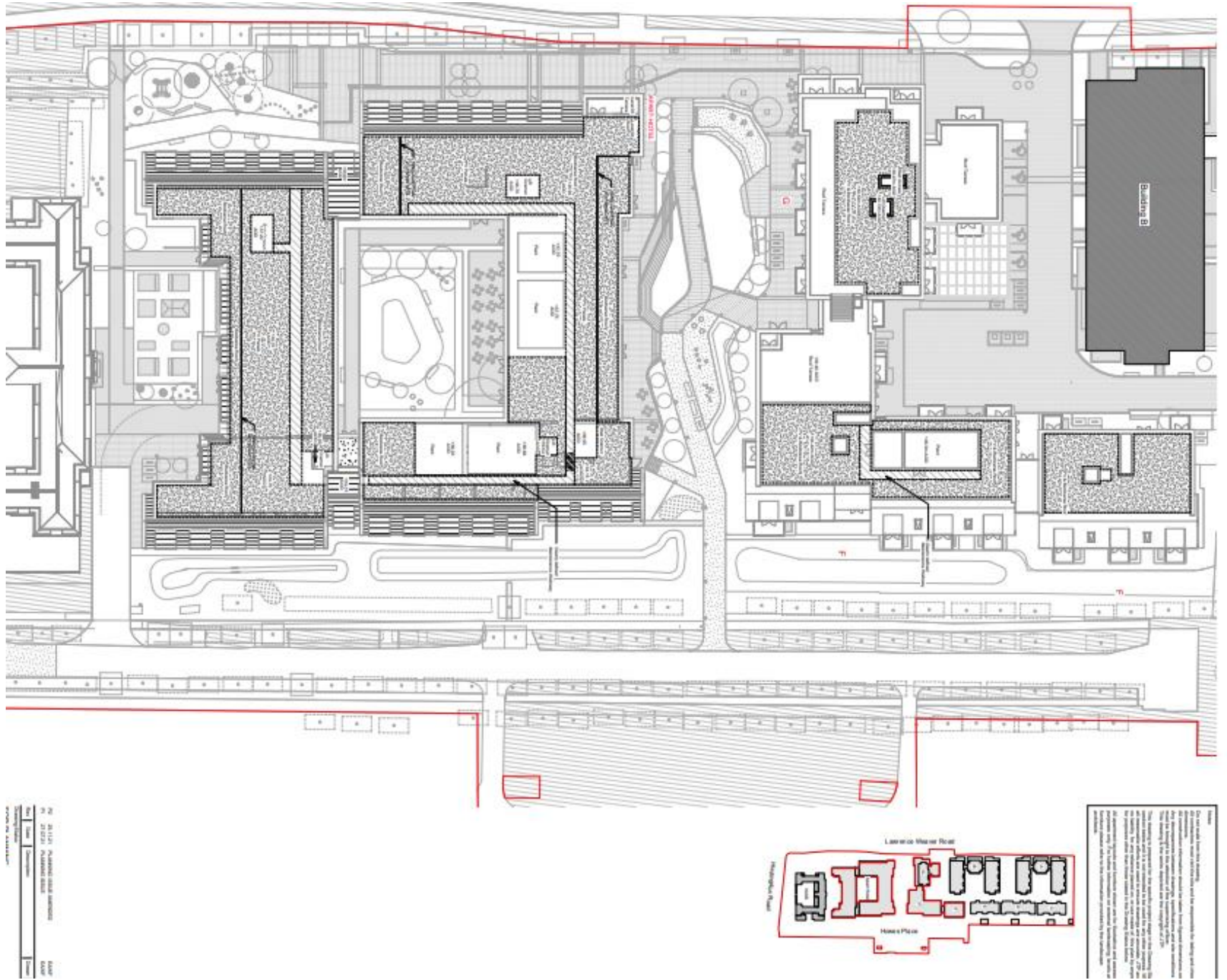
