In regard to the first matter, the applicant has set out that the proposal may help to increase occupancy to the hotel in winter months. Officers have recognised that the proposal may increase the appeal of the hotel facilities throughout these months, however it does not expand the hotel rooms facilities and therefore would have limited public benefits in regard to the increased tourism spend in

the city.

To Note:

It is recognised that there may be further employment opportunities if occupancy is increased throughout the hotel. The applicant suggests that the proposal would support this and estimates that an increase of 10 staff members across winter months would result from this. The suggested increase in staff would be positive but do not outweigh the harm identified in the report.

The applicant has provided additional information regarding the events that have been held on the roof terrace. The proposed roof terrace would primarily be used as part of the operation of the hotel, the applicant has suggested that events could be held in winter months.

The applicant draws on an application at the Park Street car park location. Whilst this is acknowledged as a recent decision, Officers recommend that members focus on the merits of the scheme that has been submitted.
