

## Committee Action Sheet - North Area Committee (NAC)

Date: 9/3/2023

1. Minute reference: 22/20/NAC North Area Residents' Environmental Projects
  - Action: Cllr Collis to liaise with Becky Allen regarding Happy Bee Streets scheme participation.
  - Progress:
    - 29/11/22 - Cllr Collis advised this matter was still on-going.
2. Minute reference: 22/21/NAC Greater Cambridge Partnership (GCP) Milton Road Update
  - Action: Cllr Scutt to invite Stagecoach to future NAC to discuss changes to bus routes.
  - Progress:
    - 17/11/22 – Cllr Scutt advised that the intention was to invite a representative from Stagecoach to the next meeting unfortunately the agenda for the November meeting was full.
3. Minute reference: 22/22/NAC Open Forum
  - Action: Saplings in Chatsworth Avenue and other areas in the ward are dying due to lack of water.
  - Cllr Collis undertook to investigate if trees/plant maintenance was the responsibility of the City Council. Ideas from residents to improve planting maintenance would be passed onto Guy Belcher (Biodiversity Officer).
  - Cllr Collis undertook to liaise with Greater Cambridge Partnership as the responsible party for trees on Histon Road.
  - Progress:
    - 29/11/22 – Officers went to look at the trees on Chatsworth Avenue and decide what action was required – Cllr Collis to follow up.
    - 29/11/22 – GCP trees – matter still on-going, Cllr Collis to follow up.
4. Minute reference 23/4/NAC – Residents' Forum / Speak
  - Action: Cllr Gawthrope Wood asked whether Chesterton Choral Society might consider performing at Arbury Carnival. Committee Manager to check consent to share information and share contact details with Cllr Gawthrope Wood.
  - Progress – 9/3/23 – **Action completed.**

5. Minute reference 23/6/NAC – Environmental Report – Replacement litter bin
- Action: For Senior Operations Manager to provide an update on the replacement of the bin to Cllr Bird and member of the public where the Chisholm Trail meets the towpath.
  - Progress – 7/3/23 – Advised that due to the vandalism of previous bins which had been installed, the plan was to secure metal litter bins to a concrete plinth. It was hoped to undertake this work within the next couple of weeks. **Action completed.**
6. Minute reference 23/6/NAC – Environmental Report – Food waste not collected in East Chesterton
- Action: Shared Waste Service to provide a response why food waste had not been collected in East Chesterton.
  - Progress:
7. Minute reference 23/7/NAC – Open Forum Q1– Repairs at mini roundabouts in Campkin Road and Northfield Avenue
- Action: Cllr Meschini to follow up with the County Council when repairs would be undertaken at mini roundabouts in Campkin Road / Northfield Avenue.
  - Progress – 1/3/23 – The County Council advised that there wasn't a regular cycle of line and mini roundabout repainting. There was a programme of refreshing in spring and summer and the areas identified (Campkin Road and Northfield Avenue) would be added to one of the programmes for 23/24. Advised that the best way for residents to notify the County Council of any defects or concerns is via the Report It tool here: <https://highwaysreporting.cambridgeshire.gov.uk/>. **Action completed.**
8. Minute reference 23/7/NAC – Open Forum Q5 – Continued closure of Union Lane
- Action: Councillor Meschini undertook to follow up with officers when Union Lane might be opened.
  - Progress – 1/3/23 – Greater Cambridge Officers acknowledged that the closure at Union Lane had been longer than originally planned. Advised that there had been some difficulties constructing the new layout with unforeseen obstructions and utilities not being where was expected which

had slowed down the progress. Hoped the junction would be opened within the next 3-4 weeks. **Action completed.**
