To consider the application of **The Alcademy** in regards to the premises **The Alcademy, 54 Chesterton Road, Cambridge, CB4 1EN** licence to **provide the following licensable activities:**

- Plays – Monday to Saturday 08:00 to 23:00; Sunday 08:00 to 22:30;
- Films – Monday to Saturday 08:00 to 23:00; Sunday 08:00 to 22:30;
- Live Music – Monday to Saturday 12:00 to 23:00; Sunday 12:00 to 22:30;
- Recorded Music – Monday to Saturday 08:00 to 23:00; Sunday 08:00 to 22:30;
- Supply of alcohol (both on and off the premises) – Monday to Saturday 11:00 to 23:00; Sunday 11:00 to 22:30;

Our reasons for this are: **(give full and detailed reasons)**

1. Whilst previous experience with licensing is relevant, the areas are different.

Our decision is as follows:

To grant the licence with the following conditions:

1. No alcohol to be consumed outside the premises.
2. The following times shall apply to the sale and consumption of alcohol on the premises:

12:00 to 19:00 Monday-Sunday

Our reasons for reaching the decision are as follows:

1. We have considered other licences in the area and their opening and closing times. Two premises are far away from residential areas. The others are very different types of establishments; being Delicatessens, Restaurants and a shop. The remainder are cafes with earlier closing times. There is only one comparable bar close by with an extended closing time but the customers of that establishment are likely to avoid the residential streets, due to its location.
2. This premises is on a residential road and likely to have a greater impact on the nearby residential streets.
3. With reference to paragraph 3.2 of the Agenda, the onus is on the applicant to demonstrate why the granting of the licence would not add to the cumulative impact already being experienced within the area. We found that the reported issues primarily occur at night time. The Applicant has not fully demonstrated why granting the licence would not add to the cumulative impact of the area. We have therefore restricted the licensing hours.

The reason you appeared before the Sub-Committee:

For the Sub-Committee to consider an application under section 17 of the Licensing Act 2003 to apply for a Premises Licence for the sale by retail of alcohol with respect to The Alcademy, 54 Chesterton Road, Cambridge, CB4 1EN has been received from Othersyde Limited. The application was served on Cambridge City Council (the Licensing Authority) on 8th May 2024. A copy of the application was also served on each responsible authority. The application and plan is attached to the report at Appendix 1.

Representations were received from 21 members of the public objecting to the application and 3 members of the public in support of the application.

The Sub Committee had to decide whether to grant the application or refuse the application.

We found the following facts:

1. The Premises is in a cumulative impact area.
2. The proposed community events will add value to the area.
3. The Premises is in a residential area.
4. There were 21 notified objections to the application and 3 representations in support of the application.
5. There is an unlit alleyway in close proximity to the premises.
6. The entrance to the front of the premises is very close to moving heavy traffic.
7. The premises is on the corner of a traffic junction.
8. There are 9 various licensed premises in the cumulative impact area with various opening and closing times.
9. The issues regarding the licensing objectives raised by the residents primarily relate to nighttime.

We did not consider the following matters to be relevant:

1. The previous premises ran by the Applicant are not relevant.
