Key Decision

1 Executive summary

Portfolio Plans

- 1.1 In August 2010 Strategic Leadership Team and the Executive Councillors reviewed the Council's service planning process to reflect the Council's new organisational structure, the reshaping of the political executive and the new vision statement. It was agreed that service plans based on service areas would be replaced by seven annual Portfolio Plans, from 2011/12.
- 1.2 The Portfolio Plan for Environmental and Waste Services Portfolio will be reported to the next committee cycle. The Plan will identify the strategic objectives for the portfolio over the financial year 2011/12 and beyond. Beneath each of the objectives are detailed the particular outcomes that will be achieved in 2011/12. Finally the plans include performance measures that will provide evidence to Members and the public that the outcomes have been achieved.
- 1.3 This information will enable the Executive Councillor and the services contributing to the delivery of the plan to be clear about the priorities for the portfolio and will assist in decisions about where resources should be focussed within the portfolio as part of the budget-setting process.

Revenue and Capital Budgets

- 1.4 The following report sets out the overall base revenue and capital budget position for the Environmental and Waste Services Portfolio. The report compares the proposed revised budget to the budget as at September 2010 and details the budget proposals for 2011/12 and 2012/13.

2 Recommendations

The Executive Councillor is recommended to:

Review of Charges:

- a) Approve the proposed charges for Environmental and Waste services, as shown in Appendix B to this report.

Revenue Budgets:

- b) Approve, with any amendments, the current year funding requests and savings, (shown in Appendix A) and the resulting revised revenue budgets for 2010/11 (shown in Table 1) for submission to the Executive.
- c) Agree proposals for revenue savings and unavoidable bids, as set out in Appendix C, which have been incorporated into the budgets presented for this portfolio.
- d) Agree proposals for Priority Policy Fund (PPF) bids, as set out in Appendix E.
- e) Approve the budget for 2011/12 as shown in Table 2, for submission to the Executive.

Capital:

- f) Seek approval from the Executive to carry forward resources from 2010/11, as detailed in Appendix G, to fund rephased capital spending.
- g) Approve capital bids, as identified in Appendix H, for submission to the Executive for inclusion in the Capital Plan or addition to the Hold List, as indicated.
- h) Confirm that there are no items covered by this portfolio to add to the Council's Hold List, for submission to the Executive.
- i) Approve the revised Capital Plan for 2010/11, as detailed in Appendix J, to be updated for any amendments detailed in (f), (g) and (h) above.

3 Background

- 3.1 At its meeting on 8 November 2010, Council gave initial consideration to the budget prospects for the General Fund for 2011/12 and future years. As a result an overall savings requirement was set for net expenditure. The expectation was that service reviews would contribute significantly to achievement of these targets and the position on any service reviews within this portfolio are shown in paragraph 6.3.
- 3.2 The overall Budget Strategy Report (BSR) to Strategy & Resources Scrutiny Committee on 17 January 2011 will include a review of all the factors relating to the overall financial strategy that were included in the Medium Term Strategy (MTS).
- 3.3 For 2011/12 provision was made for a Priority Policy Fund (PPF) of £500,000 to provide funding for developments that can be demonstrated to make a significant contribution to the Medium Term Objectives, as set out in the Annual Statement so this report considers any items to be funded from PPF.
- 3.4 The report to Strategy & Resources Scrutiny Committee is expected to include details of the Government's Final Settlement for 2011/12 and the impact for concessionary fares and New Homes Bonus. The announcements are likely to be made shortly after the conclusion of the consultation periods, which end on 10 January 2011 and 24 December 2010, respectively.
- 3.5 Capital bids will be prioritised by the Executive at its meeting on 20 January 2011. Items in the existing Capital Plan and Hold List will also be reviewed to identify any which are no longer required, or where the current indicated timing for spending is no longer accurate. The Capital Plan can then be revised to take account of any changes required.
- 3.6 Further work is required on detailed budgets due to the corporate and departmental restructuring, so delegation to the Director of Resources will be sought from Council for authority to finalise changes relating to this and the reallocation of support service and central costs, in accordance with the CIPFA Best Value Accounting Code of Practice and the Service Reporting Code of Practice for Local Authorities (SeRCOP) which applies from 1 April 2011 i.e. for 2011/12 budgets.

4 Revised Budget 2010/11

- 4.1 The following table sets out the proposed revised revenue budget for this portfolio in comparison with the September 2010 budget.

- 4.2 On 17 February 2011, Council will consider for approval the revised budget proposals for this portfolio. The table above demonstrates a reduction in the use of reserves of £127,330 compared to the position at September 2010. See Appendix A for further details of amended budget proposals/changes.

5 Review of Charges

- 5.1 Proposals for the review of charges for this portfolio are presented at Appendix B. The effects of any proposed changes have been included in the base budget projections.

6 Budget 2011/12

- 6.1 A summary of the proposed budget for 2011/12 for this portfolio is shown in Table 2. This includes the effects of the proposed savings and unavoidable bids together with the impact of the proposed new charges.
- 6.2 The proposed savings and unavoidable bids, identified during the budget process to date, are detailed in Appendices C and D.

Service Reviews

- 6.3 In this portfolio a Service Review has been undertaken for Streetscene and the review for Waste Services is in progress. The anticipated net savings for both are shown in Table 2 and detailed in Appendix C.

7 Overall Revenue Budget Position

- 7.1 The approved budget proposals for this portfolio will be submitted to the meeting of Strategy & Resources Scrutiny Committee on 17 January 2011 and for consideration by the Executive at its meeting on 20 January 2011.
- 7.2 An overall summary of the budget proposals, as set out in this report, is shown below.

8 Capital - 2010/11 Revised Budget, Capital Bids and 2011/12 Proposed Budget

- 8.1 Appendix G shows the latest position against the 2010/11 Capital Plan at September 2010 for schemes and programmes within the Environmental and Waste Services Portfolio, with variances explained in detail in the accompanying notes. A variance of (£81,000) is anticipated of which (£75,000) is due to slippage. The remaining variance of (£6,000) relates to forecast net underspends on individual capital schemes and programmes.
- 8.2 Appendix H details the schemes which have been identified as bids for the Capital Plan.
- 8.3 Section 13 of the Medium Term Strategy, approved in November 2010, highlighted the need to review current Hold List items. There are currently no items on the Hold List for this portfolio.
- 8.4 Appendix J shows the Capital Plan for all the schemes and programmes within this committee's portfolio (including any approvals since the MTS was published in November 2010, but before any changes arising in paragraphs 8.1, 8.2 and 8.3 above).

9 Public Consultation

- 9.1 For a number of years the Council's budget process has included consultation with the citizens of Cambridge to find out which services were most important to residents and what they thought spending and savings priorities should be for the coming budget year.
- 9.2 We have used a mixture of surveys and workshops to build up trend data on the views of residents about spending and saving priorities and we have found that views have been quite consistent over time.
- 9.3 This year we included a survey within the autumn edition of "Cambridge Matters" which asked residents to prioritise the Council's services in terms of their relative importance. A total of 449 households responded to the questionnaire. Of these, 36 responses were received through the council's website where the survey was also made available.
- 9.4 In broad terms the results reflect previous surveys - respondents placed greatest importance on our core services: collecting rubbish, recycling, cleaning the streets and maintaining our parks and open spaces. They also placed high importance on working with the police to tackle crime and anti-social behaviour. Respondents placed least importance on managing ticketed events and free events. Respondents were split over some services, for example:
- 17% said CCTV was of high importance and 35% said CCTV was less important.
 - 28% said 'Planning for new housing, including affordable housing and designing attractive new neighbourhoods' was of high importance whilst 19% said it was less important.
 - 28% said 'Providing and maintaining sports and leisure services such as swimming pools' was of high importance whilst 16% said it was less important.

10 Options / Implications

- 10.1 In relation to bids, the decisions made may have a number of implications. A decision not to approve a revenue bid will impact on managers' ability to deliver the service or scheme in question and could have staffing, equal opportunities, environmental and/or community safety implications. A decision not to approve a capital or external bid will impact on managers' ability to deliver the developments desired in the service areas.

1 Executive summary

Portfolio Plans

- 1.1 In August 2010 Strategic Leadership Team and the Executive Councillors reviewed the Council's service planning process to reflect the Council's new organisational structure, the reshaping of the political executive and the new vision statement. It was agreed that service plans based on service areas would be replaced by seven annual Portfolio Plans, from 2011/12.
- 1.2 The Portfolio Plan for Climate Change & Growth Portfolio will be reported to the next (March) committee cycle. The Plan will identify the strategic objectives for the portfolio over the financial year 2011/12 and beyond. Beneath each of the objectives are detailed the particular outcomes that will be achieved in 2011/12. Finally the plans include performance measures that will provide evidence to Members and the public that the outcomes have been achieved.
- 1.3 This information will enable the Executive Councillor and the services contributing to the delivery of the plan to be clear about the priorities for the portfolio and will assist in decisions about where resources should be focussed within the portfolio as part of the budget-setting process.

Revenue and Capital Budgets

- 1.4 The following report sets out the overall base revenue and capital budget position for the Climate Change & Growth Portfolio. The report compares the proposed revised budget to the budget as at September 2010 and details the budget proposals for 2011/12 and 2012/13.

Recommendations

The Executive Councillor is recommended to:

Review of Charges:

- a) Approve the proposed charges for Climate Change & Growth services and facilities, as shown in Appendix B to this report.

Revenue Budgets:

- b) Approve, with any amendments, the current year funding requests and savings, (shown in Appendix A) and the resulting revised revenue budgets for 2010/11 (shown in Table 1) for submission to the Executive.
- c) Agree proposals for revenue savings and unavoidable bids, as set out in Appendix C, which have been incorporated into the budgets presented for this portfolio.
- d) Agree proposals for revenue bids funded from existing or external funding, as set out in Appendix D, which are incorporated into the budgets presented for this portfolio.
- e) Approve the budget for 2011/12 as shown in Table 2, for submission to the Executive.
- f) Approve the transfer of the Sustainable City grants budget from 2011/12 onwards from the Environment to the Customer and Community Services department (see report elsewhere on this agenda).
- g) Approve the transfer of the funding for the Cambridgeshire and Peterborough Biodiversity Partnership and the Cambridgeshire Travel for Work Partnership from 2011/12 onwards from the Environment to the Chief Executives department (see report elsewhere on this agenda).

Capital:

- h) Seek approval from the Executive to carry forward resources from 2010/11, as detailed in Appendix G, to fund repurposed capital spending.
- i) Approve capital bids, as identified in Appendix H, for submission to the Executive for inclusion in the Capital Plan or addition to the Hold List, as indicated.
- j) Confirm that there are no items covered by this portfolio to add to the Council's Hold List, for submission to the Executive, as shown in Appendix I.
- k) Approve the revised Capital Plan for 2010/11, as detailed in Appendix J, to be updated for any amendments detailed in (h), (i) and (j) above.
- l) Approve the following project appraisals as detailed in Appendix K, funded from existing capital programmes and/or additional external funding as identified in the following appraisals:
 - K (1) Tins Path cycleway improvements
 - K (2) Essential Repairs to Grafton West Multi-Storey Car Park Boundary Wall

3 Background

- 3.1 At its meeting on 8 November 2010, Council gave initial consideration to the budget prospects for the General Fund for 2011/12 and future years. As a result an overall savings requirement was set for net expenditure. The expectation was that service reviews would contribute significantly to achievement of these targets and the position on any service reviews within this portfolio are shown in paragraph 6.3.
- 3.2 The overall Budget-Setting Report (BSR) to Strategy & Resources Scrutiny Committee on 17 January 2011 will include a review of all the factors relating to the overall financial strategy that were included in the Medium Term Strategy (MTS).
- 3.3 For 2011/12 provision was made for a Priority Policy Fund (PPF) of £500,000 to provide funding for developments that can be demonstrated to make a significant contribution to the Medium Term Objectives, as set out in the Annual Statement so this report considers any items to be funded from PPF.
- 3.4 The report to Strategy & Resources Scrutiny Committee is expected to include details of the Government's Final Settlement for 2011/12 and the impact for Concessionary Fares and New Homes Bonus. The announcements are likely to be made shortly after the conclusion of the consultation periods, which end on 10 January 2011 and 24 December 2010, respectively.
- 3.5 Capital bids will be prioritised by the Executive at its meeting on 20 January 2011. Items in the existing Capital Plan and Hold List will also be reviewed to identify any which are no longer required, or where the current indicated timing for spending is no longer accurate. The Capital Plan can then be revised to take account of any changes required.
- 3.6 Further work is required on detailed budgets due to the corporate and departmental restructuring, so delegation to the Director of Resources will be sought from Council for authority to finalise changes relating to this and the reallocation of support service and central costs, in accordance with the CIPFA Best Value Accounting Code of Practice and the Service Reporting Code of Practice for Local Authorities (SeRCOP) which applies from 1 April 2011 i.e. for 2011/12 budgets.

4 Revised Budget 2010/11

- 4.1 The following table sets out the proposed revised revenue budget for this portfolio in comparison with the September 2010 budget.

- 4.2 On 17 February 2011, Council will consider for approval the revised budget proposals for this portfolio. The table above demonstrates a reduction in the use of reserves of £459,320 compared to the position at September 2010. See Appendix A for further details of amended budget proposals/changes.

5 Review of Charges

- 5.1 Proposals for the review of charges for this portfolio are presented at Appendix B. The effects of any proposed changes have been included in the base budget projections.

6 Budget 2011/12

- 6.1 A summary of the proposed budget for 2011/12 for this portfolio is shown in Table 2. This includes the effects of the proposed savings and unavoidable bids together with the impact of the proposed new charges.
- 6.2 The proposed savings, unavoidable bids and bids to existing or external revenue funding, identified during the budget process to date, are detailed in Appendices C and D.

Service Reviews

- 6.3 Service Reviews in this portfolio have been undertaken for Parking Services and Strategy & Partnerships (Sustainable City) and the anticipated net savings are shown in Table 2 and detailed in Appendix C.
- 6.4 Further reviews are being undertaken for Streets and Open Spaces and the Planning service (including a review of growth and/or fixed-term funded posts). A verbal update on these reviews will be given at the meeting.

6.5 Climate Change Fund (CCF)

- 6.5.1 A Climate Change Fund with an initial investment of £250,000 was agreed at Council on 21 February 2008 to be used to provide funding for schemes or activities that would contribute to the achievement of the Council's climate change and carbon reduction Medium Term Objective. An additional contribution of £250,000 was agreed at Council on 8 November 2010. A table detailing both approved and proposed bids to the Fund is included in Appendix L.

6.6 Local Authority Parking Enforcement (LAPE)

- 6.6.1 The management of the LAPE function transferred to Cambridgeshire County Council with effect from 1 April 2010. A table detailing both approved and proposed bids, that look to utilise the remaining LAPE surplus, is included in Appendix L.

6.7 Concessionary Fares

- 6.7.1 Since the introduction of the national Concessionary Fares scheme in England in April 2008, the City Council has faced significant shortfalls in funding.
- 6.7.2 With the support of the Local Government Association (LGA), the City Council, together with other authorities similarly affected, lobbied central government for adequate funding and in 2010/11 received additional funding through a special grant of £1.31m. Even with this additional grant, the City Council estimates a funding shortfall of approximately £600,000 in the year.
- 6.7.3 Despite the Operators' Reimbursement Rate for 2010/11 being set at a new lower rate of 63.9% (with an 'additional costs' allowance of 12p), latest projections

anticipate a further increased cost to the City Council and this is reflected by a revised budget bid of £60,000.

6.7.4 In relation to longer-term administration and funding arrangements, the Government made the decision to transfer the scheme to County and Unitary authorities from April 2011. Under the provisions of Statutory Order SI 2010 No 1179, made on the 31 March 2010, administration of the City element of the scheme will transfer to Cambridgeshire County Council with effect from 1 April 2011. The provisional Local Government Finance settlement for 2011/12 was announced on 13 December 2010. As anticipated, it included an adjustment to take account of the transfer of concessionary fares to the County Council. However, the adjustment proposed exceeds the Council's own estimate of total Government funding currently provided for the Concessionary Fares scheme by approximately £894,000. This issue is being urgently pursued with Government. Other local authorities appear to be in a similar position and the matter is also being taken up with the Local Government Association. The full implications of the transfer of funding will be considered as part of the Budget-Setting Report (BSR).

6.8 Since last year's budget report there have been further significant changes affecting external funding sources for this portfolio. These include:

- Housing and Planning Delivery Grant for 2010/11 withdrawn;
- Joint Planning Budget and Housing Growth Fund withdrawn;
- Cambridgeshire Horizons is due to be wound down from March 2011, with a six-month transition period

6.9 Housing and Planning Delivery Grant

- 6.9.1 The 3-year Housing and Planning Delivery Grant (HPDG) programme was intended to speed up plan-making and housing delivery. Government has now withdrawn the grant and no grant will be paid in 2010/11 (which was to have been the last year of the programme). Any unspent balance from 2009/10 can be spent on either Capital or Revenue expenditure.
- 6.9.2 The approved City Council budget for 2010/11 includes a figure of £777,720 for planned HPDG capital and revenue expenditure. All planned capital expenditure can be met from grant allocations made in the first 2 years of the programme, which have been carried forward. A sum of £340,570 HPDG revenue has similarly been carried forward into 2010/11 sufficient to meet much, but not all of the planned revenue expenditure. As a result, a revenue bid of £146,100 has been included in Appendix A, which is anticipated will meet the shortfall in funding. This shortfall has been offset in the current year by a predicted over achievement of planning application fee income of £320,000.
- 6.9.3 Tables detailing Housing and Planning Delivery Grant revenue and capital funding are shown in Appendix L.
- 6.9.4 As part of the 2010 MTS, a provision was made to extend by 12 months, the growth-related fixed-term posts that had been funded by those funding streams described in 6.8.
- 6.9.5 The funding for this commitment will be provided through an assumption that 50% (£436,950) will be met from external income sources, such as the New Homes Bonus scheme, with the remainder being met initially from use of reserves.

6.10 There are also a number of areas of uncertainty regarding national funding and legislative changes, including:

- New Homes Bonus;
- The government is consulting on allowing local authorities to set planning application fees locally to more accurately reflect the costs of development management;
- Announcements about the Community Infrastructure Levy indicate that the system will proceed, albeit in a modified form;
- A Greater Cambridge-Greater Peterborough Local Enterprise Partnership is due to be set up by September 2011 but it remains to be seen what functions it will cover and how far it might take on roles previously played by Cambridgeshire Horizons;
- Major changes to the planning system are a key element of the Localism Bill. This may include a role for neighbourhoods to produce their own plans and to deal with smaller scale development control proposals.

6.10.1 Due to the significant implications to the authority, the impact of these issues will be considered as part of the Budget-Setting Report (BSR).

7 Overall Revenue Budget Position

- 7.1 The approved budget proposals for this portfolio will be submitted to the meeting of Strategy & Resources Scrutiny Committee on 17 January 2011 and for consideration by the Executive at its meeting on 20 January 2011.
- 7.2 An overall summary of the budget proposals, as set out in this report, is shown below.

8 Capital - 2010/11 Revised Budget, Capital Bids and 2011/12 Proposed Budget

- 8.1 Appendix G shows the latest position against the 2010/11 Capital Plan at September 2010 for schemes and programmes within the Climate Change & Growth Portfolio, with variances explained in detail in the accompanying notes. A variance of £1,162,000 is anticipated of which £1,164,000 is due to slippage. The remaining variance of £2,000 relates to forecast net overspends on individual capital schemes and programmes.
- 8.2 Appendix H details the schemes which have been identified as bids for the Capital Plan.
- 8.3 Appendix I shows the Hold List. Section 13 of the Medium Term Strategy, approved in November 2010, highlighted the need to review current Hold List items.
- 8.4 Appendix J shows the Capital Plan for all the schemes and programmes within this committee's portfolio (including any approvals since the MTS was published in November 2010, but before any changes arising in paragraphs 8.1, 8.2 and 8.3 above).

9 Public Consultation

- 9.1 For a number of years the Council's budget process has included consultation with the citizens of Cambridge to find out which services were most important to

residents and what they thought spending and savings priorities should be for the coming budget year.

- 9.2 We have used a mixture of surveys and workshops to build up trend data on the views of residents about spending and saving priorities and we have found that views have been quite consistent over time.
- 9.3 This year we included a survey within the autumn edition of “Cambridge Matters” which asked residents to prioritise the Council’s services in terms of their relative importance. A total of 449 households responded to the questionnaire. Of these, 36 responses were received through the council’s website where the survey was also made available.
- 9.4 In broad terms the results reflect previous surveys - respondents placed greatest importance on our core services: collecting rubbish, recycling, cleaning the streets and maintaining our parks and open spaces. They also placed high importance on working with the police to tackle crime and anti-social behaviour. Respondents placed least importance on managing ticketed events and free events. Respondents were split over some services, for example:
- 17% said CCTV was of high importance and 35% said CCTV was less important.
 - 28% said ‘Planning for new housing, including affordable housing and designing attractive new neighbourhoods’ was of high importance whilst 19% said it was less important.
 - 28% said ‘Providing and maintaining sports and leisure services such as swimming pools’ was of high importance whilst 16% said it was less important.

10 Options / Implications

- 10.1 In relation to bids, the decisions made may have a number of implications. A decision not to approve a revenue bid will impact on managers’ ability to deliver the service or scheme in question and could have staffing, equal opportunities, environmental and/or community safety implications. A decision not to approve a capital or external bid will impact on managers’ ability to deliver the developments desired in the service areas.

1.3 The Procurement

Implementation of the works will be undertaken by Cambridgeshire County Council's current contractor. This contractor was procured by the County Council following a competitive tender in compliance with the County Council's regulations. The City Council's own Contract Procedure Rules are satisfied by the process that the County Council has

followed in the procurement of the services that the City Council is to part pay for.

2 Capital Project Appraisal & Procurement Report

2.1 What is the project?

The project is to significantly improve the Tins Path from Burnside to the railway bridge. This section of the path is currently very narrow with poor surfacing and lighting and is a well-used off-road route linking Cherry Hinton to Mill Road, avoiding Coldham's Lane and the busy Barnwell Road/Brooks Road roundabout. Land has been purchased by Cambridgeshire County Council from the Territorial Army in order to widen from 1.8m to 4m. The narrow wooden bridge at the entrance to the path will also be widened to 3m.

The scheme has been approved by the County Cabinet and the Cambridge Environment and Traffic Management Area Joint Committee in February and April 2010.

2.2 What are the aims & objectives of the project?

The aim of the project is to create a high quality cycling and walking link. Widening the path and improvements to the lighting will allow cyclists and pedestrians to pass one another as well as improve the environment from a personal safety perspective.

The scheme is in line with the City and County Councils' commitment to encourage cycling and walking and to cater for the growth of these modes of transport related to the growth agenda. The relevant vision in the Annual Statement is 'A city where getting around is primarily by public transport, bike or on foot.'

2.3 Summarise the major issues for stakeholders & other departments?

Land negotiations between the Territorial Army and Cambridgeshire County Council have been prolonged but

agreement has now been reached although official documents have not yet been signed. Works will not be started until the purchase of land has been completed.

It was initially proposed that the path from the new leisure development on Norman Way to Railway Street in Cherry Hinton also be improved but, due to opposition to the hedge removal in order to allow for the path widening, this has not been pursued. The area to the south of the hedge is identified as land for development and so an alternative route along the edge of any development could be provided in the future.

Following discussions on these schemes with local members and the Cambridge Cycling Campaign, a period of public consultation was undertaken. Manned exhibitions were held at a variety of venues with leaflets delivered to homes and schools, advertisements in the Cambridge News, and some press and radio coverage to publicise the events. Plans for all of the schemes were available at each venue. Plans of the proposals could also be viewed on the County's website.

Consultees were asked to complete questionnaires (also available on line) indicating whether they supported the proposed details shown. They were also encouraged to add comments.

There was notable support for improvements to this route with 50% of respondents in favour. Only 3% of respondents were opposed to making improvements to this route. Quite a significant number of people responded with 'no opinion' as the route tends to be used by residents in the east of the city only. The Cambridge Environment and Traffic Management Area Joint Committee was consulted on the scheme proposals at its meeting on 25th January.

2.4 Summarise key risks associated with the project

The project addresses the risk that people will not choose to walk or cycle because of the perceived inconvenience and danger of the existing narrow and poorly lit path.

The key risk associated with the project is that the agreement for the purchase of land is not signed. Work will not commence until the agreement is completed.

As a significant portion of the funding is from the Cycling England budget the scheme will only commence if the works can be completed by the end of the financial year when the Cycling England programme ends.

2.5 Financial implications

- a. Appraisal prepared on the following price base: 2010/11
- b. This is the last year of approved funding from the Joint-Funded Cycleways Capital Programme, so this project aims to use some of the remaining resource. A capital bid to extend the Cycleways capital programme is expected to be made to the Environment Scrutiny Committee in January 2011.

1.3 The Procurement

The Works contract (which has an estimated valued of £100,000 - including the related professional services listed below) will be competitively tendered in accordance with the new Contract Procedure Rules (the Rules).

The following professional services required for this project will be procured in accordance with the Rules:

- Structural and civil engineering
- Quantity surveying
- Work relating to Construction Design and Management Regulations (CDM).

The costs of these professional services are likely to account for between 10-12% of the total contract value.

It is recommended that the contract be let on the basis of the most economically advantageous tender taking account of both quality and price. This will be based on 60% cost and 40% quality.

2 Capital Project Appraisal & Procurement Report

Significant damage to the north wall of the Grafton Centre West Car Park has occurred. This damage is in the form of a rotation of the basement and retaining wall; this has been caused by subsidence of the underlying clay soil when moisture was extracted at depth. The repairs to the North wall should consist of removing the facing brickwork between the Level 1 basement wall and the Level 3 parapet, west of the access steps. The north wall should be underpinned to a depth of approximately 2.5m below ground level. The underpinning process could include jacking in an attempt to return the wall to its vertical position. Following these works the brickwork would then need rebuilding.

As a result of significant subsidence on the Grafton West Car Park wall and as a result of Peter Dann Consulting Engineers structural investigation and report. It has been deemed that investment in structural repairs at this car park is considered essential and unavoidable. These works will consist of replacing and restoring the structural integrity of the Salmon Lane wall at Grafton West multi story car park that will include:

- Essential structural repairs
- Demolition of defective brick walls, buttress walls and foundations
- New facing brickwork walls and buttresses, fixings, metal brackets and angles, movement joints and the like.

Two alternative options were considered. To do nothing, and to carry out localised repair work only. The option of doing nothing was considered. However, this was rejected as to leave the wall as it is will ultimately jeopardise the safety and viability of the car park structure, requiring more severe and costly repairs, and placing the business operations at risk. Localised repair work will mean that

further repairs and testing will be needed to ensure that the structure remains sound which will incur significant and increasing costs, inconvenience and disruption, year after year.

2.1 What are the aims & objectives of the project?

The aim of the project is to deliver a much-improved structural wall at Grafton West multi storey car park thereby protecting potential major revenue streams to the Council from this car park.

2.2 Summarise the major issues for stakeholders & other departments?

It is recognised that the successful, safe management and continued operation of the substantial part of the car park throughout the refurbishment is a key objective, but that significant disruption to normal operations is inevitable throughout this project. These disruptions are anticipated to be during summer 2011 whilst the works commence. To minimise inconvenience to users it is proposed to plan the works to ensure that reduction in capacity is phased as works proceed. Local businesses, and regular users will be kept informed and consulted about changes and disruption to the operation both through the Cambridge Retail and Commercial Association and Love Cambridge Partnership. This will also include local residents leafleted to inform them of the works and inconvenience caused. The specific logistics and method statements about managing the works in an operating car park will be critical factors in selecting the successful contractor. It is also recognized that the project completion will have to be sensitive to the business needs at all times.

2.3 Summarise key risks associated with the project

The key risks which this project is intended to mitigate are further serious deterioration to the car park structure, and the associated costs and loss of business to the City Council, and to Grafton Centre businesses from reduced access to the car park, or closure of the car park altogether. Other risks potentially affect the services to the Cambridge community from the loss of a car parking facility and the associated impact on congestion in other parts of the city

centre. The same risks apply to any decision not to undertake the project.

The key delivery risks are:

- Disruption and inconvenience to users and to business from the works themselves, particularly during the main summer trading period
- Disruption to residents from the noise of works
- The potential overspend of the project, should further repairs become apparent in the course of the works.
