Any public representation received by the Department after 12 noon two business days before the relevant Committee meeting (e.g. by 12.00 noon on Monday before a Wednesday meeting; by 12.00 noon on Tuesday before a Thursday meeting) will not be considered.

The same deadline will also apply to the receipt by the Department of additional information submitted by an applicant or an agent in connection with the relevant item on the Committee agenda (including letters, e-mails, reports, drawings and all other visual material), unless specifically requested by planning officers to help decision-making.

At the meeting public speakers at Committee will not be allowed to circulate any additional written information to their speaking notes or any other drawings or other visual material in support of their case that has not been verified by officers and that is not already on public file.

1. Introduction

Aim

The aim of the Neighbourhood profile update is to provide an overview of action taken since the last reporting period, identify ongoing and emerging crime and disorder issues, and provide recommendations for future priorities and activity in order to facilitate effective policing and partnership working in the area.

The document should be used to inform multi-agency neighbourhood panel meetings and neighbourhood policing teams, so that issues can be identified, effectively prioritised and partnership problem solving activity undertaken.

Methodology

This document was produced using the following data sources:

- Crime and Incident data, from September 10 December 10 and as a comparison data from May 10 – August10 and September 09 -December 09.
- Information from the Neighbourhood Policing teams, December 10.

2. Previous Priorities & Engagement Activity

Previous Priorities

At the North Area Committee meeting on 30th September 2010 the following issues were adopted as priorities. The tables below summarise action taken and the current situation regarding the priorities that were set:



Response to Question - Seasonality of Violent Crime - City North


Data for 2007-2010 has been collated to show total numbers of violent crime per calendar month. This has been calculated to show the standard deviation of the data, meaning that anything that falls outside of the **red** lines on the graph can be classed as statistically significant. As can be seen below, there are peaks and troughs in the crime data, but there are no months across all of the years that can be classed as significantly high or low.

As can be seen above, March was the peak month overall over three years for violent crime (non-DV), whilst May, November and December were the highest months for violent crime with DV markers.

The offences in March work out as 99 in 2008, 54 in 2009, and 97 in 2010. 2008 and 2010 are fairly high in comparison with 2009, but there is no stand out year or event, which seems to really tip March into being the top month across the years.

3. Emerging Issues

Neighbourhood trends

Total crime in City North has decreased with 1099 offences reported over this four month period compared to 1150 offences in the previous period and 1110 offences reported in the same period last year.

There has also been an decrease in anti-social behaviour (ASB) incident levels in City North with 616 incidents reported over this 4 month period compared with 838 in the previous period, this equates to a 26% decrease. ASB levels are also lower than recorded for the same period last year.

Although crime and anti-social behaviour levels have decreased in comparison to the previous period this is expected due to seasonal trends (higher levels of offences and incidents have historically occurred during the summer months). Also the extreme weather conditions experience in December may have affected levels

West Chesterton

- Offence levels in West Chesterton have decreased to 265 offences reported from 287 the previous period. However, this is a slight increase compared to the 256 offences reported in the same period last year.
- Dwelling burglary offences have decreased compared to the previous period (29 offences vs. 34 offences) but remained stable compared to the same period last year (29 offences). Offence levels were particularly high in October, November and December however offence levels for August were low with just one offence occurring in the month. Is isn't possible to pinpoint a peak time of day as many of the burglaries occurred over a period of several days, possibly due to the occupants being on holiday at the time of the offence.
- Violent crime offences have remained stable compared to the previous period (44 offences vs. 46 offences) and also increased compared to the same period last year (36 offences). Hotspot locations for offences were Milton Road, Chesterton Road and Arbury Road. An offender had been arrested in 13 out of the 44 offences.
- There has been a large decrease in cycle theft offences in the ward over the period with 47 offences over the period compared to 86 in the previous period (45% decrease) and 71 in the same period last year.
 West Chesterton still has the highest level of cycle theft in City North and accounts for 35% of all cycle theft offences in the neighbourhood.
- Criminal damage offences have increased from 19 offences in the previous period to 33 in the current period and have also decreased in comparison to the previous year (26 offences).
- ASB levels have decreased from 152 incidents in the previous period to 132 incidents in this period. This is also a decrease compared to the

same period last year when there were 160 incidents and as already discussed a decrease in ASB is expected during the winter months. The hotspots for ASB were Chesterton Road, Arbury Road, Garden Walk, Milton Road and Victoria Road.

Environmental Issues

- Between September and December 2010 there were 11 reports of abandoned vehicles in the ward, compared with 7 during the same period the previous year. This included 5 vehicles, which were not on site following inspection and another, which was later claimed by its owner. In addition, a CLE26 notice was issued to one offender on behalf of the DVLA for not displaying road tax on a public highway and will result in a fine issued by the DVLA. A further case is currently pending investigation and another has been referred to the police. There were no specific hotspots.
- Between September and December 2010 there were 25 reports of fly tipping in the ward, compared with 7 during the same period the previous year. There was sufficient evidence to issue warning letters to 7 domestic offenders and waste transfer documentation was requested from a trade offender. Chesterton Road (4) and Milton Road (4) were the hotspots during this period.
- Between September and December 2010, 15 derelict cycles were dealt with compared with 37 during the same period the previous year. The reduction in number is primarily on account of a large number of cycles (11) abandoned in De Freville Avenue during same period the previous year.

Between September and December 2010, and also the same period during the previous year, no needles were reported

East Chesterton

- A decrease has been seen in the total number of offences reported in this four month period compared to the previous period (154 offences vs. 233 offences) and compared to the same period last year (221 offences).
- There were 40 dwelling burglaries in this period compared to 21 offences in the previous period and 37 offences in the same period last year. There doesn't appear to be a peak time of day for offences or a common MO used, but offenders stole small transportable items such as cash, jewellery and laptops.
- Violent crime offences have decreased from 75 offences in the previous period to 63 offences in this period. Offence levels have remained stable

compared to the same period last year when there were 65 offences. The majority of offences occurred at home addresses and were domestic violence related/occurred between people who knew each other. An offender has been arrested and charged in just over a third of these offences.

- Cycle theft has fallen compared to the previous period with 31 offences occurring in this period and 47 offences in the previous period. Offence levels have remained sable compared to the same period the previous year (31 offences). Offences occurred across the ward with no particular hotspots.
- There were 154 ASB incidents in this period compared to 233 incidents in the previous period and 221 in the same period last year. The number of incidents in Kendal way had halved since the previous period. Hotspots for ASB in this period were Green End Road and High Street.

Environmental Issues

- Between September and December 2010 there were 17 reports of abandoned vehicles in the ward, compared with 13 during the same period the previous year. This included 5 vehicles, which were not on site following inspection and a further 5 which were also impounded on behalf of the DVLA for not having valid road tax, and were subsequently destroyed for non-payment of the DVLA fine. A further two cases are currently pending further investigation. There were no specific hotspots.
- Between September and December 2010 there were 28 reports of flytipping in the ward, compared with 46 during the same period the previous year. There was sufficient evidence to issue a warning letter to a domestic offender. Green End Road (4) and Maitland Avenue and Church Street Recycling Centre (both with 3) were the hotspots during this period.
- Between September and December 2010, 19 derelict cycles were dealt with compared with 21 during the same period the previous year. Union Lane (4) and Bramblefields and Cowley Road (both with 3) were the hotspots during this period.
- Between September and December 2010, 19 needles were reported compared with 26 during the same period the previous year. The majority, 14, were removed from Church Street, close to the public toilets. 3 needles were also removed from the nature reserve at Logans Meadow.

Kings Hedges

- Total crime in has increased in the last four month period compared to the previous period (304 offences vs. 274 offences) and compared to the same period last year (252 offences).
- Dwelling burglary offences have decreased considerably over the period with 24 offences compared to 44 in the previous period and 41 in the same period last year. This could be a result of a prolific burglar who was active in Kings Hedges being arrested and remanded in late August.
- Violent offences have increased compared to both the previous period (87 offences vs. 79 offences) and compared to the same period last year (54 offences). Repeat locations for offences were Campkin Road, Haviland Way and Arbury Court. Offenders have been arrested and charged in 27 of these offences.
- Theft from shop offences have more than doubled to 24 offences compared to 11 offences in the previous period. Offence levels have remained stable compared to the same period last year (22 offences). The offences occurred at three location Tescos on Campkin Road (14 offences), Co-Op on Milton Road (6 offences) and Budgens at Arbury Court (4 offences).
- There were 174 ASB incidents in this period compared to 218 ASB incidents in the previous period and 214 incidents in the same period last year. Specific hotspot locations for incidents Campkin Rd (26 incidents, mainly related to youth disorder and noisy neighbours) and Arbury Court (15 incidents, mainly relating to street drinking and rowdy behaviour such as fighting by groups congregating in the area).

Environmental Issues

- Between September and December 2010 there were 4 reports of abandoned vehicles in the ward, compared with 14 during the same period the previous year. This included one vehicle, which was later claimed by its owner and another, which was not on site following inspection. A further vehicle was also impounded on behalf of the DVLA for not having valid road tax and was subsequently destroyed for nonpayment of the DVLA fine. There were no specific hotspots.
- Between September and December 2010 there were 70 reports of flytipping in the ward, compared with 86 during the same period the previous year. There was sufficient evidence to issue a warning letter to 2 domestic offenders and waste transfer documentation was also requested from one trade offender. Arbury Court (10), Campkin Road (9), Minerva Way (8) and Edgecombe (6) were the main hotspots during this period.

- Between September and December 2010, 14 derelict cycles were dealt with compared with 27 during the same period the previous year.
 Minerva Way (3) was a hotspot during this period.
- Between September and December 2010, 4 needles were reported, compared with 5 during the same period the previous year. 3 needles were removed from the recreation ground at Nuns Way.

Arbury

- Total crime in Arbury has decreased compared to the previous four month period (276 offences vs. 297 offences). This is a decrease compared to the 304 offences reported in the same period last year.
- Dwelling burglary offences have increased compared to the previous period (53 offences vs. 32 offences). Offence levels were high in December with 24 offences and low in September with only one offence. As mentioned above offences levels were low in September due to the arrest of a prolific burglar at the end of August.
- Theft from vehicle offences have decreased to 14 offences from 24 offences in the previous period. Offences mainly occurred overnight and in most of the offences where entry has been gained, offenders have mashed windows in order to do so.
- ASB incidents have decreased compared to the previous period (156 incidents vs. 235 incidents) and the same period last year (247 incidents). Specific hotspot locations for incidents were Histon Road (29 incidents including varied issues such as prostitution, street drinking and youth disorder), Victoria Road (19 incidents, mainly rowdy or drunken behaviour).

Environmental Issues

- Between September and December 2010 there were 15 reports of abandoned vehicles in the ward, compared with 16 during the same period the previous year. This included 4 vehicles, which were not on site following inspection and another 2, which were later claimed by their owners. In addition, 2 CLE26 notices were issued to offenders on behalf of the DVLA for not displaying road tax on a public highway and will result in a fine issued by the DVLA. One vehicle was also impounded on behalf of the DVLA for not having valid road tax and was subsequently destroyed for non-payment of the DVLA fine A further case was referred to the Council's Housing department and another is currently pending further investigation. There were no specific hotspots.
- Between September and December 2010 there were 97 reports of flytipping in the ward, compared with 100 during the same period the previous year. There was sufficient evidence to issue a warning letter to

one domestic offender and a verbal warning to a trade offender. Hazelwood/Molewood Close (21), Fordwich Place/Close (10), Cockerell Road (8) and Brackley Close (7) were the main hotspots during this period.


- Between September and December 2010, 22 derelict cycles were dealt with compared with 24 during the same period the previous year.
 Cockerell Road and Stretton Avenue (both with 4) and Carlton Way (3) were the hotspots during this period.
- Between September and December 2010, 26 needles were reported, compared with 12 during the same period the previous year. 25 needles were removed from Histon Road, primarily at Histon Road Cemetery, although 10 of which were found in a sealed pack and had not been used.

4. Recommendations


- Continue work to reduce the impact of school run traffic related issues at the Shirley School
- Continue to tackle issues related to sex worker activity in the Histon Road area.
