1. After the completion of the Committee report, representations were received from the occupier of No. 2 The Grove. The representations raise the following issues:

- Overshadowing
- Loss of privacy
- Visual amenity
- Car parking
- Noise and disturbance
- Design and appearance
- Intensity of use

I have addressed all these issues in the Committee report, and the representation does not alter my assessment of the application.

2. After the completion of the Committee report, advice was received from the highway authority. The highway authority requested details of parking space dimensions and visibility splays before determination, and also recommended conditions relating to unbound material, layout of the vehicle crossover, drainage, and implementation and maintenance of the access and manoeuvring areas.

In my view, details of the parking space dimensions and visibility splays can be secured by condition; there are no constraints on the site which would make adequate spaces or splays impossible to achieve. Were the application to be approved, I recommend that conditions be attached to address all the issues raised by the highway authority. The advice of the authority does not alter my assessment of the application.

3. After the completion of the Committee report, advice was received from the Head of Environmental Services. No objection was raised; the advice recommended conditions relating to construction hours, construction deliveries, and waste storage.

Were the application to be approved, I recommend that conditions be attached to address the three issues raised by the environmental health officer. The advice of the Head of Environmental Services does not alter my assessment of the application.
