Information for the public

Public attendance

Filming Protocol

Paragraph 7.6 should read:

Investment properties – Under the Code, movements in the value of investment properties are now shown in the CIES as financing and investment income. Previously, changes in value were credited or charged to the revaluation reserve or to the income and expenditure account as appropriate. There is no change to General Fund or HRA balances as movements are transferred out via the Capital Adjustment Account. Rental income and expenditure on investment properties is now also shown as financing and investment income, as opposed to against trading operations or the relevant cost of service line.

Paragraph 8.9 should refer to Note 24 to the Statement of Accounts.
