REVIEW OF POLLING DISTRICTS, POLLING PLACES AND POLLING STATIONS

1. INTRODUCTION

- 1.1. For electoral purposes, the council is required to divide each parliamentary constituency in the area into polling districts for parliamentary elections and to designate polling places for each of those polling districts. The polling place may be a building or a defined area in which a polling station will be located. The Acting Returning Officer is responsible for designating the location of the polling station.
- 1.2. The Electoral Registration and Administration Act 2013 introduced a change to the timing of the review of polling arrangements and it is required that the next review must be completed by 31 January 2015. The current review was brought forward to avoid a conflict with the work required for the introduction of Individual Electoral Registration in June 2014.
- 1.3. An introductory report was placed before committee and considered on 19 September 2013, detailing the review and consultation process.

2. **RECOMMENDATIONS**

2.1. That the committee approve changes to the current polling district arrangements (as laid out in appendix 1) as a result of the consultation, which ended on 22 November 2013 and recommendations made by officers.

2.2. That all changes be implemented for the next publication of the revised register on 17 February 2014.

3. **BACKGROUND**

- 3.1. Each local authority in Great Britain is responsible for reviewing polling districts and polling places in its area. The Civic Affairs Committee has been delegated this function.
- 3.2. Responsibility for deciding how many polling stations are required for each polling place lies with the Acting Returning Officer for Parliamentary elections, who must allocate electors to the polling stations in such a manner as they think most convenient.
- 3.3. The last review of polling districts, places and stations in Cambridge was completed on 1 December 2010.
- 3.4. Public notice of the review was given on 1 October 2013, with a timetable as follows:

Publish notice of the review	11 October 2013

Changes made to Register of Electors	17 February 2014

- 3.5. In considering any proposals to change the polling districts or polling places, two key factors must be addressed in the reasoning given for the change to or maintaining the status quo:
 - The reasonable requirements of the electors in the constituency, and
 - The accessibility for disabled persons to the probable polling stations within the polling place.

4. **CONSULTATION RESPONSES**

- 4.1 Notice of the consultation was advertised and posted on the council website and via social media. The following interested parties were also informed of the consultation: City and County Councillors, MP's local community groups, disabled groups and local political parties.
- 4.2 The following responses were received by the deadline of 22 November 2013:

- 4.3 The above responses have been taken into account with the recommended boundary changes at appendix 1.
- 4.4 In my capacity as the (Acting) Returning Officer, I need to ensure we balance any proposal put forward with the convenience and accessibility for the elector. The small number of comments received in this consultation reflects that the polling districts are on the whole adequate. We do need to keep polling districts under review however, to ensure new residential development across the city is taken into account. I will also ensure that the location of polling stations is suitable, given the availability of such buildings.

5 CONCLUSION OF THE REVIEW

- 5.1 The council must agree final proposals for the polling districts and polling places, taking account of any representations received. The final proposals then have to be placed on public deposit, together with copies of all correspondence and representations relating to the review. The reasons for the choice of every polling district and polling place must be given; these do not have to be too detailed but should show how accessibility issues were considered.
- 5.2 The register must then be altered to show the changes in polling districts. If the changes have been agreed before the publication of the revised register then the alteration can wait until that time. Otherwise alterations will be made by the publication of another revised register, giving public notice of the fact.
- 5.3 Following the conclusion of the local authority's review, individuals have a right to make representations to the Electoral Commission. Representations to the Commission should be made within six weeks of the publication date of the finalised review. The Commission will only consider representations that the review process has not been conducted correctly.

- 5.4 Should the Commission's decision be to alter a polling district, the Electoral Registration Officer would need to republish its electoral register to incorporate the new changes.
- 5.5 In accordance with the Representation of the People Act 1983, the Commission may direct the local authority to consider alterations to the polling places, as the Commission deems necessary under the review. After two months, if the local authority has failed to make the alterations the Commission is empowered by the Act to make the alterations themselves as if the local authority had implemented them.

6 **IMPLICATIONS**

(a) Financial Implications

Each year there may be changes in the total cost for polling stations depending on the chosen venues. With the recommended extra polling stations in this report there will be an increase in costs and also an increase in staff costs to run the stations on polling day.

(b) Staffing Implications

There are no staffing implications.

(c) Equal Opportunities Implications

An Equality Impact Assessment for elections is attached at appendix b.

(d) Environmental Implications

This report has a NIL climate change impact.

(e) Procurement

No procurement is required for this project.

Changes to Market Ward

No boundary changes are recommended to Market ward, however since the refurbishment of Fisher Hall, it is acknowledged that the building is no longer suitable for a double polling station and it is therefore planned to relocate the HA polling station to its own site. The hall at St. Columba's in Downing Street has been used previously and is suggested as an alternative suitable site.

Changes to Newnham Ward

No boundary changes are recommended to Newnham ward, however the siting of a polling station in IA has become increasingly difficult in recent years. A station located at Trinity Old Field site in Grange Road has been agreed in principle, however, disable access must be addressed before the site can be confirmed. We are currently in discussion with Trinity regarding alterations to the building, but if this cannot be resolved, we will revert to using a portable unit on the site of the Rugby Ground in Grange Road.

The creation of a new polling district requires a third polling location to be found. The suggested site of St. Stephens Church Hall is unfortunately unavailable due to extensive building work planned over the coming months. A secondary site has been identified at a hall in Vinery Road, belonging to St. Phillip's parish and we are again awaiting a site visit to be agreed.

Rising 18's (16 & 17 year olds are entitled to register in advance of their 18th birthday) and young people/students (the 18-24 age group is traditionally under-registered and disengaged with democracy). POSITIVE impact: Increased voter engagement activity and publicity from registration drives and Electoral Commission campaigns. Working with schools/colleges to loan ballot equipment and visit in conjunction with external groups. Publicity on forthcoming changes to registration will increase awareness.

Older electors - traditionally registered but may have difficulty accessing voting facilities. POSITIVE impact: Polling stations are kept under review to ensure that as far is reasonably practical, premisies are accessible. This is achieved by providing clear signage to the station, installing temporary ramps where required, providing seating for those who may need to rest and training staff to assist as necessary. Access for voters arriving at the pollingstation by car are considered but not always possible at some locations. The option to have an absent vote is promoted.

(b) Disability (including people with a physical impairment, sensory impairment, learning disability, mental health problem or other condition which has an impact on their daily life)

Physical imparements that limit mobility - POSITIVE impact: Polling stations are kept under annual review to ensure that as far as is reasonably practical, premisies are accessible. This is achieved by providing clear signage to the station, installing temporary ramps where premises do not already have permanant disabled access, ensuring the layout of the room can facilitate wheelchairs or people with walking frames/crutches and providing seating for those who may need to rest. Access to polling stations for voters arriving by car is considered but not always possible at some locations.

Visual impairments - POSITIVE impact: Poll cards are provided in an increased size and magnifiers, large version example ballot papers and a braille ballot overlay template are avaliable in polling stations. Where control over ballot paper colour is permitted, its use by partially-sighted electors is considered to provide clearer print visibility. A braille booklet explaining the election process is avaliable on request.

Learning disabilities - POSITIVE impact: A booklet is avaliable in an easy-read format explaining the election process.

In all cases, polling staff are given guidance and training in order to be able to assist any elector who may need help with the voting process. Provisions in law allow the Presiding Officer to mark a ballot paper for an elector if they are unable to do so themselves. Alternatively, provisions also allow electors to have assistance from a relative/friend to help them vote.

POSITIVE impact: polling station staff are given guidance and training to assist as required and seating at polling stations is made avaliable. The layout of the polling station is such that access for prams/pushchairs is considered.

(e) Transgender (including gender re-assignment)

No known impact.

(f) Marriage and Civil Partnership

No known impact.

(g) Race or Ethnicity

NEGATIVE impact: Current electoral law does not allow printing of official election materials (e.g. application forms, ballot papers, postal vote packs, polling station signage) in any language other than English or Welsh. Translations of explanitory materials, (leaflets, booklets etc.) can be provided on request.

(h) Religion or Belief

NEGATIVE impact: Use of religious or consecrated building may discourage other faith groups from voting. There are currently 18 out of 33 buildings in use which belong to a particular faith group. Due to the requirement to provide polling stations in a specified area (a polling district) and the requirement to make them accessible to all, it is often not possible to secure the use of a more generic facility. In these cases, we promote the absent voting facilities if the use of such a building is unavoidable. These buildings have been in use for many years without this particular issue arising, however it should be kept under review and considered as part of the process when selecting new polling station buildings.

The conduct of elections is heavily legislated as well as under scrutiny by the Electoral Commission. In general such regulations and guidance are intended to promote equal access to elections, but some constraints are imposed which prevent further action being taken. E.g. the provision of official documents in languages other than English/Welsh.
