#### **Information relating to Area Committee meetings**

Council agreed on 27 May 2021:

"That Area Committees continue to be run virtually up to 31 December 2021 initially, with a review by Civic Affairs Committee in the autumn on a more permanent change and to request that the Monitoring Officer make necessary immediate amendments to the Council's Constitution to give effect to this change."

As Councillors will be aware, the Government did not extend the provisions in the Coronavirus Act 2020 beyond 7 May 2021 to enable councillor decision making to take place virtually.

Area Committees, by being virtual and not in person, will therefore not be able to make any decisions either independently or that have been delegated by the Executive (eg area committee grants-which are not scheduled to be considered until spring 2022).

Civic Affairs Committee will consider the pros and cons of continuing with virtual Area Committees in the autumn. At Council on 27 May, Members asked that other considerations are also included in the review (eg the boundaries of the current Area Committees, the format). Councillors views will be canvassed as part of the review.

The Constitution needs to be amended to reflect that Area Committees will be non-decision making **for as long as they are held virtually**.

The changes to the Constitution are as follows:

#### Article 8

- 8.2.5 Area committees have these principal purposes:
  - To make decisions concerning executive and regulatory functions of the Council which have been delegated to them;

Deleted as Area Committees cannot make decisions whilst being held virtually.

#### Part 3 Section 11

This section describes the Council functions for which area committees are to be responsible for.

This will not apply in so far as Area Committees operating as virtual meetings cannot be decision making. Area Committees can advise and decisions will be taken subsequently by the relevant person or body empowered to do so taking into account the views of the Area Committee.

#### Part 4EE: Area Committee Procedure Rules

6.1 An area committee shall, at its first meeting of the municipal year, elect City Councillors as Chair and Vice-Chair and shall be responsible for filling any vacancy.

This procedure rule will not apply whilst Area Committees are virtual.

#### **Appointing a Chair and Vice-Chair**

Part 4EE 6.1 makes it clear that Chairs and Vice Chairs are appointed at the first Area Committee of the new Municipal Year

However this presents a difficulty in how a Chair/Vice Chair is agreed upon as the area committees, by being virtual, cannot make any decisions, and this includes the election of a Chair and Vice Chair.

Although the meetings at least until 31 December will be non-decision making, it is still desirable to have a named Councillor co-ordinating matters in between meetings amongst both Councillors and Officers and to co-ordinate the discussion at the meetings themselves.

Officers will report to the meeting how a Chair/Vice Chair can be agreed upon.

#### **County Councillors present at Area Committee**

Members are reminded that County Councillors are co-opted to the area committee where the clear majority of the County Council Division is within the area committee. [When making decisions as an Area Committee County Councillors may vote on all matters except for any decision relating to city council funding and the election of the Chair and Vice Chair].

Note-some county councillors have chosen to also attend area committees where less than the majority of a Division is in that area.

#### 21/3/SAC Minutes

The minutes of the meeting held on 7 September and 30 November 2020 were approved as a correct record by the Chair.

#### 21/4/SAC Matters and Actions Arising from the Minutes

The committee action sheet was noted. Councillors would send any updates to the Committee Manager outside of the meeting.

Minute reference: 20/10/SAC and 21/04/SAC Open Forum

- Action:
  - Cherry Hinton City and County Councillors to contact Richard Ling (Team Leader, County Council) to compile a list of pedestrian crossings where the timings need to be changed.
  - Councillor Jones asked for examples from across the city to pass onto County Officers via SAC Chair and County Councillors.
- Progress:
  - Councillor Jones asked for details from stakeholders that she could forward on as examples. None have been received to date.

#### 21/5/SAC Open Forum

A member of the public raised the following issues:

- i. In March 2020 County Council Officers came to South Area Committee and gave £800,000 cost figure for the Dutch Style Roundabout.
- ii. The cost increased due to utilities work.
- iii. Took issue with the figures given by County Officers. This was an issue of transparency.

Councillor McPherson said the County Council had been contacted and their response published on the South Area Committee webpage containing this meeting agenda. Suggested that further queries regarding the Dutch Style Roundabout costs should be directed to the County Council.

Councillor Taylor said she and Liberal Democrat Councillors were taking up this issue at the County Council via the Highways and Transport Committee. A report was due 9 March 2021 regarding the Dutch Style Roundabout project details. Regular reporting was expected to the Committee and local councillors in future.

### 21/6/SAC Policing and Safer Neighbourhoods

The Committee received a report from Sergeant Mazur regarding policing and safer neighbourhoods trends.

The report outlined actions taken since the last reporting period. The current emerging issues/neighbourhood trends for each ward were also highlighted (see report for full details). Previous local areas of concern and engagement activity noted in the report were:

- i. Traffic [general] and anti-social behaviour by drivers of vehicles and motor bikes in the AURA, Lime Avenue and Hobson Avenue areas of South Trumpington;
- ii. Support for funding so Police Officers can be trained to use decimetre to monitor decibels of noise from vehicles and motor bikes, as part of general monitoring of speeding and anti-social behaviour by drivers/riders;
- iii. Drug dealing around the Clay Farm Centre;
- iv. Drug dealing and anti-social behaviour around Cherry Hinton Hall; and
- v. Policing of the 'Cambridge Lakes'.

The Committee discussed the following policing issues:

i. Bike theft in Trumpington Ward, such as Great Kneighton.

Members of the public raised the following policing issues:

- i. Bike theft from:
  - a. Ninewells apartments due to poor building security.
    - i. Thieves could break in without leaving signs of doing so.
    - ii. The Police listed Trumpington buildings as exemplars of 'secure by design' initiative, which was a misnomer that needed to be corrected as the secure bike areas were not fit for purpose.
  - b. City centre and railway station.
- ii. Drug dealing and anti-social behaviour around Cherry Hinton Hall. The City Council were not installing CCTV cameras at Cherry Hinton Hall.
- iii. Anti-social behaviour in the Trumpington area.

Councillor Thornburrow (speaking as a Planning Committee Member and Executive Councillor for Planning Policy and Open Spaces) said the Planning Committee reviewed general building details when they came to committee, the Police signed off general details, but third party (ie developer) was ultimately responsible for bike storage security as they detailed the materials and construction. Councillor Thornburrow would liaise with Ninewells residents and the developer (Hills).

Councillor McPherson encouraged people to report crimes/issues to the Police either through ringing 101 or other methods such as on-line. The Police would use information to build up intelligence data. Sergeant Mazur encouraged residents to invite the police to attend resident association meetings. She was happy to be the South Area contact.

Councillors requested changes to the recommendations.

- i. Councillor McPherson formally proposed to add the following priority: Drug dealing, moped riding and anti-social behaviour around Cherry Hinton Rec and Cherry Hinton Hall.
- ii. Councillor McGerty formally proposed to add the following priority: Bike theft in Ninewells and Trumpington Ward.

The amendments were unanimously agreed.

The following priorities were unanimously agreed:

- i. Continue work to tackle vehicle-related antisocial behaviour and driving across the South of the City.
- ii. Continue work (patrols and diverting young people away from crime and antisocial behaviour) across the South of the City, with specific focus on Trumpington Ward.
- iii. Drug dealing, moped riding and anti-social behaviour around Cherry Hinton Rec and Cherry Hinton Hall.
- iv. Bike theft in Ninewells and Trumpington Ward.

#### 21/7/SAC SAC Area Committee Grants 2021-22

The Committee received a report from the Community Funding & Development Manager regarding Community Grants.

The Officer's report detailed applications received to date for 2021-2022 funding for projects in the South area and made recommendations for awards. It also provided information on the eligibility and funding criteria.

Following discussion, Members **resolved (unanimously)** to agree the proposed awards detailed in Appendix 1 of the Officer's report and summarised in the table below:

#### 1. Introduction

This report provides an overview of the Council's Streets and Open Spaces, Environmental Health and Shared Waste service activity in the Area Committee area over the past six months.

This report provides open data on service performance, so that City and County Councillors and their constituents are informed of what service activity is happening in their area; and has the opportunity to engage in and help to shape this activity, including identifying specific local service requests/ issues.

- 1. Streets and Open Spaces Operations Team:
  - a. Street cleansing and Grounds Maintenance cleans all residential streets and public land and maintains all grass and shrub beds across the city.
  - b. Community Engagement Team works with Community Payback and Streets and Open Spaces volunteers to deliver community nominated improvement projects.
  - c. Dog Service works to deal with dog fouling and stray dogs across the city
  - d. Enforcement Team investigate and take action against instances of environmental crime in public places across the city.
- 2. Streets and Open Spaces Assets Development Team:
- 3. Streets and Open Spaces Projects Team
  - a. Projects
  - b. Parks
  - c. Trees
- 4. The Greater Cambridge Shared Waste Service provide rubbish and recycling collections from homes and business in Cambridge and South Cambridgeshire and empties 32,000 bins each day. It is responsible for setting policy on how this should be done and educating residents and customers on how best to recycle.
- 5. Environmental Health:
  - a. Pest control free treatments for rats, mice, cockroaches, bedbugs and pharaohs ants
  - b. Private sector Housing interventions complaints and investigations regarding condition of properties
  - c. Other public health interventions refuse, hoarding, bonfires
  - d. Noise complaints day time and night time noise complaints,

### 2. South Area Profiles

In this section an update of what teams have been doing in the previous six months is detailed.

- Regular proactive and reactive patrols carried out across the wards.
- Fly-tipping hotspot areas highlighted.
- New signage installed to deter behaviour.
- Continued working in conjunction with residents, friends of groups and supporting volunteers
- Regular patrols of the green open spaces conducted across the wards. During patrols poo bags are handed out to dog walkers as required.

### **Community Engagement Team**

Works including; SOS Volunteer Litter Picks, Green Teams, Corporate Events, Community Payback, Local Nature Reserves and Biodiversity. (The volunteer service resumed in April 2021)

#### **APRIL 2021**

Green Team: Conservation work at Cherry Hinton Hall. Volunteers helped to remove brambles from around young trees, coppiced some Elder which was shading the pond and removed lots of thistles from around the old oak tree.

SOS Volunteer Litter Pick: Cherry Hinton Hall

<u>Local Nature Reserves</u>: Wenvoe Meadow Volunteers planted wildflower plug plants and weeded invasive plants.



#### **MAY 2021**

SOS volunteers litter picked at Cherry Hinton Hall, watered saplings and made habitats for wildlife in the nature reserve, drilling holes in fallen trees Page 17

Local Nature Reserves: Volunteers helped to create and reprofile the pond margins at Wenvoe Meadow and built a Bee bank using alternating layers of clay and straw, sand and cement. This provides a range of nesting habitats for our native solitary Bees.

#### **Enforcement Team**

Regular patrols are conducted throughout the ward, spending approximately 15 hours a week dedicated to the area:

#### **Cherry Hinton Hall**

- Instances of dumped waste in the car park, consisting of electrical items, cardboard and bags of general waste. Investigations conducted, resulting in FPN 19 issued for flytipping.
- Dog on dog attack in the hall grounds. Suspected identified resulting in Police involvement.
- Abandoned items removed from the nature reserve after the area had been used for illegal gatherings during lock-down and reported illegal camping in a tent investigated.
  - Dog walkers not adhering to the Public Spaces Protection Order, Dogs on Lead Area
- around the pound and in the nature reserve. Patrols increase, dog walkers engage, verbal warnings given and an FPN 16 issued for failure to comply with the order.
- Dog fouling witnessed in the hall grounds, FPN 16 issued for failing to clear up after the dog immediately

#### **Welstead Road**

 Suspected abandoned vehicle investigated, resulting in the vehicle being claimed by the registered keeper.

#### St Bedes Crescent / St Bedes Gardens / Walpole Road

Highlighted as a fly-tipping hotspot area during this period. There have been many
instances of dumped waste, consisting of sofas, chairs, cardboard, furniture, electrical items
and other general waste which have been responded to and removed by this service.
 Further investigations have been conducted when evidence found, resulting in Warning
Letters issued and education in waste management given to residents.









 St Bedes Crescent. Dog control report passed on from the ASB team in February - Dog being allowed to stray loose in communal gardens and onto the Highway. Community Protection Notice (Warning Letter) issued. March further non-compliance from the dog's owner resulted in a Community Protection Notice issued. April FPN 17 served on the dog's owner for failure to comply with a Community Protection Notice.

#### **Glenmere Close**

 The area has become a fly-tipping hotspot over this period with large amounts of waste consisting of wood, rubble, furniture and other general items being dumped in the garage area. Investigations have been conducted, resulting in FPN 1 issued for littering and one investigation still on-going.



#### **Greystoke Court**

- Suspected abandoned vehicle investigation. Vehicle declared abandoned, removed to storage and destroyed after it was not claimed.
- Instances of fly-tipping in the area during this period, consisting of general household. Inspections conducted but no evidence found.



#### Limekiln

• Waste Fly-tipped in layby. Inspected but no evidence found, unable to trace suspect.

#### **Upperhall Court**

 Two suspected abandoned vehicles investigated which were subsequently claimed by the registered keepers.

#### **Ainsdale**

- Untaxed vehicle reported by customer. Vehicle not at site at time of inspection.
- Suspected abandoned Motorbike investigated and declared abandoned. Motorbike removed to storage and destroyed after it was not claimed.

#### **Church End**

- Five suspected abandoned vehicles investigated, which resulted in the vehicles either moved from the site or claimed by the registered keeper.
- Continued problems with the high volume of vehicles parked. Monitoring of the businesses
  in relation to fixing and repairing vehicles on the highway is on-going and reports of vehicles
  parked on double yellows lines have been passed onto the County Council Parking Team.
  One incident of fly-tipping
- Littering from a vehicle witnessed. FPN 1 issued for littering.

#### **Colville Road**

- Suspected abandoned vehicle investigated. The registered keeper claimed the vehicle and removed it from the site.
- Throughout this period there has been instances of mattresses, fridges and other large household items dumped on the grass verges. Door knock enquires have been made but unable to trace suspect.

#### **Queens Meadow**

- Suspected abandoned vehicle reported. On inspection the vehicle was no longer at the site.
- Dog repeatedly straying loose at Queens Meadow and onto Coldhams Lane. Dog owner identified and Community Protection Notice issued.

#### **Chalfont Close**

• Suspected abandoned vehicle reported. On inspection the vehicle was no longer at the site.

#### **Rush Grove**

 Three large black bags containing household waste dumped on pavement. Investigated and suspect identified. Community Protection Warning issued, with on-going monitoring.

## Bliss Way / Fulbourn Old Drift / Langdale Close / Tenby Close / Kelsey Crescent / Highdene Road

There have been many instances of furniture, mattresses,
electrical items, sofas and other general waste dumped throughout this area during the
period. Investigations have been conducted and perused where evidence found.

#### Harcombe Road

 Two suspected abandoned vehicles investigated, resulting one being moved from the site and one claimed by the registered keeper.

#### **Cherry Close**

• Suitcase containing household waste dumped. Search but no evidence found.

#### **High Street**

- Two businesses issued FPN 7's for failure to manage business waste correctly and not adhering to a section 47 notice.
- Two instances of furniture dumped on the pavement. No evidence found.

#### **Teversham Drift**

- Wooden desk dumped on grass verge, no evidence found
- Suspected abandoned vehicle investigated. Vehicle moved by owner after 7-day letter issued.

#### **Leete Road**

- Verge parking issues. Contact made with the household and the parking arrangements discussed.
- Illegally placed estate agent board investigated.


#### **Bridewell Road**

#### **Operations Team**

During this period, we have continued to litter pick, empty bins, deep clean the streets, cut our hedges and shrubs and in March start grass cutting again. Even during the pandemic, we have continued to carry out these tasks in a safe manner concentrating on some deep cleaning of streets whilst there was a massive reduction in footfall during this time. Even with the massive reduction in footfall we still found that our bins needed emptying just as regularly, especially in our parks, as members of the public used these areas to take their daily exercise, and now lockdown measures are coming to an end people are using the parks more than ever, putting a lot of strain on the service. We are currently in consultation about changing the bins and rounds to accommodate the extra waste that is left every day on the parks, so will hopefully keep them clean and green for all.

We are also trying to keep up with the influx of fly-tipping across the city, especially in our housing areas, where we seem to be getting the higher concentrations. The sort of flytip we are getting is also very hard to pass to our enforcement team, as there is no way of knowing where it has come from.


Also, in this period a new management plan has been drawn up regarding the use of glyphosate based weed killer. In conjunction with Streets and Open Spaces, City Homes, our Health and Safety team and the County Council Highways Department, we have drawn up a plan to stop using weed killers in any area other than footpaths and roads, unless it is needed for health and safety reasons. This includes all parks, shrub beds and grass verges within the city boundary. Some of this work started last year in some areas, but it has now been extended to cover a lot more of the areas that we maintain.

We are also now trialling areas of grass where we are to use a 'cut and collect' machine. This means these areas are only cut a few times a year but when they are the cuttings are removed, which helps reduce the grass growth and promote more wildflowers, in those areas.

In Cherry Hinton we have carried out 3 Graffiti removal jobs.

#### **Enforcement Team**

#### Mowbray Road / Fendon Road

- Patrols targeting verge parking are conducted regularly, resulting in eleven Warning letters and verbal warnings given during this period. Most of the verge parking violations occurred on Mowbray Road. There were no repeat offenders.
- Mowbray Road. Dog repeatedly straying from property into gardens. Dog owner identified and contact made. Liability denied, however no further reports of dog straying received.

- During a patrol littering whilst on foot witnessed, FPN 1 for littering issued.



### **Operations Team**

During this period, we have continued to litter pick, empty bins, deep clean the streets, cut our hedges and shrubs and in March start grass cutting again. Even during the pandemic, we have continued to carry out these tasks in a safe manner concentrating on some deep cleaning of streets whilst there was a massive reduction in footfall during this time. Even with the massive reduction in footfall we still found that our bins needed emptying just as regularly, especially in our parks, as members of the public used these areas to take their daily exercise, and now lockdown measures are coming to an end people are using the parks more than ever, putting a lot of strain on the service. We are currently in consultation about changing the bins and rounds to accommodate the extra waste that is left every day on the parks, so will hopefully keep them clean and green for all.


We are also trying to keep up with the influx of fly-tipping across the city, especially in our housing areas, where we seem to be getting the higher concentrations. The sort of flytip we are getting is also very hard to pass to our enforcement team, as there is no way of knowing where it has come from.

Also, in this period a new management plan has been drawn up regarding the use of glyphosate based weed killer. In conjunction with Streets and Open Spaces, City Homes, our Health and Safety team and the County Council Highways Department, we have drawn up a plan to stop using weed killers in any area other than footpaths and roads, unless it is needed for health and safety reasons. This includes all parks,

shrub beds and grass verges within the city boundary. Some of this work started last year in some areas, but it has now been extended to cover a lot more of the areas that we maintain.
We are also now trialling areas of grass where we are to use a 'cut and collect' machine. This means these areas are only cut a few times a year but when they are the cuttings are removed, which helps reduce the grass growth and promote more wildflowers, in those areas.
In Queen Edith's we have carried out 8 Graffiti removal jobs.

#### **Enforcement Team**

Regular patrols are conducted throughout the ward, spending approximately 15 hours a week dedicated to the area:

#### **Trumpington Meadow**

 Stray dog contained by a member of the public, collected by this service and reunited with his owner. A follow up warning letter was sent to the keeper requiring the dogs microchip record be updated. Warning letter complied with.

#### Hobson's Park


- Dog on Human attack reported. Bitten by a loose dog. Passed to Police for investigation.
- Dog fouling problem area reported. Increased patrols of the area conducted. Dog walkers engaged and poo bags handed out.

#### **Hobson Avenue**

 Suspected abandoned Motor Home reported. Investigation conducted. Deemed to not be abandoned. Vehicle not moved due to Covid restrictions.

#### **Anstey Way**

- Fly-tipping hotspot at the garage area behind the shops. Many instances of waste dumped inside the fenced area, currently used to store household bins. Waste consisting of sofas, tyres and general household items. Due to the on-going problem the Housing officer has been approached regarding the removal of the fence to open-up the area. All dumped waste inspected but no suspects identified to date. Fly-tipping signage installed. Drain unblocked and the road swept to tidy up the area.
- Storage of business waste at the site. Waste transfer agreement requested made. Continued monitoring of the business.
- Two black bags dumped next to litter bins. Searched but no evidence found.







#### Byron's Square

- The recycling point is constantly miss used and has recently been set on fire. Investigations
  into the large number of instances of dumped waste have been conducted and two
  Community Protection Notice (Warning Letters) issued. Fly-tipping signage has been
  installed.
- May 2021 Unauthorised encampment on the King George V Playing Field.

#### **Alpha Terrace**

Vehicle SORN on the highway. Removed under the untaxed vehicle process

#### **Gonville Place**

- Pushchair and children's toys dumped. No suspect identified.
- During a patrol witnessed littering whilst on foot FPN 1 issued.

#### **Tenison Road**

- Several incidences of waste dumped on the pavement investigated. Including black bags containing household waste. Education provided to residents regarding side waste and management of waste.

- Dog control report. Dog straying out of property into gardens. Joint working with housing, Investigation on-going

- Suspected abandoned vehicle investigated. Vehicle claimed by registered keeper.
- Cardboard dumped on pavement. Investigated but unable to trace suspect

#### **Piper Road**

Suspected abandoned vehicle investigated. Vehicle claimed by registered keeper.

#### **Glebe Farm Drive**

- A large number incidence of dumped waste at the underground recycling point. New signage has been installed, informing what can and cannot be recycled and fly-tipping signage put up to deter.
- Dog fouling problem highlighted by resident. New fouling signage installed.

#### **Addenbrookes Road**

- Suspected abandoned vehicle investigated. Vehicle was subsequently claimed and removed from the site by the registered keeper.
- Intimidating dog walked off lead reported. No suspect identified.

For this period a total of 72 incidents of dumped waste responded to and removed by this service. Investigations have been undertaken where evidence found.

In conjunction with Streets and Open Spaces, City Homes, our Health and Safety team and the County Council Highways Department, we have drawn up a plan to stop using weed killers in any area other than footpaths and roads, unless it is needed for health and safety reasons. This includes all parks, shrub beds and grass verges within the city boundary. Some of this work started last year in some areas, but it has now been extended to cover a lot more of the areas that we maintain.

We are also now trialling areas of grass where we are to use a 'cut and collect' machine. This means these areas are only cut a few times a year but when they are the cuttings are removed, which helps reduce the grass growth and promote more wildflowers, in those areas.

In **Trumpington** we have carried out **28** Graffiti removal jobs. (A lot of these were tags on litter bins/green comms boxes on Trumpington Road)
