21/26/WAC Welcome, Introduction and Apologies for Absence

Apologies were received from Councillor Gilderdale.

21/27/WAC Declarations of Interest

No declarations of interest were made.

21/28/WAC Notes of last meeting

The notes of the meeting held on 9 September 2021 were noted.

21/29/WAC Matters and Actions Arising From the Notes

21/14/WAC-Open Forum-Insurance for residents groups

Cllr Porrer advised the committee there was not a straightforward solution unfortunately and having investigated sufficiently it should be closed as an action.

21/30/WAC Open Forum

Members of the public asked a number of questions, as set out below.

1. How Fitzroy and Burleigh Street cycling and e-scooter use can be better controlled as people seemed to ignore the instruction that it is pedestrian only 10-4 Monday to Saturday. Also that some people did not understand what the signage prohibiting use during that time meant.

Councillor Bick said in the longer term how those two streets are used were to be included in a city centre access strategy. It was the intention that this would better reflect the mixed use and requirement of these two throughfares.

In the immediate term the only solutions could be enforcement by the Police (who were at the meeting and may respond to the points made) and a review of the signage by council officers.

Action: Head of Environmental Services (signage)

2. Re. the footpath at Skater's Meadow. Councillors had been circulated advice the member of the public had received from the Rambler's Association and the Open Spaces Society. The committee was asked that in support of the City Council's Sustainable Transport Policy, will the committee and the City Council now actively support Cambridgeshire County Council Highways in implementing the original plan of County Council Officers:- to install key-operated bollards to prevent unauthorised motor vehicles driving on the footpath, to ensure the safety of pedestrian and cyclists using the footpath?

Councillor Nethsingha stated that she had been personally trying to resolve this matter since it was raised in the summer and agreed it was unsatisfactory, although noting that the footpath was not unusable. Establishing land ownership was being pursued by the authorities to enable the County Council to pursue a course of action as there existed no chance of agreement amongst residents in the local area how to resolve the issue.

- Councillor Gehring stated that he would send the information circulated from the Ramblers and Open Space Society to the County Council.

- 3. Whether the bike racks moved from Bridge Street at the start of lockdown would be replaced. The Head of Environmental Services advised that 3 Sheffield Stands near Fitzbillies were removed. This was to permit easier movement of pedestrians. Overall more cycle parking has been added in the last year, but for these 3, there were no plans to re-instate.
- 4. Why there appears to be a total absence of policing and driver education on Maids Causeway despite this continual and flagrant law-breaking; what concrete steps the committee proposes to take in conjunction with the Police, City Council, County Council and local bus operators in order to remedy this nuisance; to confirm that the committee will ensure that the proposals of the Greater Cambridge Partnership are not likely to increase this nuisance (for example by virtue of an increased number of speeding buses); whether the proposals of the Greater Cambridge Partnership provide an opportunity for a radical redesign of Maids Causeway, to the benefit of residents, pedestrians and cyclists alike, for example with fully-segregated cycleways and increased green space as is proposed for sections of Newmarket Road.

Councillors Porrer and Bick replied. Anti social driving either car or motorbike was on the increase across the city. A trial of mobile 20mph flash signs are going to be deployed along Maids Causeway with help from the County Council. Local councillors were also investigating whether the council could deploy a mobile noise camera which would assist the police in gathering evidence to prosecute owners. This approach was being used successfully in a couple of London boroughs. Regarding Greater Cambridge Partnership's plans for Maid's Causeway, it was noted that this had been on a long list of potential schemes (to stop the cut through/rat running to Mitcham's Corner rather than via Elizabeth Way). Cllr Bick would investigate where this scheme had got to in the overall GCP programme development and report back.

5. Skateboarding is a hugely popular sport in Cambridge, but our facilities are not winter-appropriate. The installation of lights and CCTV would result in far more people using these facilities, reduce anti-social behaviour, and promote physical and mental wellbeing for Cambridge's young people. Our recent Light Sessions at Trumpington skatepark demonstrate the community's demand for this - around 50 skaters

attended and provided portable lights to make the park skateable. In both Jesus Green and Trumpington skatepark we see lighting on sports facilities neighbouring the skatepark. Skating deserves the same support.

The Head of Environmental Services undertook to contact camskate. Sgt Misik and Cllr Bick supported the proposal, noting that hours of operation, type of lighting would need to be sensitive to the neighbouring community and consulting local residents and ward councillors would be important.

21/31/WAC Policing and Safer Neighbourhoods

Sgt Misik introduced the report. He picked up the earlier conversation raised in the open forum regarding Fitzroy and Burleigh streets and would add it to the local lists of concern, but highlighted that the signage could also be looked at.

Councillors raised concerns about e-scooters on open spaces, Christs Pieces, Parkers Piece. These issues are now being regularly raised by residents. Sgt Misik referred Cllrs to contact Voi to geo-fencing areas (speed control in designated parts of the city) for the remainder of the trial period.

Councillors requested that the police consider retaining anti-social driving, including e-scooters and e-bikes as a police priority. The other current areas of concern remain important as detailed in the police report.

Sgt Misik undertook to liaise with the city council officers on the evidence gathered on the use of Voi scooters so that the Combined Authority received co-ordinated feedback on the trial.

21/32/WAC Making Connections: Have Your Say on Greener Travel in Greater Cambridge Consultation - WCAC

The committee welcomed the presentation from the officers and encouraged the public to participate in the current consultation.

21/33/WAC Greater Cambridge Local Plan - consultation

The committee received a presentation on the latest local plan consultation.

A member of the public asked: The Cambridge Assessment Site by Parker's Piece/Hills Road currently sits unused. I registered the site as being suitable for a new large concert hall for Cambridge, something that the City Council's Architect formally proposed in 1966 following confirmation by Sir Ivor Jennings QC in a speech in 1962 that the University would stump up 50% of the cost. The site is recommended for removal from the local plan. This is contrary to the commitment in your Indoor Leisure Facilities Strategy 2015-31 which says Cambridge needs a new large concert hall. The existing local plan has no clear site allocated for a concert hall. How do we go about getting this removal struck out? Who in The University is the decision maker who needs to be lobbied.

The planning officer advised that the area was designated for employment use in the adopted local plan. That site is not likely to come forward from the landowner for such cultural use. The council will continue to pursue cultural aspects of its planning policy, the well-being topic paper covers this in the current consultation.

The committee welcomed the current consultation and thanked the officers for their presentation.

21/34/WAC Oral update on City Centre Recovery-Head of Environmental Services

The committee noted that the update report from the head of environmental services had been circulated to all area committees this meeting cycle.

The committee thanked the officer for the update.

1. Executive Summary

- 1.1 This report details applications received for 2022-2023 funding for projects in the West Central area and makes recommendations for awards. As Area Committees are meeting virtually and therefore cannot make decisions, the committee will comment on the applications and the decisions on grant awards will be made by officers after the meeting, taking into account the committee's view.
- 1.2 The report provides information on the eligibility and funding criteria and the opportunity offered for Platinum Jubilee grants for local celebrations.

2. Recommendations

The West Central Area Committee Councillors are recommended to:

- 2.1 Comment on the grant applications received and awards proposed for West Central Area Committee grants detailed in Appendix 1, in line with the Area Committee Community Grants criteria detailed in paragraph 3.4.
- 2.2 Comment on the Platinum Jubilee grant applications received for activities in the west central area and awards proposed detailed in Appendix 2.

2.3 Comment on award proposals to enable officers to make decisions on the grant awards.

3. Background

- 3.1 Funding has been devolved to Area Committees for local projects meeting the Community Development, Sports and Arts strategic priorities since 2004. This process is managed by the Grants Team in Community Services who promote the funding and bring applications for consideration to one meeting of each of the area committees annually.
- 3.2 The 2022-23 grants were publicised via neighbourhood workers, voluntary organisations, in local publications and by posters and publicity leaflets. Recent applicants were also invited to apply. Officers held a webinar briefing to explain the application process and eligibility criteria and priorities.
- There is a total of £70,000 available across the four area committees for 2022-23 as detailed in the Community Grants report to Environment and Community Scrutiny Committee 27th January 2022. The approved population and poverty formula calculation is set out in Appendix 2. The amount available for each area is as follows:

3.4 Area Committee Community Grant Priorities and Outcomes

Projects and activities should have a targeted approach and make a difference to people in one of the areas (North, East, South or West Central) by reducing social or economic inequality via one of the following funding priorities:

- sporting activities
- arts and cultural activities
- community development activities
- reducing poverty activities

- legal and/or financial advice (the Advice Quality Standard (AQS) or equivalent required)
- employment support
- capacity building of the voluntary sector to achieve the above
- 3.5 Applications are invited from voluntary organisations, community groups and groupings of local residents that are able to meet basic accountability requirements.
- 3.6 The maximum any one organisation can apply for is £5,000 per area committee and grants cannot be made retrospectively. Full details of the eligibility criteria are available on request.
- 3.7 Where no funding is proposed it will be due to one or more of the following not being adequately met:
 - grant scheme outcomes and/or priorities
 - identifying need
 - quality or viability of the project or
 - proposals were the remit of another service/fund or organisation
 - organisations did not demonstrate the beneficiaries could not fund the activity themselves, or that reserves could not be used to fund the activity

3.8 Platinum Jubilee

Alongside the area committee grants, local groups have been invited to apply for grants up to £500 for events to celebrate the Platinum Jubilee via a simple application form. 39 Platinum Jubilee applications have been received, of which 5 are from the West Central area with a total award value of £2,365, detailed in Appendix 3. All of these applications have been recommended an award for the full amount requested.

- 3.9 **All awards** are subject to grant agreements and monitoring reports. We consider proportionate requirements dependent on the size of the organisation, project and award.
- 3.10 If the current recommendations for the West Central Area Committee and Platinum Jubilee grant awards are approved following consideration by this committee, the budget allocation for the West Central area will be increased by £9 from service project budgets to support the jubilee activities.

- 3.11 Enquiries for grants made until October will be considered should any funding become available through the return of unspent grant awards. Officers will make decisions on awards up to £5,000 as approved by the Community Services Scrutiny Committee in January 2014.
- 3.12 In October 2022, any remaining community grant funding will be pooled to ensure its effective use on new enquiries for funding from the voluntary and community sector or projects to meet identified need.

1. Introduction


This report provides an overview of the council's Streets and Open Spaces, Environmental Health and Shared Waste service activity in the Area Committee area over the past six months.

This report provides open data on service performance, so that City and County Councillors and their constituents are informed of what service activity is happening in their area; and can engage in and help to shape this activity, including identifying specific local service requests/ issues.

- 1. Streets and Open Spaces Operations Team:
 - a. Street cleansing and Grounds Maintenance cleans all residential streets and public land and maintains all grass and shrub beds across the city.
 - b. Community Engagement Team works with Community Payback and Streets and Open Spaces volunteers to deliver community nominated improvement projects.
 - c. Enforcement Team investigate and take action against instances of environmental crime and dog control issues in public places across the city.
- 2. Streets and Open Spaces Assets Development Team:
- 3. Streets and Open Spaces Projects Team
 - a. Projects
 - b. Parks
 - c. Trees
- 4. The Greater Cambridge Shared Waste Service provide rubbish and recycling collections from homes and business Cambridge and South Cambridgeshire and empties 32,000 bins each day. It is responsible for setting policy on how this should be done and educating residents and customers on how best to recycle.
- 5. Environmental Health:
 - a. Pest control free treatments for rats, mice, cockroaches, bedbugs and pharaohs ants
 - b. Private sector Housing interventions complaints and investigations regarding condition of properties
 - c. Other public health interventions refuse, hoarding, bonfires
 - d. Noise complaints day time and night time noise complaints,



Community Engagement team

The team carried out essential maintenance works at Ascension Burial Ground, strimming and raking plots 3 and 5 not only to ensure the cemetery is kept neat but also that the soil is not too fertile. 

The Operations teams have been busy during the last few months continuing to carry out scheduled mechanical sweeping all bus routes, main roads and housing footways and carriageways.


The hot spot map shows the numbers and locations of the flytips cleared within the last six-month period.

Community Engagement team

Two corporate volunteer events were held on Parkers Piece with volunteers from Aveva and Johnson Matthey. Various tree works, including weeding the oak tree halo, and the lime trees had saplings removed.





Over 15 volunteers came and helped clear the front and rear gardens of All Saints Church on Jesus Lane. The church is managed by the Churches Conservation Trust who requested that the garden be cleared to encourage more visitors to this fantastic building. Since we started the project, All Saints have seen an increase in visitor numbers at the weekends. Our volunteers were kindly given access to the church and received a guided tour which they found very informative. Our volunteers will return later in the year to assist with planting.

Enforcement team

During the period between August 2021 to January 2022 officers continued to undertake proactive litter patrols within the city, whereby fixed penalty notices were issued for littering.

One abandoned vehicle was investigated at Coronation Mews. Following apply a notice to the vehicle it was subsequently claimed and moved by the registered keeper.


There were five breaches of section 47 notices relating to business for mismanagement of the trade waste, fixed penalty notices were issued to all businesses and paid in full.

Lion Yard, New Square, Park Terrace, Regent Street, St Andrews Street, Fitzroy street and Burleigh street have had officers foot patrolling the locations and this has culminated in fixed penalty notices being issued for littering of cigarettes. There has been numerous littering offence investigated in relation to litter thrown from motor vehicles within the ward. Several suspects have been identified and fixed penalty notices issued and paid.

Domestic household waste has been found littered at numerous locations within the ward, these have been investigated. Fixed penalty notices have been issued to suspects of domestic waste littering and additional suspects were issued fixed penalty notices for fly tipping or littering domestic waste, and/or breach of household duty of care.

The Operations teams have been busy during the last few months continuing to carry out scheduled mechanical sweeping all bus routes, main roads and housing footways and carriageways.


Our Grounds Maintenance have been out hoeing, pruning, and leafing our city centre parks, sheltered housing, church yards. Which is continual general maintenance and preparation work. The cleansing team are daily keeping the City centre clean. The streets are regularly swept by mechanical sweepers or by hand. The market square is washed twice a week and swept daily.

The Rapid Response/Graffiti Team continue to wash down pavements within the City and outside seating areas. They also wash down after the mess left by night life. There has been an increase in

graffiti and fly posting and stickers.




The hot spot map shows the numbers and locations of the flytips cleared within the last six-month period.

Enforcement team

During the period between August 2021 and January 2022 officers continued to undertake proactive and reactive patrols on the open spaces' patrols. This includes illegal campers, and littering patrols.

Fly tipping issues at Lammas Land recycling centre which was previously a hot spot have eased since the recycling bins were removed.

Abandoned vehicles have been dealt accordingly with throughout the ward, with one vehicle at Kings Road removed. Abandoned vehicles were also reported at Clarkson Road, Herschel Road and Clerk Maxwell Road but were either claimed by the owners or not on site at the time of inspection.

Officers continue to monitor businesses that had previously had issues with the management of their trade waste. Commercial fly tips have been investigating within the ward and suspect businesses have been issued fixed penalty notices for the offences.



There have also been domestic waste fly tips investigated and cleared, suspects have been issued fixed penalty notices for the offences and all paid.



Hot spot maps within each of the ward profiles shows the numbers and locations of the flytips within the last six-month period.

Needles:

- Castle: In September there was one instance where two needles were removed from Histon Road.
- Market:
 - At Auckland Road, there were one incident in September where five needles were removed from Midsummer Orchard.
 - o At Burleigh Street in December twenty needles were removed.
 - o At Granted Place in November a carrier bag of twenty-five needles was removed.
 - o At James Street 47 needles were removed in August.
 - o Twelve needles were cleared from a bin on Tredgold Lane in August
 - o In Wellington Street repeat incidents occurred in September (three instances and a total of eight needles cleared), October (seventeen needles cleared) and January (three needles cleared).
 - In September at Corn Exchange Street one needle was removed, at Bridge Street one needle was removed in August, two needles
 were cleared from Holy Trinity Church Yard in September, and one in September. One needle was cleared from Paradise Street in
