Licensing Act 2003 - Licensing Sub-Committee: Hearings Procedure

Preliminary Matters

- 1. **The Chair** will commence the hearing by introducing him/herself, the other two members of the Sub-Committee and the officers present.
- 2. **The Chair** will ask the applicant(s)/the responsible authorities/the interested parties present, and their representatives (if applicable), to introduce themselves and identify their interest in the proceedings.

Failure of a party to attend the hearing

- 3. If a party has informed the licensing authority that he/she does not intend to attend or be represented at a hearing, the hearing may proceed in his/her absence.
- 4. If a party who has not so indicated fails to attend or be represented at a hearing, the Sub-Committee may
 - (a) where it considers it to be necessary in the public interest, adjourn the hearing to a specified date, or
 - (b) hold the hearing in the party's absence.
- 5. Where the Sub-Committee holds the hearing in the absence of a party, the Sub-Committee will consider at the hearing the application, representations or notice made by that party.
- 6. **The Chair** will explain the procedure to be followed at the hearing and will confirm whether the Sub-Committee must reach its decision at the end of the hearing or within 5 workings days of the hearing, depending on the application being heard.
- 7. The Clerk to the Sub-Committee will indicate whether any party has requested permission for any other person(s) (other than his/her representative) to appear at the hearing to assist the Sub-Committee in relation to the application, representations or notice of the party making the request. The Sub-Committee will decide whether to grant permission to allow any other person(s) to appear at the hearing on behalf of the party; such permission will not be unreasonably withheld.
- 8. The Clerk to the Sub-Committee will ask whether any party is seeking to introduce any document(s) or other information not previously disclosed to all the other parties to the hearing and the licensing authority. If all the other parties consent, the previously undisclosed document(s) or other information can be produced by a party in support of their application, representations or notice (as applicable).
- 9. The hearing will take the form of a discussion led by the Chair of the Sub-Committee. Cross-examination will not be permitted unless the Sub-Committee considers that cross-examination is required to

- consider the representations, application or notice as the case may require.
- 10. The Sub-Committee will consider any requests to permit crossexamination on a case-by-case basis. When permission is given to one party, it will also normally be extended to all other parties.
- **11.**The Sub-Committee will decide the equal maximum period of time that each party will have to present their case.

The Hearing

- 12. The Licensing Officer will present the report to the Sub-Committee.
- 13. Members may ask any relevant questions of the Licensing Officer.
- 14. The applicant, or the party who has initiated the hearing, will present their case first.
- 15. The party shall be entitled to:
 - (a) give further information in support of their application, representations or notice (as applicable) in response to a specific request by the licensing authority prior to the hearing;
 - (b) question any other party (if permission has been given by the Sub-Committee);
 - (c) address the Sub-Committee.
- 16.If the Police are a party to the hearing, they will present their case. The Police have the rights listed in paragraph 15 (a) (c) above.
- 17.If any other "responsible authority" are a party to the hearing, they will present their case in turn after the Police and have the rights listed in paragraph 15 (a) (c) above.
- 18. Any other interested parties will then present their case in turn and have the rights listed in paragraph 15 (a) (c) above.
- 19. Members of the Sub-Committee may ask questions of the /each party or any other person permitted to appear at the hearing in support of the party.
- 20.**The Chair** will invite the applicant, or the party who has initiated the hearing, and any parties making representations, to briefly summarise their points if they wish.
- 21. **The Chair** will ask the applicant, or the party who has initiated the hearing, and all parties making representations, that they are satisfied that they have said all they wish to.

The Decision

22.In considering any representations or notice made by a party, the Sub-Committee may take into account documentary or other information produced by a party in support of their application, representations or notice (as applicable) either before the hearing or, with the consent of all the other parties, at the hearing.

- 23.In reaching its decision, the Sub-Committee will disregard any information given by a party, or any person who has been permitted to appear at the hearing, which is not relevant to
 - (a) the application, representations or notice (as applicable) or in the case of another person, the application, representations or notice of the party requesting their appearance, and
 - (b) the promotion of the licensing objectives or, in relation to a hearing to consider a notice given by the Police, the crime prevention objective.
- 24. The Sub-Committee may consider its decision in private and may move into private session where it considers that the public interest in so doing outweighs the public interest in that part of the hearing taking place in public. If the Sub-Committee do move into private session then all the parties and their representatives, any other person permitted to appear at the hearing, officers, the public and the press will be asked to leave the room whilst the decision is made.

The Chair will tell those present at the meeting the decision taken by the Sub-Committee and the reasons for the decision.

INTRODUCTION

1.1 An application under section 34 of the Licensing Act 2003 to vary the Premises Licence issued in the respect of Boom Battle Bar, 36 & 36a St Andrews Street, Cambridge, CB2 3AR has been received from BBB UK Property Ltd. The application was served on Cambridge City Council (the Licensing Authority) on 2 June 2025. A copy of the application was also served on each responsible authority. The application and plans are attached to the report as Appendix 1 and Appendix 1a, 1b, 1c and 1d, respectively. Current Premises Licence is attached to the report as Appendix 2.

- 1.2 The applicant is seeking to extend the hours of licensable activities on Thursday, Friday and Saturday as follows:
 - Exhibit films 10:00 to 02:30
 - Recorded Music 10:00 to 03:00
 - Indoor sporting events 10 to 03:00
 - Late Night refreshment 23:00 to 03:00
 - Supply of alcohol 10:00 to 02:30

Opening hours – 08:00 to 03:00

- 1.3 The applicant is also seeking to add licensable activity of 'Indoor sporting Events'
 - Sunday to Wednesday: 10:00 to 00:30
 - Thursday to Saturday: 10:00 to 03:00
- 1.4 Furthermore, the applicant is applying to amend/remove the following conditions;
 - 1. Removal of Condition 16: which states: "No person will be allowed to play the axe throwing or similar games if they have consumed alcohol or illegal drugs/substances prior to playing the game, and no person playing these games will be allowed to consume alcohol or take illegal drugs/substances whilst playing these games. Where staff or door staff are unsure if the person is under the influence of alcohol, then that person will be breathalysed, using a calibrated breathalyser."
 - 2. Modification of condition 24 that currently requires "A minimum of two SIA registered door supervisors will be employed at the premises each day from 21.00hrs until close of business. On Fridays and Saturdays, all Sundays preceding a Bank Holiday, New Years' Eve, and Boxing night a further two SIA registered door supervisors will be employed from 21:00hrs until all customers have safely dispersed from the vicinity of the premises."

Amend to: "On Thursday, Fridays and Saturdays, all Sundays preceding a Bank Holiday, New Years' Eve and Boxing night a minimum of 4 SIA registered door supervisors will be employed from 21:00hrs until all customers have safely dispersed from the vicinity of the premises. At all times the Premises Licence Holder shall risk assess the requirement to employ additional door

supervisors in such numbers and at such times as deemed necessary. This risk assessment will take into consideration information and advice provided by the local Police. A copy of this risk assessment will be made available to the Police and Licensing Authority on request."

3. Amendment to Condition 18 that currently states: "Should beer pong be played in these premises then polycarbonate drinking vessels must be used, and non-alcohol drinks will only be used for the game. For clarification no alcohol will be used for this game."

Amend to: remove the prohibition on alcohol use in this activity, while maintaining the requirement for polycarbonate or metal drinking vessels.

4. Amendment to Condition 43: which currently states "After 21:00 hours persons under the age of 18 years of age will not be allowed on the premises"

Amend to: "After 21:00 hours persons under the age of 18 years of age will not be allowed in the part of the premises occupied and trading as Boom Battle Bar. After 21:00 hours persons under the age of 18 years of age will be allowed in the part of the premises occupied and trading as Escape Hunt (shown edged in blue the plan attached to the application) but only if supervised by a responsible adult."

- 1.5 The applicant has provided measures within the application form on how they intend to promote the four licensing objectives, with requested changes.
- 1.6 In accordance with the regulations of the Act, the application was advertised on the premises and in Cambridge Independent on 11 June 2025 to invite representations from responsible authorities and other persons. The last date for submitting representations was 30 June 2025.
- 1.7 Representations were received from 1 'Other Persons'. The representations are attached to the report at Appendix 3.

- 1.8 No representations were received from the Responsible Authorities. However, conditions were agreed with Cambridgeshire Constabulary detailed within Appendix 4.
- 1.9 The applicant attended a meeting with Cambridgeshire Constabulary and Environmental Health during the representation period and it was noted that opening times did not match up with activities. This was an error and applicant did redo the form for the ease of responsible authorities reading. This is attached within the report as Appendix 1a.
- 1.10 The application needs to be determined.

2. RECOMMENDATION

2.1 That Members determine the application on its individual merits having reference to the statutory licensing objectives and Cambridge City Council's Statement of Licensing Policy and the Cumulative Impact Assessment.

3. BACKGROUND

- 3.1 The proposed premises is located within a Cumulative Impact Area (CIA) and is therefore subject to the Cumulative Impact Assessment.
- 3.2 The onus is on the applicant to demonstrate why the requested variations to license would not add to the cumulative impact already being experienced within the area.
- 3.3 The premises license was granted on 3rd January 2024, and was previously All Bar One, restaurant and bar.
- 3.4 In carrying out its licensing functions, the Licensing Authority must have regard to its Statement of Licensing Policy, the Cumulative Impact Assessment and additionally the statutory guidance issued under Section 182 of the Licensing Act 2003. The relevant sections from the Council's Statement of Licensing Policy are:
 - Objectives, section 2
 - Fundamental principles, section 4
 - Cumulative Impact, section 5

- Licensing Hours, section 6
- Licence Conditions, section 8

4. CONSULTATIONS

- 4.1 The Licensing Act 2003 requires applications made under section 34 of the Act to be served on the Responsible Authorities and also advertised on the premises and in a local newspaper circulating within the vicinity of the premises. During the consultation period, Responsible Authorities and Other Persons (any individual, body or business entitled to make representations to licensing authorities) may make a representation in respect of the application.
- 4.2 Statutory consultation has therefore taken place with Responsible Authorities and interested parties in accordance with the procedures set out in the Licensing Act 2003 and associated regulations made under the Act.

5. OPTIONS

- 5.1 Whilst having reference to the information provided by the applicant, the information raised in the representations and also Cambridge City Council's Statement of Licensing Policy and Cumulative Impact Assessment, the Sub-Committee's decision must be made with a view to promoting one or more of the four licensing objectives, namely:
 - (a) the prevention of crime and disorder;
 - (b) public safety;
 - (c) the prevention of public nuisance; and
 - (d) the protection of children from harm.
- 5.2 Members should take such steps that they consider are necessary for the promotion of the licensing objectives. The Sub-Committee may resolve:
 - (a) to grant the variation as applied for;
 - (b) to modify the conditions of the licence
 - (c) to reject the whole or part of the application.
- 5.3 Members must give reasons for their decision.

6. CONCLUSIONS

6.1 The Licensing Authority has a duty under the Licensing Act 2003 to promote the Licensing Objectives. Each objective has equal importance. In carrying out its licensing functions, the Licensing Authority must also have regard to its Statement of Licensing Policy, the Cumulative Impact Assessment and the Statutory Guidance under the Licensing Act 2003, and it is bound by the Human Rights Act 1998. The Council must also fulfill its obligations under Section 17 of the Crime and Disorder Act 1998 to do all that it reasonably can to prevent crime and disorder in Cambridge.

7. IMPLICATIONS

(a) Financial Implications

Cambridge City Council (the Licensing Authority) has a statutory duty to determine applications made under the Licensing Act 2003. The application fees associated with such applications are set by Central Government and are intended to cover the cost of administering the licensing regime.

There are no specific financial implications associated with this report.

(b) Staffing Implications

There are no staffing implications associated with this report.

(c) Equal Opportunities Implications

No Equality Impact Assessment has been conducted as the only consideration in reaching a decision is whether the granting of the application will undermine the statutory licensing objectives.

(d) Environmental Implications

Any environmental implications that need to be considered must specifically relate to the promotion of the statutory licensing objectives and will be contained in the representations made by the responsible authorities or interested parties.

(e) Community Safety

Cambridge Constabulary, Cambridgeshire Fire & Rescue Service, Cambridge City Council's Environmental Health Team, Cambridge City Council's Planning Service, Cambridgeshire County Council's Child Protection & Review Unit, Cambridgeshire County Council's Trading Standards Department and the Public Health Director were consulted as part of the application process and could have made representation if it was considered that the granting of the application would undermine one or more of the statutory licensing objectives.

Those making representations would have raised any relevant community safety implications.

operate a number of other Boom venues across the country where we do not have any conditions around the axe throwing games; we have comprehensive operating procedures and policies in place, where staff training, customer safety and engagement are key. Our trained staff continuously assess customers' ability to safely participate in activities regardless of alcohol consumption. Our comprehensive safety protocols include: a.t Rigorous staff training specifically focused on customer assessment and safety b.tStrict operational policies where every axe throwing session is supervised by trained staff members at all times c.tContinuous assessment of customers' behaviour and coordination throughout their visit d.tClear authority for staff to refuse participation based on observable behaviour regardless of alcohol consumption e.tSecure storage and controlled distribution of axes only by trained staff. f.tSignificantly lower alcohol-related incidents at our venues compared to traditional vertical drinking establishments Our riskbased approach focuses on observable behaviour and coordination, we believe this assessment would be more effective than blanket prohibition, as it focuses on the actual capability of participants rather than assuming any alcohol consumption creates risk. Our robust safety systems effectively mitigate any potential risks, allowing a more enjoyable experience for our customers while maintaining good safety records. 4)tModification of SIA Security Requirements: We propose to modify the condition 24 that currently requires "A minimum of two SIA registered door supervisors will be employed at the premises each day from 21.00hrs until close of business. On Fridays and Saturdays, all Sundays preceding a Bank Holiday, New Years' Eve, and Boxing night a further two SIA registered door supervisors will be employed from 21:00hrs until all customers have safely dispersed from the vicinity of the premises." Specifically, we seek to remove the need for security Sunday through Wednesday, as our risk assessments and operational experience have demonstrated that these days have significantly lower customer volumes and present minimal risk profiles that do not warrant dedicated SIA presence. This tailored approach to security staffing better aligns with the actual needs of the venue and customer patterns, supporting more efficient operations while maintaining appropriate security levels. We will continue to employ comprehensive risk assessment procedures and can deploy security personnel if specific events or circumstances warrant additional measures, ensuring the licensing objectives continue to be promoted through realistic and proportionate measures. 5)tAmendment to Condition 18: We propose to modify Condition 18 which currently states: "Should beer pong be played in these premises then polycarbonate drinking vessels must be used, and non-alcohol drinks will only be used for the game. For clarification no alcohol will be used for this game." We seek to remove the prohibition on alcohol use in this activity and use metal drinking vessels for

| | safety. This amendment would align with customers' expectations of the beer pong experience as it is traditionally played with alcohol and with our operations at other venues, where we have successfully managed this activity with alcohol while maintaining appropriate safety standards through the use of suitable drinking vessels and proper supervision. 6)tAmendment to Condition 43: We propose to vary condition 43 which currently states "After 21:00 hours persons under the age of 18 years of age will not be allowed on the premises" to "After 21:00 hours persons under the age of 18 years of age will not be allowed in the part of the premises occupied and trading as Escape Hunt (shown edged in blue the plan attached to the application) without a responsible adult." This variation recognises that our premises operates two distinct business models - Boom Battle Bar and Escape Hunt - with different risk profiles and customer demographics. The Escape Hunt area provides family-friendly escape room experiences that benefit from extended family operating hours, while maintaining appropriate safeguards through responsible adult supervision. This variation supports the protection of children from harm objective by ensuring proper supervision while allowing families to enjoy escape room experiences during extended evening hours. The amendment maintains safety standards while providing more flexibility for legitimate family entertainment activities. |



The proposed variations are as follows:

 Addition of Indoor Sporting Events: We seek to add "Indoor Sporting Events" as a licensable activity at the premises with the following timings:

Sunday to Wednesday: 10:00 to 00:30 Thursday to Saturday: 10:00 to 03:00

Note: Recorded music timings for Sunday to Wednesday to be brought in line with opening hours as discussed. That is, Sunday to Wednesday: 10:00 to 00:30

 Extended Hours: We seek to extend our closing time on Thursday, Friday, and Saturday from 01:30am to 03:00am, with corresponding adjustments to licensable activities as follows:-

Opening hours – 08:00 to 03:00

Exhibit films - 10:00 to 02:30

Recorded Music - 10:00 to 03:00

Indoor sporting events - 10 to 03:00

Late Night refreshment - 23:00 to 03:00

Supply of alcohol - 10:00 to 02:30

This extension will allow us to meet customer demand during peak trading periods and align our operating hours with our other venues in the UK, providing a more consistent customer service. The staggered timing allows for gradual wind-down of activities before closing, supporting the prevention of public nuisance objective by ensuring an orderly dispersal of customers.

- 3) Removal of Condition 16: We propose to remove the condition which states: "No person will be allowed to play the axe throwing or similar games if they have consumed alcohol or illegal drugs/substances prior to playing the game, and no person playing these games will be allowed to consume alcohol or take illegal drugs/substances whilst playing these games. Where staff or door staff are unsure if the person is under the influence of alcohol, then that person will be breathalysed, using a calibrated breathalyser." We operate a number of other Boom venues across the country where we do not have any conditions around the axe throwing games; we have comprehensive operating procedures and policies in place, where staff training, customer safety and engagement are key. Our trained staff continuously assess customers' ability to safely participate in activities regardless of alcohol consumption. Our comprehensive safety protocols include:
 - a. Rigorous staff training specifically focused on customer assessment and safety
 - b. Strict operational policies where every axe throwing session is supervised by trained staff members at all times

- c. Continuous assessment of customers' behaviour and coordination throughout their visit
- Clear authority for staff to refuse participation based on observable behaviour regardless of alcohol consumption
- e. Secure storage and controlled distribution of axes only by trained staff.
- f. Significantly lower alcohol-related incidents at our venues compared to traditional vertical drinking establishments

Our risk-based approach focuses on observable behaviour and coordination, we believe this assessment would be more effective than blanket prohibition, as it focuses on the actual capability of participants rather than assuming any alcohol consumption creates risk. Our robust safety systems effectively mitigate any potential risks, allowing a more enjoyable experience for our customers while maintaining good safety records.

- 4) Modification of SIA Security Requirements: We propose to modify the condition 24 that currently requires "A minimum of two SIA registered door supervisors will be employed at the premises each day from 21.00hrs until close of business. On Fridays and Saturdays, all Sundays preceding a Bank Holiday, New Years' Eve, and Boxing night a further two SIA registered door supervisors will be employed from 21:00hrs until all customers have safely dispersed from the vicinity of the premises." We seek to replace this with "On Thursday, Fridays and Saturdays, all Sundays preceding a Bank Holiday, New Years' Eve and Boxing night a minimum of 4 SIA registered door supervisors will be employed from 21:00hrs until all customers have safely dispersed from the vicinity of the premises. At all times the Premises Licence Holder shall risk assess the requirement to employ additional door supervisors in such numbers and at such times as deemed necessary. This risk assessment will take into consideration information and advice provided by the local Police. A copy of this risk assessment will be made available to the Police and Licensing Authority on request." Our risk assessments and operational experience have demonstrated that these days have significantly lower customer volumes and present minimal risk profiles that do not warrant dedicated SIA presence. This tailored approach to security staffing better aligns with the actual needs of the venue and customer patterns, supporting more efficient operations while maintaining appropriate security levels. We will continue to employ comprehensive risk assessment procedures and can deploy security personnel if specific events or circumstances warrant additional measures, ensuring the licensing objectives continue to be promoted through realistic and proportionate measures.
- 5) Amendment to Condition 18: We propose to modify Condition 18 which currently states: "Should beer pong be played in these premises then polycarbonate drinking vessels must be used, and non-alcohol drinks will only be used for the game. For clarification no alcohol will be used for this game." We seek to remove the prohibition on alcohol use in this activity and use metal drinking vessels for safety. This amendment would align with customers' expectations of the beer pong experience as it is traditionally played with alcohol and with our operations at other venues, where we have successfully managed this activity with alcohol while maintaining appropriate safety standards through the use of suitable drinking vessels and proper supervision.
- 6) Amendment to Condition 43: We propose to vary condition 43 which currently states "After 21:00 hours persons under the age of 18 years of age will not be allowed on the premises" to "After 21:00 hours persons under the age of 18 years of age will not be allowed in the part of the premises occupied and trading as Boom Battle Bar. After 21:00 hours persons under the age of 18 years of age will be allowed in the part of the premises occupied and trading as Escape Hunt (shown edged in blue the plan attached to the application) but only if supervised by a responsible adult." This variation

recognises that our premises operates two distinct business models - Boom Battle Bar and Escape Hunt - with different risk profiles and customer demographics. The Escape Hunt area provides family-friendly escape room experiences that benefit from extended family operating hours, while maintaining appropriate safeguards through responsible adult supervision. This variation supports the protection of children from harm objective by ensuring proper supervision while allowing families to enjoy escape room experiences during extended evening hours. The amendment maintains safety standards while providing more flexibility for legitimate family entertainment activities.

a) General - all four licensing objectives (b, c, d and e) (please read guidance note 9)

- Our management team will hold regular documented meetings with staff to review compliance with licensing objectives.
- We will maintain active engagement with local licensing authorities, Security Team, Police and Council to uphold all four licensing objectives.
- All staff receive comprehensive training on our operating procedures, with regular refresher training that is documented and available for inspection.
- A designated member of management will be responsible for ensuring compliance with all licensing conditions and objectives.

b) The prevention of crime and disorder

- With regard to the variation in security requirement our approach will be based on comprehensive documented risk assessments that consider factors such as expected customer numbers, type of event, day of week, and seasonal variations. This allows security provision to be better aligned to actual needs and risk levels.
- For the removal of Condition 16 relating to axe throwing and alcohol we have implemented robust operational policies including:
 - Continuous supervision by trained staff members
 - Regular assessment of participants' behaviour and coordination
 - Clear authority for staff to refuse participation based on observable behaviour
 - Active incident reporting system to capture and learn from any safety concerns
- We maintain a detailed incident log recording all refusals, incidents, and actions taken, which
 is available for inspection by authorities.
- CCTV system covering all activity areas will be maintained in good working order, with recordings kept for a minimum of 31 days and made available to authorities upon request.
- We implement a strict Challenge 25 policy for age verification with all relevant training and signage.
- Regarding the amendment to Condition 43 (Escape Hunt area), we will maintain clear
 protocols for managing mixed-age groups and ensuring responsible adult supervision is
 maintained throughout visits.

c) Public safety

- We conduct and regularly review comprehensive risk assessments for all activities, focusing on participant and spectator safety.
- All gaming equipment is regularly checked and maintained.
- Staff are trained in emergency procedures including evacuation, first aid response, and managing customer incidents.
- With regard to the extension of hours to 03:00, we will implement a staggered departure system with alcohol service ending at 02:30, ensuring a gradual wind-down of activities before closing.
- For beer pong with alcohol, we will strictly maintain the use of polycarbonate or metal vessels
 to eliminate breakage risks, with staff trained to monitor the activity and intervene if necessary.
- For the Escape Hunt area operating with under-18s after 21:00, we will ensure responsible adults maintain direct supervision and that escape room activities are appropriate for mixed-age groups.

d) The prevention of public nuisance

- We have implemented a dispersal policy that minimises noise and disturbance when customers leave, particularly during extended hours.
- Staff are trained to monitor noise levels and manage customer behaviour that may cause disturbance.
- Prominent signage at exits reminds customers to leave quietly and respect neighbouring properties.
- For activities with alcohol, including axe throwing and beer pong, staff monitoring will ensure
 activities remain controlled and do not create excessive noise or disruptive behaviour.
- We maintain good relationships with neighbouring businesses and residents, providing contact details for addressing any concerns
- The Escape Hunt area activities are inherently low-noise and contained within purpose-built rooms, minimising any potential noise impact from extended family visits.

e) The protection of children from harm

- Our proposed variations will not adversely affect our commitment to protecting children from harm, as we will maintain all existing safeguards and enhance them where appropriate.
- Our extended hours (to 03:00 on Thursday-Saturday) will not impact child protection as our policy prohibiting children under 18 after 9pm remains unchanged
- Regarding the removal of Condition 16 (axe throwing and alcohol) and amendment to condition 18(beer pong with alcohol), our staff will continue to enforce strict age verification and maintain physical separation between underage customers and axe throwing/beer pong activities where alcohol is being consumed nearby.
- The modification to SIA security requirements will not impact child protection as security will
 remain in place during busier periods when families with children are more likely to be present,
 and staff will maintain vigilance during all operating hours.
- The amendment to Condition 43 specifically enhances child protection by requiring responsible adult supervision for under-18s in the Escape Hunt area after 21:00, rather than a blanket prohibition. This ensures appropriate oversight while allowing legitimate family entertainment activities.
- All staff will continue to receive comprehensive training on age verification procedures and the Challenge 25 policy, with particular emphasis on managing mixed-age environments in the Escape Hunt area
- We will maintain our refusals log for age-restricted products and services, available for inspection by authorities.
- Enhanced staff monitoring during all activities where alcohol is served will ensure any risks to children are identified and addressed immediately.

Annex 1 - Mandatory conditions

- No supply of alcohol may be made under the premises licence -
- (a) at a time when there is no designated premises supervisor in respect of the premises, or
- (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
- (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
- (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises—
- (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to—
- (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
- (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective:
- (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.
- (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).
- The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
- (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
- (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—
- (a) a holographic mark, or
- (b) an ultraviolet feature.
- The responsible person must ensure that—
- (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—
- (i) beer or cider: ½ pint;
- (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
- (iii) still wine in a glass: 125 ml;
- (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available."
- A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- For the purposes of the condition set out in paragraph 7—

- (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979:
- (b) "permitted price" is the price found by applying the formula—

 $P = D + (D \times V)$

Where -

- (i) P is the permitted price,
- (ii) D is the rate of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence—
- (i) the holder of the premises licence,
- (ii) the designated premises supervisor (if any) in respect of such a licence, or
- (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence:
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "valued added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
- 9. Where the permitted price given by Paragraph (b) of paragraph 8 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 10. (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 8 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
- (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.
- 11. The admission of children under the age of 18 to film exhibitions permitted under the terms of this licence shall be restricted in accordance with any recommendations made a. By the British Board of Film Classification (BBFC) where the film has been classified by that Board, or
- b. By the Licensing Authority where no classification certificate has been granted by the BBFC, or, where the licensing authority has notified the licence holder that section 20 (3) (b) of the Licensing Act 2003 applies to the film.

Annex 2 - Conditions consistent with the operating schedule

No adult entertainment or services, activities, other entertainment or matters ancillary to the use of the premises that may give rise to concern in respect of children shall be permitted in the premises at any time.

General

-

- Persons under the age of 18 years old must always be accompanied by a responsible adult.
- A nominated personal licence holder will always be on duty during licensable hours.
- Substantial food offering will be available until one hour prior to closing time.
- Drinks purchased in our venue are to be consumed on our premises only.
- All staff will undertake responsible alcohol sales training prior to engaging in the sale of alcohol.
- Refresher training will be carried out at least once every 6 months. Fully auditable training records should be maintained for all staff in respect of the sale of alcohol. These will be made available for inspection upon request to the Police and all other Responsible Authorities.

- 7. All staff must complete welfare and vulnerability training. This is to include 'Ask for Angela' Scheme (as long as it is still in operation). The training is to be carried out at least once every 12 months and written records of the training must be kept for inspection by Cambridgeshire Police or an authorised officer of a responsible authority.
- A written delegation of authority record will be kept at the premises whereby non personal licence holders are authorised to make sales on behalf of a personal licence holder.
- 9. Any person participating in the axe throwing (or similar game) or beer pong must be over 18 years of age, and photographic identification in the form of a passport, driving licence or proof of age scheme (PASS) approved identification before ID must be checked for every participant before they play these games.
- The licensee will risk assessment to need for using non glass drinking vessels and bottles.
- 11. The person nominated as the designated premises supervisor will join and actively support the Cambridge Pubwatch/CAMBAC, whilst it is in existence and support its aims and objectives. This includes support of its agreed banning policy and attending meetings, personally or by sending an authorised representative of the venue.
- 12. The premises will subscribe to the CAMBAC radio system, which will be monitored and used during licensed hours by managers and SIA door supervisors. This will be binding as long as the scheme is operating.
- 13. An effective internal communication system for the use of staff on duty shall be employed.
- 14. A secure deposit box will be kept on the premises for the retention of confiscated items, such as drugs and knives etc. Police will be advised of the seizure of any such items to ensure safe disposal.
- 15. Prominent, clear and legible notices at all exits will be displayed requesting patrons departing to respect the needs of local residents and to leave the premises and the area quietly.
- 16. No person will be allowed to play the axe throwing or similar games if they have consumed alcohol or illegal drugs/substances prior to playing the game, and no person playing these games will be allowed to consume alcohol or take illegal drugs/substances whilst playing these games. Where staff or door staff are unsure if the person is under the influence of alcohol, then that person will be breathalysed, using a calibrated breathalyser.
- Any high risk activities will be hosted at all times and equipment locked away from customers when not in use.
- 18. Should beer pong be played in these premises then polycarbonate drinking vessels must be used, and non-alcohol drinks will only be used for the game. For clarification no alcohol will be used for this game.
- The primary use of the premises shall be that an activity-based bar experience. The
 premises shall not operate solely as a late-night drinking venue or similar.
- There shall be no off-sales of alcohol from 11pm until close of business daily, and all offsales of alcohol are to be in sealed containers.

The prevention of crime and disorder

- 21. The premises licence holder shall install and maintain a comprehensive CCTV system as per the minimum requirements of the Police. All entry and exit points will be covered, as will areas where licensable activities are happening, including the till points, axe throwing stalls, darts area, Karaoke rooms and games rooms enabling frontal identification of every person entering in any light condition. The CCTV system shall continually record whilst the premises is open for licensable activities and during all times when customers remain on the premises. All recordings shall be stored for a minimum period of 31 days with date and time stamping. Viewing of recordings shall be made available immediately upon the request of the police or an authorised officer throughout the preceding 31-day period. A staff member from the premises who is conversant with the operation of the CCTV system shall always be on the premises when the premises are open to the public. This staff member shall be able to show police recent data or footage with the absolute minimum of delay when requested and be able to download relevant footage onto a disc or memory stick.
- 22. BWV (Body Worn Video) cameras to be available, in working order and used by management staff and SIA Door Supervisors whilst licensable activities are taking place. All recordings shall be stored for a minimum period of 31 days with date and time stamping. Viewing of recordings shall be made available immediately upon the request of the police or

an authorised officer throughout the preceding 31-day period. A staff member from the premises who is conversant with the operation of the BWV cameras shall always be on the premises when the premises are open to the public. This staff member shall be able to show police recent data or footage with the absolute minimum of delay when requested and be able to download relevant footage onto a disc or memory stick.

- 23. A written or computerised log shall be kept at the premises for a minimum of 12 months from the date of each entry and made available on request to an authorised officer of Cambridge City Council or the Police. It must be completed within 24 hours of the incident and will record the following:
- (a) all crimes reported to the venue
- (b) all ejections of patrons
- (c) any complaints received concerning crime and disorder
- (d) any incidents of disorder
- (e) any faults in the CCTV system
- (f) any refusal of the sale of alcohol
- (g) any visit by a relevant authority or emergency service.
- 24. A minimum of two SIA registered door supervisors will be employed at the premises each day from 21.00hrs until close of business. On Fridays and Saturdays, all Sundays preceding a Bank Holiday, New Years' Eve and Boxing night a further two SIA registered door supervisors will be employed from 21:00hrs until all customers have safely dispersed from the vicinity of the premises. At all times the Premises Licence Holder shall risk assess the requirement to employ additional door supervisors in such numbers and at such times as deemed necessary. This risk assessment will take into consideration information and advice provided by the local Police. A copy of this risk assessment will be made available to the Police and Licensing Authority on request.
- 25. SIA security staff will prevent entry to anyone they deem drunk and/or disorderly.
- 26. Where SIA licensed door supervisors are used at the premises a record shall be maintained (on the premises) which is legible and details:
- a. The day and date when door supervisors were deployed.
- The name and SIA registration number of each door supervisor on duty at the premises,
 and
- c. The start and finish time of each door supervisor's worked duty period.

This record shall be retained on the premises for 30 days and held thereafter for a minimum of 12 months. All such records will be made available immediately upon reasonable request of authorised agents of a Responsible Authority.

- 27. At all times when SIA door supervisors are required to be on duty by virtue of a condition of this licence, SIA licensed door supervisors will supervise customers smoking outside, and any queue to enter the premises that forms outside the premises to ensure the footpath doesn't become obstructed. Upon closing time they will ensure the prompt, safe dispersal of customers from the immediate vicinity.
- 28. When door staff are not available at the premises then staff will monitor any customers smoking outside, and any queue to enter the premises that forms outside the premises. 29. An ID scanner will be installed at the premises and will be in operation when SIA security staff are manning the entrance door from 21:00 until close on Fridays, Saturdays and all Sundays preceding a Bank Holiday, New Years' Eve and Boxing night. At least 80% of customers who seek to enter the premises after that time will be requested to provide an appropriate form of identification and have that identification scanned into the system. Any customer who refuses (upon request) to allow their identification to be scanned into the system will be refused entry to the premises. The premises shall be permitted to allow entry to a maximum of 20% of customers who seen to enter the premises after that time without requesting their identification on a risk assessment basis considering the premises admissions policy.
- 30. The premises will have a written search policy, whereby when SIA security staff are on duty searches prior to entry of both customers and their belongings may be conducted to entry to ensure safety of all customers and staff. Any persons refusing to be searched shall not be permitted entry to the premises. Female customers will only be personally searched by a female member of door staff. A metal detecting wand will be used on all persons searched before entry to the premises. A notice will be prominently displayed advising customers that they may be searched as a condition of entry.

31. Prior to opening the Premises as Boom Battle Bar, the Premises Licence Holder shall draft a Dispersal Policy and liaise with Cambridgeshire Police licensing to agree its contents. The Policy will include a requirement for any SIA Door Supervisors engaged in the dispersal of patrons from the premises, to wear hi-viz jackets/vests while doing so.

Public safety

32. There shall be a policy agreed with Cambridgeshire Constabulary and approved by the Licensing Authority, relating to the seizure of illegal drugs, knives or other prohibited items found on persons or on the premises, which will be made available to Police or other Responsible Authorities on request.

The prevention of public nuisance

- Customers will not be allowed to enter or leave the premises with an open vessel of alcohol.
- 34. No customer will be allowed entry or re-entry to the premises after an hour before closing
- 35.Commencing 30 minutes prior to close of business daily, the Premises shall operate a winding-down period, in which the volume of music on the Premises shall be gradually reduced, until it is off at closing time.
- 36.All external doors and windows shall be kept shut after 23:00 on any days that the premises opens past this time, apart from the main entrance door/s (that allow general ingress and egress) which shall be kept closed so far as reasonably practicable.
- 37. The placing of waste including bottles into receptacles outside the premises and the emptying of premises waste receptacles by waste contractors shall only be permitted to take place between the hours of 07.00 and 23.00 to minimise disturbance to nearby properties.
- 38.Prominent, clear and legible notices will be displayed at all exits requesting the public to respect the needs of nearby residents and to leave the premises and the area quietly.
- 39. There will be sufficient first aid provision and appropriate supplies of first aid equipment available on the premises.
- 40.The premises licence holder shall ensure there are sufficient risk assessments in place for the activity of axe throwing. These will include details of:
- how axes will be stored securely when not in use,
- how the activity will be suitably supervised, and
- how customers who have consumed alcohol/drugs will not be able to access the activity.

The protection of children from harm


- 41. A "Challenge 25" Policy shall be implemented in full and appropriate identification sought from any person who appears to be under the age of 25. The only acceptable photographic driving licences, passports, HM forces cards, or a form of identification with the "PASS" hologram.
- 42. The premises licence holder shall ensure that notices shall be prominently displayed in the premises to advise patrons and staff that a 'Challenge 25' scheme operates in the premises.
- 43. After 21:00hrs persons under the age of 18 years old will not be allowed on the premises.


