**Incident 27 of 06/12/2006** relates to an assault at City Kebab Regent Street Cambridge at approximately 01:40 hours two males, one tall and skinny the other short and stockier have entered the Kebab Shop and asked for a lighter staff have told them that they did not have one and the males have then become abusive swearing at staff members and making comments about them being foreigners. They have also become abusive to !!!!!!! and !!!!!!, two students who were in the kebab shop at the time. \*\*\*\*\* ,who is Turkish and has only been working in the shop for two weeks ushers the males out of the shop. A short time later the smaller male has returned and picked up a bottle belonging to one of the girls and hit \*\*\*\*\* in the face with it before leaving the shop with the other male.

Police have been called by \*\*\*\*\* who also works at the shop and who also claims that when the male where in the shop the first time they have caused damage to a door within the shop.

Upon arrival ??????? and ?????? are spoken to and provide detailed description of the males involved. A short while later a taxi driver speaks to officers and tells them that he has dropped two male off in the Coleridge Road area who may have been involved in the assault at the kebab shop.

AG search the area and find ??????? & ??????? on the recreation ground on Davy Road both match the description given of the offenders and both have cuts and both are wearing clothing which appears to have blood stains??????and ??????? are arrested on suspicion of GBH.

In Custody ???????, the shorter of the two, has visible injuries, he states he recently broke his right hand but has not had any treatment for it there is a large lump on the back of his hand. He also has fresh cuts to this hand that were bleeding; he also has a cut to his head above the ear and blood on his coat and top.

Clothing has been seized from both ??????? and ??????? and swabs taken of the any visible cuts. These have been booked into crime property along with glass fragments of the bottle used at the scene.

The doctor has also been requested to document ??????? injuries which may also need photographing in the morning (as likely he is going to claim he was the victim of an assault inside the Kebab Shop)

A brief statement has been taken from \*\*\*\*\* , reference him witnessing the assault on \*\*\*\*\* and the criminal damage, he is also Turkish and there were some communication issues if a more detailed statement is needed then an interpreter may be required.

Statements have also been taken from !!!!!!! and !!!!!!! as well as a first account from \*\*\*\*\*

\*\*\*\*\* was taken to Addenbrookes and is aware that a statement will be needed from him in the morning he is available all day and lives at the kebab shop; he speaks good English and will not require an interpreter. Photos of his injuries will be needed when taking a statement he currently has cuts to face and head not sure how serious at this stage.

There is no CCTV inside the store but ??????? and ??????? may have been captured entering/exiting the shop on CCTV this will also need checking in the morning.

I have spoken to all witnesses and they are available if needed for any identification procedures tomorrow.
