

1. INTRODUCTION

Aim

The aim of the Neighbourhood profile update is to provide an overview of action taken since the last reporting period, identify ongoing and emerging crime and disorder issues, and provide recommendations for future priorities and activity in order to facilitate effective policing and partnership working in the area.

The document should be used to inform multi-agency neighbourhood panel meetings and neighbourhood policing teams, so that issues can be identified, effectively prioritised and partnership problem solving activity undertaken.

Methodology

This document was produced using the following data sources:

- Cambridgeshire Constabulary crime and anti-social behaviour (ASB) incident data for September to December 2012, compared to the previous reporting period (May to August 2012) and the same reporting period in 2011.
- City Council environmental services data for September to December 2012, compared to the same reporting period in 2011; and
- Information provided by the Safer Neighbourhood Policing Team, Cambridgeshire Fire & Rescue Service and the City Council's Safer Communities Section.

2. CURRENT PRIORITIES

At the North Area Committee meeting of 27 September 2012, the committee recommended adopting the following issues as priorities:

- Continuation of arson preventative work in East Chesterton;
- Anti-social cycling issues across the area; and
- Anti-social driving on Fen Road.

The Neighbourhood Action Group, at its meeting of 4 October, assigned the actions to be taken and the lead officers for each of the priorities. The tables below summarise the action taken and the current situation.

Continuation of arson preventative work in East Chesterton					
Objective	Continue with the arson prevention work in East Chesterton.				
Action Taken	There has been a significant reduction in deliberate fires in the area as a result of excellent partnership work. For the first time in the 10 years this data has been collected, there were no deliberate fires in Cambridge in December. There were two fires in the area, not linked to ASB.				
	The City Council's Safer Communities Section are continuing to work closely with the Fire Service, police, young people's agencies and housing associations with regards to fire setting in the area, particularly in the Nuffield Road / Bramley Court / Cams Causeway environs. With the support of the Fire Service and the young persons' parents, the Section has issued an Acceptable Behaviour Contract (ABC) to a young person in the area. The City Council's Children & Young People's Participation Service (ChYPPS) is also running a project in the East Chesterton area to engage with young people who may be linked to fire starting.				
Current Situation	Unfortunately on 10 January 2013 there was an escalation in serious arson in East Chesterton by an identified cohort of young males previously involved in ASB, which resulted in a fire endangering life and damage to property to the value of £6,000. Fire Setter Intervention, Restorative Justice and a Youth Engagement Scheme will start in February to address the issue. The work of the Safer Communities Section and ChYPPS will also continue.

Action	Colleagues from the Special Constabulary assisted in tackling							
Taken	this priority. Earlier in the period, and against the backdrop of							
	the Lights Instead of Tickets (LIT) campaign, they issued 40 Fixed Penalty Notices for offences of cycling without lights and cycling on the footpath. Local Police Community Support Officers also provided a visible deterrent presence in key risk areas.							
	A huge amount of effort has gone into this priority. Focus has generally been on areas where specific complaints have been received, but wherever it has been safe and appropriate to stop offending cyclists, this has been done. The LIT campaign has worked well. A lot of the work has come from the Special Constabulary, but North team officers have had an active role with 8 tickets being issued in one evening. The effort has also been applied on a citywide basis (where over 1000 tickets have been issued). The campaign has been well advertised in the local press and through the medium of ecops and hopefully the culture of anti-social and dangerous cycling has begun to change.							
Current	As the daylight hours remain short, cycling without lights is still							
Situation	an issue. Clearly cycling behaviour is a "cultural issue" unlikely							
	to change overnight, so further work in this area is recommended.

Objective	Target anti-social driving on Fen Road					
Action	Police Automatic Number Plate Recognition (ANPR) units have					
Taken	been used in several days of action around East Chesterton. North team officers spent dedicated days on Fen Road itself and 6 Fixed Penalty Notices were issued for various driving offences (e.g. driving whilst using a mobile phone and no seatbelt). Regular hi-visibility patrols from the North team have clearly had a deterrent effect on anti-social driving.					
	In the post-Christmas period, Operation Bind resources were deployed to Fen Road for 5 days. Section 59 warnings proved effective before; perhaps the fact only two have been issued during this period indicates a decline in the most brazen examples of bad driving.					

Current Situation	The high visibility police presence and positive action has clearly had an impact on anti-social driving. Word spreads very quickly when the police are about, which can only be a good thing. Complaints about this issue are now few and its negative
	impact on the community has reduced.

3. PRO-ACTIVE WORK & EMERGING ISSUES

- The City Council's Safer Communities Section is working with police, the street outreach teams and housing officers in South Arbury and Kings Hedges to identify and take positive action with regards to tenancies where properties housing vulnerable tenants have been targeted, leading to ASB in the property and surrounding area. This is in an increasing problem due to the lack of accommodation options for single homeless in Cambridge.
- □ There have been good reductions in ASB.
- Overall crime is down compared to previous reporting period, but shows an increase compared to the same period last year. This is mainly due to non-dwelling burglary in the East Chesterton and King's Hedges areas and thefts from vehicles in the King's Hedges area. These offences are the subject of an on-going police operation (Operation Keating). There have been some notable arrests that have impacted on this problem, e.g. on 15 January 2013, the North team officers were quick on the scene and apprehended three men who had broken into a vehicle on the De Freville Estate. These men have been charged with an offence and enquiries suggest they may be responsible for a series of vehicle and shed burglaries across East Chesterton.
- Cycle crime has seen an increase compared to the same period last year and would benefit from further work around both prevention and enforcement. The North team have a person on bail for handling stolen cycles and expect to make further arrests.
- There have been good reductions in violent crime and dwelling burglary compared to the previous reporting period.
- Two good drug arrests were made by the North team; one being a suspected dealer from London.

King's Hedges	Fire-related ASB in this ward has almost ceased. There was one incident of a fire in the open ignited by an identified youth, which was dealt with by the Safer Neighbourhood partners and one vehicle fire relating to a car stolen elsewhere, dumped and fired in the area.
Arbury	During the reporting period there was no fire-related ASB. Fire Setters Intervention Scheme and Restorative Justice action continues in the ward with three young males.
