## APPOINTMENT OF A TEMPORARY PART-TIME SURVEYOR AT CAMBS HOME IMPROVEMENT AGENCY Not a Key Decision

## **1. Executive Summary**

- 1.1 This decision is needed to enable the new shared Cambs Home Improvement Agency (operating across City, South Cambs and Huntingdonshire) complete more Disabled Facilities Grant cases in Huntingdonshire during 2013/14. This will be achieved by recruiting a temporary part-time surveyor (24 hours per week fixed for 12 months).
- 1.2 The opportunity to consider this proposal and increase grant funding from Huntingdonshire District Council was not progressed in time to align with the City Council's budget setting process.
- 1.3 This decision, if approved, will enable recruitment to proceed and does not have a direct impact on the City Councils own budget.

#### 2. Recommendations

The Executive Councillor is recommended:

2.1 To approve the appointment by Cambs HIA of a fixed term / temporary part-time surveyor, with associated operational costs as outlined in this report, for a period of up to12 months. This approval is being granted on the basis that this has a neutral financial implication with all costs anticipated to be fully met from additional fee income.

## 3. Background

3.1 The new shared Cambs HIA was officially established in April 2012, in a partnership agreement between Cambridge City, South Cambs and Huntingdonshire District Councils. The City Council (as the lead authority) provides financial, HR, policy and management support. A

Management Board comprising of representatives of the three councils oversees, monitors and provides strategic direction for the Agency. The Management Board endorsed this proposal for recommendation to the City council at a Board meeting on 30<sup>th</sup> January 2013.

3.2 Hunts Council can make available an additional £300,000 for approved Disabled Facilities Grants in 2013/14, if Cambs HIA is able to project manage and deliver these additional works. The existing rate of referrals from the occupational therapy service in Huntingdonshire demonstrates that this additional work will meet an identified local need. Of the additional £300,000, the HIA will be eligible to claim £30,000 of this in fees to fund the additional costs of managing the works as detailed below:
