1 INTRODUCTION

Aim

The aim of the Neighbourhood profile update is to provide an overview of action taken since the last reporting period, identify ongoing and emerging crime and disorder issues, and provide recommendations for future priorities and activity in order to facilitate effective policing and partnership working in the area.

The document should be used to inform multi-agency neighbourhood panel meetings and neighbourhood policing teams, so that issues can be identified, effectively prioritised and partnership problem solving activity undertaken.

Methodology

This document was produced using the following data sources:

- Cambridgeshire Constabulary crime and anti-social behaviour (ASB) incident data for April to July 2014, compared to the previous reporting period (December 2013 to March 2014) and the same reporting period in 2013.
- City Council environmental services data for the period April to July 2014, compared to the same reporting period in 2013; and
- Information provided by the Safer Neighbourhood Policing team and the City Council's Safer Communities team.

2 CURRENT PRIORITIES

At the West/Central Area Committee meeting of 24 April 2014, the committee recommended adopting the following priorities:

- Street-based ASB
- Operation Safe Passage
- Vehicle obstruction of pavements

The Neighbourhood Action Group, at its meeting of 1 May 2014, assigned the actions to be taken and lead officers for each of the priorities. The tables below summarise the actions taken and the current situation.

Street-based ASB	
Objective	To continue to tackle ASB in the city
Action Taken	<p>Since the last meeting the StreetLife Team has been working to address street-based anti-social behaviour and to reduce the harm caused by such behaviour.</p> <p>There have been a number of successes and we have prosecuted 2 people for persistently breaching their ASBOs. Ultimately both received custodial sentences which provided relief from their behaviour to the people of Cambridge.</p> <p>We have also been successful in prosecuting a number of persistent offenders who again have received custodial sentences for their continued criminality.</p> <p>In addition to the enforcement element of our work, we have continued to work with both the Street Outreach team and the Chronically Excluded Adults team to address the behaviour of people who persistently beg and cause issues within the city. This joint working has been successful in diverting a number of people from begging and they are currently being supported in their tenancies.</p> <p>There remain a number of people who decline help and who continue to beg and engage in anti-social behaviour. Supported by the council, we have mounted a number of begging patrols over weekends, resulting in more than 20 report files and temporary exclusions from the City Centre under s27 powers. We will continue to take robust enforcement action against these individuals as well as gathering evidence to apply for ASBOs.</p>

	<p>During this reporting period there have been a number of significant public events including both the Strawberry and Midsummer Fairs, the Big Weekend and the Tour de France. These were all well attended, and in the case of the TdF attracted unprecedented numbers. There were few issues.</p> <p>Working with our SNT and Special Constabulary colleagues, we have continued to work hard within the night time economy under Operation Sodium. With a particular focus on weekends and other key nights, teams of officers continue to be deployed with a specific remit to deal with issues within the night time economy. In addition to the issues of alcohol-related violence or ASB over recent weeks, a considerable amount of work has also been done to tackle the issue of street begging within the night time economy environment. This work has resulted in numerous people being reported for the issue of a summons.</p>
Current Situation	Work to continue to tackle this priority is on-going, as outlined above.

Operation Safe Passage¹	
Objective	Address road safety issues for all road users.
Action Taken	<p>Operation Safe Passage is still on-going and continues to receive considerable support from our colleagues in the Roads Police Unit.</p> <p>In addition to the reassurance and deterrent element provided by both static and high visibility patrolling, enforcement action has been taken across a number of areas. These have included:</p> <ul style="list-style-type: none"> ❑ The arrest of a disqualified driver ❑ Cannabis warnings ❑ The seizure of uninsured vehicles ❑ Multiple alcohol breath tests ❑ Excess speed offences ❑ Seatbelt offences ❑ Mobile phone use offences ❑ Parking and obstruction offences ❑ Licensing offences <p>In addition, the team has also responded directly to enquiries</p>

	<p>and issues raised by members of the public.</p> <p>We are regularly bidding for and receiving support from the Force Road Policing Unit.</p> <p>The City Centre team has also been in dialogue with the Hackney Carriage Association to discuss mutual concerns. A number of future initiatives were discussed which will be considered in due course. Future work will involve consultation with the main firms in the local area, and a proposed VOSA operation.</p>

Vehicle obstruction of pavements²	
Objective	Address road safety issues for all road users.
Action Taken	<p>Enforcement activity has taken place resulting in the issue of Fixed Penalty Notices for unnecessary obstruction in Victoria and Orchard Streets.</p> <p>In addition, like notices have been issued to vehicles other than taxis causing obstruction in the ranks.</p> <p>Attention by way of high visibility patrols continue.</p>
Current Situation	Work to continue to tackle this priority is on-going, as outlined above.

3 PRO-ACTIVE WORK & EMERGING ISSUES

- The City Council's Safer Communities team has one ongoing ASB case involving a tenancy in The Grafton area. Legal steps have been taken and the team is liaising closely with local residents.
- The Safer Communities team have had several reports of rough sleepers notably in the area of the Park Street car park. The team is working with the police's StreetLife team and the Council's Task & Target Group to address these ongoing issues.

- Reports of youths gathering and causing nuisance and littering on the New Square Park were reported to the Safer Communities team. Working with the City Centre police team, Safer Communities liaised with local residents and Jesus College to help address the issue.
- PS Paul Street has now left the City Centre problem solving team. His replacement is PS Ian Wood.
- There has been an overall increase in crime of 9% (118 more crimes) in comparison with the previous reporting period. The majority of this increase was seen in the Market ward where 104 more crimes were recorded.
- There has been an overall increase in ASB of 15% (50 more incidents) in comparison with the previous reporting period. Of note is that by comparison to this same period in 2013, this does still represents a reduction of 15%.
- Each of the Wards has seen a reduction in dwelling burglary and other burglary has remained stable.
- Robbery has reduced from 8 offences in the previous reporting period to 4 in this period. There were no crimes of this type in the Newnham ward and just one in the Castle ward.
- There has been just one reported vehicle theft in this reporting period and theft from vehicle remains stable.
- There has been an overall increase in cycle theft of 45% (105 more crimes) in comparison with the previous reporting period. The majority of this increase has been seen in the Market Ward (up 80) followed by Newnham (up 18) and finally Castle (up 7).
- A *Shape Your Place* blog has been set up for members of the public who can't attend the West Central meeting in person to highlight issues.
