# **Glossary of orders**

- Dog exclusion areas Children using play areas should be able to do so without coming across
  dog fouling or out of control dogs. This order officially excludes dogs from some children's play
  areas, bowling greens, tennis courts and outdoor paddling pools.
- Dogs on leads areas This order requires all dogs to be on leads when in Newmarket Road Cemetery, parts of Cherry Hinton Hall and Histon Road Cemetery as well as some children's play areas.
- Clearance of dog fouling This order enables the council to penalise anyone for not cleaning up after his or her dog immediately in all streets and open spaces across the city.
- Dogs on leads by direction With the exception of above, as is the case now, dogs are allowed to roam off of leads in all open spaces in Cambridge. However, we do ask that they are still under control and can be called and obey orders from their owner / handler. If it is clear that a dog cannot be kept under control off lead, then this order will enable authorised officers from the council to request that the dog is placed on a lead.

**Executive summary** 


In October 2017 Cambridge City Council created a Public Space Protection Order for dog control to tackle the issues of irresponsible dog ownership. The council is required by law to review the orders set in 2017 (which were valid for 3 years) or they lapse. In March 2020, the council commissioned M·E·L Research to deliver a consultation to review the current dog control restrictions to get feedback on what residents, visitors and businesses affected by the restrictions think about them. The parts which were consulted on were dog fouling, dogs on leads, exclusion of dogs and new restrictions.

During March and April 2020, an online survey was circulated to gather feedback. The consultation was promoted on the Council website, social media pages, an email to a range of stakeholders such as residents' groups and a letter was sent to households that were directly affected by the new proposals. The section presents the key findings of the research.

# Introduction

## Research context

The vast majority of dog owners in Cambridge are responsible, however there are a minority who do not clear up after their dog, who allow their dog to act aggressively or do not have control of their dog in public places. Legislation enables the local authority to create Orders to tackle issues and problems relating to dogs within Cambridge.

In October 2017 Cambridge City Council created a Public Space Protection Order for dog control to tackle the issues of irresponsible dog ownership. The council is required by law to review the orders set in 2017 (which were valid for 3 years) or they lapse. In March 2020, the council commissioned M·E·L Research to deliver a consultation to review the current dog control restrictions to get feedback on what residents, visitors and businesses affected by the restrictions think about them. The parts which were consulted on were dog fouling, dogs on leads, exclusion of dogs and new restrictions.

## Methodology

During March and April 2020, an online survey was circulated to gather feedback. The consultation was promoted on the council website, social media pages, posters displayed at parks and open spaces in Cambridge, an email to a range of stakeholders such as residents' groups and a letter was sent to households that were directly affected by the new proposals. In addition to the online survey, the council were planning on carrying out an in-parks survey at Byron's Pool and Cherry Hinton Hall. Due to the Covid-19 outbreak and associated government restrictions this element of the research was not able to take place. Below presents a summary of the approach taken:

## Statistical reliability

The survey findings are based on results of a survey of a <u>sample</u> of Cambridge and results are therefore subject to sampling tolerances. With 267 residents having completed the survey, this returns a confidence interval of  $\pm 6.0\%$  for a 50% statistic at the 95% confidence level. This simply means that if 50% of residents indicated they agreed with a certain aspect, the true figure (had the whole population been surveyed) could in reality lie within the range of 44% to 56% and that these results would be seen 95 times out of 100. Table 1 below shows the confidence intervals for differing response results (sample tolerance).

## **Analysis and reporting**


As an online survey is a self-selection methodology, with residents free to choose whether to participate or not, it is anticipated that returned responses would not necessarily be fully representative of the target population. Therefore, results are to be used as indicative only.

#### Presentation of data

Owing to the rounding of numbers, percentages displayed visually on graphs and charts within this report may not always add up to 100% and may differ slightly when compared with the text. The figures provided in the text should always be used. Where figures do not appear in a graph or chart, these are 3% or less. The 'base' or 'n=' figure referred to in each chart and table is the total number of residents responding to the question with a valid response.

# **Findings**

## **Dog fouling**

An agreement of the current order is that any person in charge of a dog must clear up after their dog immediately (i.e. dog fouling). Respondents were first asked to what extent they agreed or disagreed they agreed with this requirement.

• Almost all respondents (99%) either 'strongly' (93%) or 'fairly' (6%) agreed with the current order.

Respondents were asked is they had any comments on this requirement. A total of 81 comments were made by respondents which have been themed and are shown in the table below. One response could have contained more than one theme and as such the total presented in the table may be higher than the number of responses.

Results show that the most frequent comment (30%) was that this should be done anyway or that it is already done. Other comments made reference to dog poo being picked up but left out in bags (16%) and the need for more dog waste bins / more frequent emptying (14%).

## **Keeping dogs on leads**

With the exception of dog exclusion and dogs on leads areas, as is the case now, dogs are allowed to roam off of leads in all open spaces in Cambridge. However, it is asked that dogs are still under control and can be called and obey orders from their owner / handler. If it is clear that a dog cannot be kept under control off lead, then authorised officers from the council can request that the dog is placed on a lead. Respondents were asked to what extent they agreed or disagreed with this.

- Overall, the vast majority of respondents (97%) either 'strongly' (81%) or 'fairly' (15%) agreed with this action.
- Just 1% of respondents disagreed, whilst 2% neither agreed nor disagreed.

## Dog on lead areas

There are areas in Cambridge where dogs have to be on a lead at all times such as cemeteries and children's play areas. Current controls are already in force in the areas listed below:

- Histon Road cemetery
- Newmarket Road cemetery

Respondents were asked to what extent that they agree or disagree that dogs should be kept on leads in the above cemeteries.

- Almost nine in ten (89%) respondents 'strongly' (76%) or 'fairly' (13%) agreed that dogs should be on leads in these cemeteries.
- Just 6% of respondents disagreed, whilst 5% neither agreed nor disagree with this control.

The council are looking at proposing two **new additional areas** where dogs will have to be on leads at all times. The two new areas they are seeking views on is the green space at Hanover and Princess Court and the children's play area at Tenby Close.






Respondents were asked to what extent they agree or disagree with the new proposed orders in the above areas.

- Overall, respondents were more supportive of the proposed order being enforced at Tenby Close children's play area (84%) than at the Hanover & Princess Court green area (74%).
- 14% disagreed with the proposed order being enforced at Hanover & Princess Court green area whilst just 7% disagreed with it being enforced at Tenby Close children's play area.

Respondents were also given the opportunity to add any further comments. A total of 38 comments were made by respondents which have been themed and are shown in the table below. One response could have contained more than one theme and as such the total presented in the table may be higher than the number of responses.

Some residents took this opportunity to reiterate their support for the proposal (34%) whilst 16% suggested that dogs need the space to exercise, socialise or train (16%).


The council are also looking at **removing** the order that dogs are required to be on leads in the areas below:

- Kings Hedges Recreation Ground (the part of the park that contains the children's play equipment)
- Molewood Close (the whole of the park)
- Velos Walk (the whole of the park)

Respondents were asked to what extent they agree or disagree with the proposal to remove the orders at the above locations.

- 30% of respondents agreed that the order should be removed from <u>Kings Hedges Recreation</u> <u>Ground</u>; 57% disagreed.
- 46% of respondents agreed that the order should be removed from <u>Molewood Close</u>; 39% disagreed.
- 47% of respondents agreed that the order should be removed from <u>Velos Walk</u>; 39% disagreed.

Respondents were also given the opportunity to add any further comments. A total of 38 comments were made by respondents which have been themed and are shown in the table below. One response could have contained more than one theme and as such the total presented in the table may be higher than the number of responses.

Over two fifths of the comments (42%) expressed further disagreement with the removal of the order with 18% of comments suggesting this was because dogs off leads can be dangerous or scary for children.

## Dog exclusion areas

Children and adults using certain areas should be able to do so without coming across dog fouling or out of control dogs. The current order officially excludes dogs from some children's play areas, bowling greens, tennis courts, green spaces and outdoor paddling pools. For the following areas, there is a proposal to continue to exclude dogs at all times:



Respondents were asked to what extent they agree or disagree that dogs should be excluded from the above areas.

- The majority of respondents agreed that dogs should be excluded from bowling greens, paddling pools, tennis courts and children's play areas, but less agreed they should be excluded from green spaces.
- 90% of respondents agreed that dogs should be excluded from bowling greens; 5% disagreed.
- 90% of respondents agreed that dogs should be excluded from paddling pools; 5% disagreed.
- 84% of respondents agreed that dogs should be excluded from tennis courts; 7% disagreed.
- 88% of respondents agreed that dogs should be excluded from children's play areas; 6% disagreed.
- 45% of respondents agreed that dogs should be excluded from green spaces; 41% disagreed.




Figure 6: Agreement that dogs should be excluded from the bowling greens, paddling pools, tennis courts, children play areas and green spaces listed



Currently, Coldhams Lane and Abbey Pool children's play areas have a dogs on leads order in force. The council are proposing to change Coldhams Lane and Abbey Pool children's play areas to dog exclusion areas. Respondents were asked to what extent they agree or disagree with this proposal.

- Overall, around seven in ten (69 -70%) respondents were supportive of the proposal to change Abbey Pool children's play area and Coldhams Lane children's play area to dog exclusion zones.
- 24% either 'strongly' or 'fairly' disagreed with the proposed change being enforced at Coldhams Lane children's play area whilst 23% disagreed with it being enforced at Abbey Pool children's play area.

Respondents were also given the opportunity to add any further comments. A total of 37 comments were made by respondents which have been themed and are shown in the table below. One response could have contained more than one theme and as such the total presented in the table may be higher than the number of responses.

Results show that the most frequent comment was that the proposal is not suitable for families with dogs, who may wish to take their children to play and walk their dog(s) (41%).



Ditton Fields also currently has a dogs on leads order in force that the council is proposing to change to a dog exclusion area. Respondents were asked this question in two parts. Firstly, to what extent they agree or disagree with the proposal to remove the dogs on leads order for the whole of the park and secondly, the proposal to introduce a dog exclusion zone for the children's play area. This would increase access for local dog walkers and restrict only the fenced children's play area.

- Overall, half of respondents (50%) either 'strongly' or 'fairly' agreed that the dogs on leads order should be removed; 37% disagreed.
- Over three quarters (77%) agreed that dogs should be excluded from the children's play area; 17% disagree.

- Huntsman Road children's play area
- Kingsway flats green area
- Lichfield Road children's play area
- Searle Podium at Dobson Way

Respondents were asked to what extent they agree or disagree with the new proposed dog exclusion zones.



- Respondents were most supportive of the proposal to exclude dogs from Lichfield Road children's play area and least supportive of the proposal to exclude dogs from Kingsway flats green area.
- 60% of respondents agreed that dogs should be excluded from <u>Bean Tree green</u>; 26% disagreed.
- 75% of respondents agreed that dogs should be excluded from <u>Huntsman Road children's</u> play area; 15% disagreed.
- 58% of respondents agreed that dogs should be excluded from <u>Kingsway flats green area</u>; 32% disagreed.
- 77% of respondents agreed that dogs should be excluded from <u>Lichfield Road children's play</u> area; 14% disagreed.
- 61% of respondents agreed that dogs should be excluded from <u>Searle Podium at Dobson</u> <u>Way</u>; 25% disagreed.

Respondents were also given the opportunity to add any further comments. A total of 71 comments were made by respondents which have been themed and are shown in the table below. One response could have contained more than one theme and as such the total presented in the table may be higher than the number of responses.

The most frequent comment was that dogs need space (and therefore should not be excluded) and/or that alternative green spaces should be made available (20% of comments). Other comments further expressed general agreement or disagreement with the proposed exclusion order.



The council are also looking at removing the order that dogs are excluded from the Brooks Road children's play area, as this is no longer fenced. Respondents were asked to what extent they agree or disagree with the new proposal to remove the dogs on leads order.

- A third (33%) of respondents either 'strongly' or 'fairly' agreed with the proposal to remove the order.
- Over half (51%) of respondents disagreed, with 39% 'strongly' disagreeing. 16% neither agreed nor disagreed with the proposal.

Respondents were also given the opportunity to add any further comments. A total of 71 comments were made by respondents which have been themed and are shown in the table below. One

response could have contained more than one theme and as such the total presented in the table may be higher than the number of responses.

The most frequent themes included suggestions to fence the area off again (28% of comments) and comments suggesting that the dogs on lead order should be maintained (24% of comments).

## **Byron's Pool**


The council are proposing a restriction on the number of dogs that can be walked by a person at any given time to a maximum of four dogs at Byron's Pool. They are looking at this as there have been a number of complaints regarding aggressive dogs, lack of dog control and dog straying without their owners' control. This proposal is based on the Professional Dog Walkers' Guidelines, which can be viewed <a href="here">here</a>.



Respondents were asked to what extent they agree or disagree with the proposed restrictions on the number of dogs walked by a person at any given time at Byron's Pool.

- Overall, around three quarters (74%) of respondents either 'strongly' (56%) or 'fairly' (19%) agreed with the proposal to restrict the number of dogs walked.
- A fifth of respondents (20%) disagreed with the proposal, with 6% neither agreed nor disagreed.

Respondents who either agreed or disagreed were asked why this was. A total of 108 comments were made by respondents which have been themed and are shown in the table below. One response could have contained more than one theme and as such the total presented in the table may be higher than the number of responses.

For those that agreed with the new proposed restriction, the most common themes show that respondents feel more than four dogs will be hard to control (46%) or that four dogs is sufficient or in itself too many (38%). A fifth of comments (22%) also suggested the area needs protecting.

For those respondents that disagreed with the proposed restriction, comments suggest it is because they feel the behaviour of the dog(s) should be taken into consideration (38%) and/or restrictions on number of dogs should be enforced on a case-by-case basis (32%).



## **Cherry Hinton Hall**

There is a requirement at Cherry Hinton Hall around the pond / stream area that requires dogs to be on leads at all times. Respondents were asked to what extent they agreed or disagree with this order.

- Seven in ten (70%) respondents either 'strongly' (51%) or 'fairly' (18%) agreed with this order.
- Around a quarter (23%) of respondents disagreed with the order, with 7% who neither agreed nor disagreed.

Respondents were also given the opportunity to add any further comments. A total of 50 comments were made by respondents which have been themed and are shown in the table below. One response could have contained more than one theme and as such the total presented in the table may be higher than the number of responses.

Around a quarter (24%) of respondents took the opportunity to express disagreement with the order whilst 16% of comments mentioned a need to protect wildlife and/or children, with dogs intimidating some children - with these respondents agreeing with the proposal (with the exception of one respondent who neither agreed nor disagreed).

## **Exceptions to the order**

Currently dog control restrictions do not apply to all people, and the council want to ensure that restrictions placed on dog owners and handlers are reasonable and take into account conditions where it is not possible to comply. The orders do not apply to a person in control of a working assistance dog which has been trained to assist a person who has a disability. Respondents were asked to what extent they agreed or disagreed with this exception.

- Overall, nine in ten (89%) respondents 'strongly' (71%) or 'fairly' (18%) agreed with this exception.
- Just 4% of respondents disagreed, whilst 7% neither agreed nor disagree.

### **Additional comments**

Lastly, respondents were asked if they had any further comments about the dog control public spaces protection order. A total of 80 comments were made by respondents which have been themed and are shown in the table below. One response could have contained more than one theme and as such the total presented in the table may be higher than the number of responses.

Some respondents took the opportunity to further express agreement with the proposals (19%) whilst a similar proportion specified a need for more or better facilities for dog walking in the City. A further 16% of comments mentioned that more enforcement was needed for dog fouling and antisocial behaviour.

# **Conclusion**

### High levels of agreement with existing orders and changes to existing orders

On the whole, there were high levels of agreement with the existing orders currently in place to tackle issues of irresponsible dog ownership in Cambridge. The vast majority were in agreement that any person in charge of a dog must clear up after them immediately and that an authorised officer should be able to request dogs to be put on leads if necessary.

There were also high levels of agreement when respondents were asked if they believe dogs should continue to be excluded from the specific bowling greens, paddling pools, children's play areas and tennis courts they are currently excluded from. However, when it came to the green spaces at Ravensworth Gardens, respondents were more ambivalent; though it should be noted that in 2017 this area was highlighted as an area of limited usage and awareness.

Respondents were also more ambivalent when asked about the suggested changes to the existing orders already in place. More specifically, the removal of the dogs on leads orders. Agreement with the proposals to change the current dogs on leads order to dog exclusion zones within children's play areas also had lower levels of agreement, though more were in agreement than disagreement.

#### Mixed views on with new proposed orders

Generally, levels of agreement with the new proposed orders was lower than the current orders already in place. Having said that, the majority of respondents did agree with them, with agreement ranging from 58% to 84%. The highest level of agreement being with the proposal to introduce a dogs on lead order at Tenby Close play area and the lowest level of agreement being with the proposed dog exclusion order on the Kingsway flats green area.

#### Differing views by area

When looking at the levels of agreement of both existing orders and new proposed orders, results suggest that residents were more welcoming of dog control orders being enforced in more confined spaces (i.e. children's play area's) or spaces predominantly used for a purpose other than dog walking (i.e. bowling green and paddling pools), than at more general use green spaces (i.e. Ravensworth Gardens and Kingsway flats). Around nine in ten also agreed with the dogs on lead order currently enforced at Histon Road and Newmarket Road cemeteries. Some residents also voiced concerns that other areas should have orders enforced, with Mill Road cemetery being most frequently mentioned. However, this order was removed following the 2017 consultation.
