2010/11 Revenue and Capital Outturn, Carry Forwards and Significant Variances

Not a Key Decision

1. Executive summary

- 1.1 This report presents a summary of the 2010/11 outturn position (actual income and expenditure) for services within the Arts & Recreation portfolio (now Arts, Sport & Public Places), compared to the final budget for the year. The position for revenue and capital is reported and variances from budgets are highlighted, together with explanations. Requests to carry forward funding arising from certain budget underspends into 2011/12 are identified.
- 1.2 It should be noted that this report reflects the reporting structure in place prior to the recent changes in Executive reporting responsibilities.

2. Recommendations

The Executive Councillor is recommended:

- a) To agree which of the carry forward requests, totalling £186,140 as detailed in Appendix C, are to be recommended to Council for approval.
- b) To seek approval from Council to carry forward capital resources to fund rephased net capital spending of £415,000 from 2010/11 into 2011/12 and of £135,000 from 2011/12 into 2010/11 as detailed in Appendix D.

3. Background

Revenue Outturn

- 3.1 The outturn position for the Arts & Recreation (now Arts, Sports & Public Places) portfolio, compared to final revenue budget, is presented in detail in Appendix A.
- 3.2 Appendix B to this report provides explanations of the main variances.
- 3.3 Appendix C sets out the final list of items, for this service portfolio, for which approval is sought to carry forward unspent budget from 2010/11 to the next financial year, 2011/12.
- 3.4 The overall revenue budget outturn position for the Arts & Recreation (now Arts, Sports & Public Places) portfolio is set out in the table below:

The variance represents 7.20% of the overall portfolio budget for 2010/11

Capital Outturn

- 3.5 Appendix D shows the outturn position for schemes and programmes within the Arts and Recreation portfolio, with explanations of variances.
- 3.6 An overall underspend of £247,000 has arisen. £ 415,000 is due to slippage and rephasing of the capital programmes is required to transfer the budget into 2011/12 and £135,000 for advance works for which capital budgets need to be rephased from 2011/12 into

2010/11. £24,000 can be returned to available developer contributions in respect of a project which has been completed at a lower than anticipated cost. The remainder represents small overspend to be funded fro other sources.

4. Implications

- 4.1 The net variance from final budget, after approvals to carry forward £186,140 budget from 2010/11 to the next financial year, 2011/12, would result in a reduced use of General Fund reserves of £427,724.
- 4.2 In relation to anticipated requests to carry forward revenue budgets into 2011/12 the decisions made may have a number of implications. A decision not to approve a carry forward request will impact on officers' ability to deliver the service or scheme in question and this could have staffing, equal opportunities, environmental and/or community safety implications.
