11/20/Civ Apologies for absence

There were no apologies for absence.

Councillor McGovern attended as the alternate for the seat formerly held by Councillor Pitt.

11/21/Civ Minutes of previous meeting

The minutes of the meeting held on 23rd March 2011 were approved as a true and accurate record.

11/22/Civ Declarations of Interest

There were no declarations of interest.

11/23/Civ Public Questions

There were no public questions.

11/24/Civ Draft Audit Fee Letter 2011/12

The committee received the draft audit fee letter 2011/12 from the District Auditor and the Audit Manager. The District Auditor explained how the fee was calculated, the audit process and the mechanism for adjusting the fee in year if required.

Cllr Reid attended and spoke under Council procedure rule 39.2 (3), and asked whether the reduced budget and workforce of the City Council was reflected in the revised fee. The District Auditor explained that there was no direct correlation between the size of the budget and the audit fee. It was noted that it was the intention of the Audit Commission (subject to affordability) to refund part of the 2010/11 fee, which would be offset against the 2011/12 fee.

Resolved (unanimously) to note the Draft Audit Fee Letter for 2011/12 and thank the Audit Commission for their ongoing work.

11/25/Civ Delegations to Officers

The committee received a report from the Head of Legal Services regarding updating the scheme of delegation to reflect the corporate restructure.

The committee agreed to recommend that the specific references to the Head of Human Resources and Head of Strategy and Partnership, within the definition of Directors in section 1.1. (a) of the appendix to the committee report should be removed. It was also agreed that delegations by the

Executive to officers should be expressed as delegated "by the Executive", rather than attributed to individual members of the Executive.

The Committee suggested that the following references were made:

Under powers delegated to the Chief Executive: Climate Change.

Under powers delegated to Director of Environment: Nature Reserves

The committee noted that it was intended to undertake a major review of the delegations in the near future, but that minor interim changes to clarify the responsibilities for climate change and nature reserves were agreed.

Resolved (Unanimously) subject to the points mentioned above, to

- i. Recommend to Council the approval of the draft scheme of delegation in relation to powers delegated by the Council.
- ii. Recommend to the Executive the approval of the draft scheme of delegation in relation to powers delegated by the Executive.

11/26/Civ Nominations for Leader of the Council

The committee received one nomination for the Leader of the Council, Councillor Sian Reid.

Resolved to recommend to Council that Councillor Sian Reid be elected Leader of the Council.

11/27/Civ Proposed Changes to Executive Responsibilities

The committee received a report from the Head of Legal Services and the Democratic Services Manager regarding proposed changes to executive responsibilities.

The Leader explained the proposed changes and the reasons underlying the proposed changes.

Cllr Herbert acknowledged that the configuration of portfolios was a decision for the Executive, but challenged the rationale for splitting responsibility for the Environmental Improvement Programme (EIP) and sustainable transport between portfolios. Cllr Herbert also questioned whether the proposed changes to tree management arrangements would improve the quality of decision-making.

Cllr Wright attended and spoke under Council procedure rule 39.2 (3) and echoed the concerns raised by Cllr Herbert. Cllr Wright also suggested that there should be greater clarity on which portfolio was responsible for liaising with County Council on highways matters.

The committee agreed to amend recommendation 2.1 to replace "endorse" with "notes".

Council is recommended to

- i. Note the changes to executive responsibilities.
- ii. Approve the recommended changes to scrutiny arrangements as set out in the committee report.
