

# TOWN POLICE CLAUSES ACT 1847 & LOCAL GOVERNMENT (MISCELLANEOUS PROVISIONS) ACT 1976– HACKNEY CARRIAGE & PRIVATE HIRE DRIVER'S LICENCE DDL1019

Please find your Hackney Carriage & Private Hire Driver's Licence enclosed. The badge should be worn or prominently displayed at all times when you are acting as a licensed driver so that it is plainly and distinctly visible.

The Licence was issued on 19 June 2025 and will remain in force until 18 June 2028, unless it is suspended or revoked by Cambridge City Council or you surrender the Licence.

This licence has been granted without prejudice to any subsequent decision that this licensing authority makes.

Whilst the Licence is in force, you are deemed to be continuously licensed and you must therefore comply with the conditions attached to the rear of the Licence at all times. Additionally, you should make yourself aware of the statutory obligations imposed on Hackney Carriage & Private Hire Drivers as set out in the Taxi Guide.

If you are aggrieved by any condition attached to this Licence, you may appeal to Cambridge Magistrates' Court, 12 St Andrews Street, Cambridge CB2 3AX within 21 days of receipt of this letter.

#### LICENCE CONDITIONS

# (Applicable to the Private Hire Driver's Licence only)

Local Government (Miscellaneous Provisions) Act 1976

# 1. Conduct

The driver must give reasonable help with luggage, be clean, respectable, polite and orderly. He must also take reasonable steps to ensure the safety of passengers and must not drink, eat or play a radio or similar device to the annoyance of any person during the hiring.

## 2. Passengers

The maximum number to be carried is as prescribed in the vehicle licence. No child under 10 may be carried in the front seat beside the driver.

# 3. Lost Property

The driver must search the vehicle to ensure that property is not left behind, and if property is left behind he must, if registered with an operator, contact operator with information of found item within 24 hours.

If not registered with an operator, driver should contact Cambridge City Licensing Team at Taxi@cambridge.gov.uk within 24 hours with information of found item. If property is not claimed after 28 days, driver can dispose of property.

## 4. Written Receipts

Must be provided for charges, if requested.

### 5. Animals

All drivers are obliged to carry assistance dogs unless they have been granted a medical exemption from the Taxi Licensing Office. A driver may not carry an animal owned by him, or in his custody, or that of the proprietor of the vehicle or its operator.

## 6. Deposit of Drivers Licence

If the proprietor permits or employs any other person to drive the licensed vehicle he shall, before that person commences to drive the vehicle, ensure he is in possession of his "Taxi" Drivers licence for retention.

Alternatively, if the vehicle is a "fleet" Private Hire Vehicle, you are required to deposit your Private Hire Drivers licence with the Private Hire Operator.

# 7. Change of Address and Convictions

The holder of a "Taxi" Drivers licence shall, within seven days, notify the Council in writing of any change of address, or conviction imposed on him, during the period of the licence.

### 8. Badges

Badges must be displayed prominently, in such a position that is easily seen by passengers.

Failure to comply with the conditions of this Licence may result in disciplinary action.
