Please describe the nature of the proposed variation	The premises currently holds a licence permitting the sale of alcohol from 12:00 to 19:00, seven days a week. This application seeks to extend the terminal hour for the sale of alcohol to 23:00, with no change to the start time, premises layout, capacity, or the range of licensable activities authorised under the licence. The premises operates as an art café, bar, and cultural venue dedicated to the legacy of Syd Barrett, hosting arts-led and community-focused events. The extension of alcohol sales hours will support the sustainability of the business and allow greater flexibility for evening cultural activity, while remaining appropriate to the character of the area. There will be no material change to the nature of the operation, and the premises will continue to promote the licensing objectives. The basement forms part of the existing premises and no physical alteration to the licensed area is proposed as part of this application; any cultural or arts-led activity will operate within existing statutory exemptions and permissions.

a) General - all four licensing objectives (b,c,d,e)	The premises will continue to operate as a café, bar, and cultural venue. The proposed extension of alcohol sales hours will be managed within existing operational practices, staffing levels, and management oversight. No changes are proposed to the nature of the operation, capacity, or layout of the premises.
b) The prevention of crime and disorder	The premises will promote responsible alcohol consumption at all times. Alcohol will be sold as part of a café and cultural offering, with substantial food, including freshly prepared pizzas in the evening, available to customers. This approach is intended to discourage excessive alcohol consumption and support a relaxed and well-managed environment. Staff will refuse service to anyone who appears intoxicated.

c) Public safety	The premises will operate within its existing approved capacity and layout, including the basement areas used for cultural events. Clear access to exits and escape routes will be maintained at all times, and staff will be present to supervise events and manage customer safety. No changes are proposed to the physical structure or safety arrangements of the premises as a result of this variation.
d) The protection of public nuisance	The premises is not operated as a late-night drinking venue. Cultural events such as exhibitions, performances, and launches are managed to ensure they conclude in an orderly manner. The availability of food supports a controlled atmosphere, and staff will manage customer dispersal to minimise noise and disturbance to nearby residents, particularly during later hours.
e) The protection of children from harm	The premises operates as a café and cultural venue that is suitable for families during the day. Children will not be permitted to consume alcohol, and staff will continue to operate a Challenge 25 policy. Cultural events hosted at the premises are appropriately managed, and no adult entertainment or activities unsuitable for children take place or are proposed.
