To Note:

Page 59 Table 6 provides a breakdown of what has been delivered so far / is under construction as part of Phase 1 (at the time of the outline application submission in September 2025) and what is proposed under the new outline Applications for Phase 2.

For clarification the following table clarifies the number of homes that are proposed and would be delivered across the Eddington site as a whole.

Total homes granted permission in 2013 outline permission	3,000
Total homes in Phase 1 (built and consented of the 2013 permission)	1,848
Proposed homes for Phase 2 (the Applications)	3,800
Total number of homes across the whole site (Phase 1 plus Phase 2)	5,648

Page 134, Table 11 Open Space Provision states:

The required amount in hectares should state **14.16ha** not 14.6.

S106 obligations

In the context of having received a points of clarification response from the applicant the following points are raised on the Planning obligations:

General point: Where 3,000 occupations is referenced as a S106 the trigger, this equates to 1,152 for the applications under determination. The 3,000 relates to Phase 1 delivered (1,848) and the 1,152 residual amount.

Page 152 library provision is referenced:

Amendment to **Condition 62** set out in **Appendix 8**:

62. Highway works

Prior to the first occupation of either the commercial development dependant on the Huntingdon Road West access or the ~~4,290th~~ **3,169th** dwelling (private or Key Worker Housing, excluding student accommodation), whichever comes first, the Huntingdon Road access and associated highway general arrangements detailed on submitted drawings ref: 24067-KMC-HGN-XX-SK-CH-HR21 Rev PL07 and 24067-KMC-HGN-XX-SK-CH-HR22 Rev PL04 (which may be subject to amendment or alteration during the Highway S278 approval stage) shall be fully constructed and open to traffic. The access shall thereafter be retained for its intended purpose.

Reason: To ensure the provision of a safe, suitable and effective means of access serving the development, to promote sustainable travel, and in the interests of highway safety and the efficient operation of the local and strategic highway network in accordance with Policy 80 of the Cambridge Local Plan 2018, Policy TI/2 of the South Cambridgeshire Local Plan and the NPPF (2026).
